Co-Chair Osborne called the meeting to order at 10:07 a.m. and attendance was noted.

INTRODUCTION OF MEMBERS

Representative Osborne asked that the Members introduce themselves.

GUARDIAN UPDATE

Department of Child Safety (DCS)

Mike Faust, Director, Department of Child Safety, discussed the implementation of the Guardian system, the continual improvements of access to information between agencies and answered questions posed by the Committee.

Foster Care Review Boards/Courts

Caroline Lautt-Owens, Director, Dependent Children's Services Division, Administrative Office of the Courts, discussed the implementation and the effectiveness of the Guardian System, problems with access to information by the Foster Care Review Board and answered questions posed by the Committee.

Mr. Faust addressed areas of discussion from the Foster Care Review Board and answered questions posed by the Committee.

Arizona Ombudsman - Citizens Aide

Joanne MacDonnell, Arizona Ombudsman Citizens' Aide, discussed the CHILDS and Guardian systems progression, explained training and access issues with DCS and the lack of shared information. Ms. MacDonnell answered questions posed by the Committee.

Mr. Faust addressed the areas of concern from the Ombudsman, discussed DCS staffing and answered questions posed by the Committee.

DCS – REVIEW OF NORTH STAR INDEPENDENT LIVING SERVICES INCIDENT

Mr. Faust gave an overview of the North Star group home incident, discussed housing options for youth and DCS' responsibilities. Mr. Faust answered questions posed by the Committee.

Senator Barto read a letter from a former employee of North Star Independent Living Services and asked questions of Director Faust.

Mr. Faust responded to Senator Barto and answered questions posed by the Committee.

DCS AGENCY UPDATE

Mr. Faust encouraged Members to schedule confidential briefings for further information and explained how the Legislature could help improve DCS as an agency and answered questions posed by the Committee.

Mr. Faust explained that his office would deliver a detailed package containing further explanation on the North Star Independent Living Services incident, DCS group homes and of the Guardian system integration to the Members.

Representative Osborne requested additional items from Mr. Faust in preparation for the next meeting.

Senator Barto thanked the Committee and the agencies for their time.

There being no further business, the meeting was adjourned at 12:54 p.m.
