3 TO THE PATIENT'S HEALTH CARE INSURER"; strike "A" insert "THE"

4 Between lines 24 and 25, insert:

5 "C. A DIRECT PRIMARY CARE AGREEMENT MAY ALLOW THE PERIODIC FEE AND
6 ANY ADDITIONAL FEES FOR ONGOING CARE UNDER THE AGREEMENT TO BE PAID BY A
7 HEALTH CARE INSURER OR OTHER THIRD PARTY.

9 A DIRECT PRIMARY CARE AGREEMENT FOR DENTAL SERVICES IS LIMITED TO

11 SERVICES OFFERED BY DENTISTS IN OTHER PRACTICE ENTITIES."
