AN ACT

AMENDING SECTION 11-201, ARIZONA REVISED STATUTES; AMENDING TITLE 11, CHAPTER 2, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 11-269.27; RELATING TO THE COUNTY BOARD OF SUPERVISORS.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 11-201, Arizona Revised Statutes, is amended to
3 read:

4 11-201. Powers of county

5 A. The powers of a county shall be exercised only by the board of
6 supervisors or by agents and officers acting under its authority and
7 authority of law. It has the power to:

8 1. Sue and be sued.

9 2. Purchase and hold lands within its limits.

10 3. Make such contracts and purchase and hold such personal property
11 as may be necessary to the exercise of its powers.

12 4. Make such orders for the disposition or use of its property as
13 the interests of the inhabitants of the county require.

14 5. Levy and collect taxes for purposes under its exclusive
15 jurisdiction as are authorized by law.

16 6. Determine the budgets of all elected and appointed county
17 officers enumerated under section 11-401 by action of the board of
18 supervisors, EXCEPT THAT THE BOARD OF SUPERVISORS MAY NOT REJECT OR
19 OTHERWISE INTERFERE WITH A LAW ENFORCEMENT AGENCY'S OR PROSECUTION
20 AGENCY'S RECEIPT OF FEDERAL GRANT MONIES, AWARD MONIES AND OTHER MONIES
21 THAT ARE INTENDED TO SUPPLEMENT THE BUDGET OF A LAW ENFORCEMENT OR
22 PROSECUTION AGENCY AS PRESCRIBED IN SECTION 11-269.27.

23 B. Except for the purposes of acting as an intermediary in a
24 license transfer or sale, a county shall not own a commercial cable
25 television system or any other pay television system.

26 C. Section 11-251.05, subsection A, paragraph 1 does not authorize
27 a county to levy and collect taxes for any purposes beyond those otherwise
28 specifically authorized by statute.

29 Sec. 2. Title 11, chapter 2, article 4, Arizona Revised Statutes,
30 is amended by adding section 11-269.27, to read:

31 11-269.27. Grants, awards and other funding for operation of
32 law enforcement or prosecution agency: required
33 acceptance

34 A COUNTY BOARD OF SUPERVISORS SHALL ACCEPT FOR THE OPERATION OF A
35 LAW ENFORCEMENT OR PROSECUTION AGENCY FEDERAL GRANT MONIES, AWARD MONIES
36 AND OTHER MONIES THAT ARE INTENDED TO SUPPLEMENT THE APPROVED BUDGET OF
37 THE LAW ENFORCEMENT OR PROSECUTION AGENCY IF THE LAW ENFORCEMENT OR
38 PROSECUTION AGENCY IS OTHERWISE ELIGIBLE AND QUALIFIED FOR THE FEDERAL
39 GRANT, AWARD OR OTHER FUNDING.
