- 1 Page 1, line 14, strike "JURISDICTION" insert "CITY, TOWN OR COUNTY"
- 2 Line 15, strike ", WHICH ARE THE FINANCIAL RESPONSIBILITY OF THE JURISDICTION,"
- 4 Page 6, line 15, strike "OR" insert a comma; after "AGENCY" insert "OR A MENTAL HEALTH TREATMENT AGENCY"
- 6 Line 18, strike "OR" insert a comma; after the second "AGENCY" insert "OR MENTAL HEALTH TREATMENT AGENCY"
- 8 Line 19, after "TRANSPORTER" insert "IF AVAILABLE IN THE CITY, TOWN OR COUNTY"
- 9 Line 23, strike "OR" insert a comma; after "AGENCY" insert "OR A MENTAL HEALTH TREATMENT AGENCY"
- 11 Between lines 34 and 35, insert:

"C. THIS CHAPTER DOES NOT REQUIRE A CITY, TOWN OR COUNTY TO CONTRACT WITH AN AUTHORIZED TRANSPORTER TO PROVIDE SERVICES PURSUANT TO THIS CHAPTER INSTEAD OF A PEACE OFFICER. A CITY, TOWN OR COUNTY THAT ENTERS INTO A CONTRACT WITH AN AUTHORIZED TRANSPORTER IS FINANCIALLY RESPONSIBLE FOR THE CONTRACTED SERVICES PROVIDED PURSUANT TO THIS CHAPTER BY THE AUTHORIZED TRANSPORTER."

- 19 Line 35, after "AGENCY" insert "OR MENTAL HEALTH TREATMENT AGENCY"
- 20 Page 12, line 26, strike "LED" insert "LEAD"
- 21 Line 27, after "AGENCY" insert "PURSUANT TO SECTION 36-535"

1 Page 14, between lines 16 and 17, insert:

2 "4. Identifying means of improved integration of authorized
3 transporters as defined in section 36-501, Arizona Revised Statutes, as
4 amended by this act, in the behavioral health system."
