

COMMITTEE ON APPROPRIATIONS  
HOUSE OF REPRESENTATIVES AMENDMENTS TO S.B. 1263  
(Reference to Senate engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 5-572, Arizona Revised Statutes, is amended to  
3 read:

4 5-572. Use of monies in state lottery fund; report

5 A. If there are any bonds or bond related obligations payable from  
6 the state lottery revenue bond debt service fund, the state lottery revenue  
7 bond debt service fund shall be secured by a first lien on the monies in  
8 the state lottery fund after the payment of operating costs of the lottery,  
9 as prescribed in section 5-555, subsection A, paragraph 1, until the state  
10 lottery bond debt service fund contains sufficient monies to meet all the  
11 requirements for the current period as required by the bond documents.  
12 Debt service for revenue bonds issued pursuant to this chapter shall be  
13 paid first from monies that would have otherwise been deposited pursuant to  
14 this section in the state general fund. After the requirements for the  
15 current period have been satisfied as required by the bond documents, the  
16 monies in the state lottery fund shall be expended for the expenses of the  
17 commission incurred in carrying out its powers and duties and in the  
18 operation of the lottery.

19 B. Of the monies remaining in the state lottery fund each fiscal  
20 year after appropriations and deposits authorized in subsection A of this

1 section, ~~ten million dollars~~ \$10,000,000 shall be deposited in the Arizona  
2 game and fish commission heritage fund established by section 17-297.

3 C. Of the monies remaining in the state lottery fund each fiscal  
4 year after appropriations and deposits authorized in subsections A and B of  
5 this section, ~~five million dollars~~ \$5,000,000 shall be allocated to the  
6 department of child safety for the healthy families program established by  
7 section 8-481, ~~four million dollars~~ \$4,000,000 shall be allocated to the  
8 Arizona board of regents for the Arizona area health education system  
9 established by section 15-1643, ~~three million dollars~~ \$3,000,000 shall be  
10 allocated to the department of health services to fund the teenage  
11 pregnancy prevention programs established in Laws 1995, chapter 190,  
12 sections 2 and 3, ~~two million dollars~~ \$2,000,000 shall be allocated to the  
13 department of health services for the health start program established by  
14 section 36-697, ~~two million dollars~~ \$2,000,000 shall be deposited in the  
15 disease control research fund established by section 36-274 and ~~one million~~  
16 ~~dollars~~ \$1,000,000 shall be allocated to the department of health services  
17 for the federal women, infants and children food program. The allocations  
18 in this subsection shall be adjusted annually according to changes in the  
19 GDP price deflator as defined in section 41-563, and the allocations are  
20 exempt from the provisions of section 35-190 relating to lapsing of  
21 appropriations. If there are not sufficient monies available pursuant to  
22 this subsection, the allocation of monies for each program shall be reduced  
23 on a pro rata basis.

1           D. If the state lottery director determines that monies available to  
2 the state general fund may not equal ~~eighty-four million one hundred fifty~~  
3 ~~thousand dollars~~ \$84,150,000 in a fiscal year, the director shall not  
4 authorize deposits to the Arizona game and fish commission heritage fund  
5 pursuant to subsection B of this section until the deposits to the state  
6 general fund equal ~~eighty-four million one hundred fifty thousand dollars~~  
7 \$84,150,000 in a fiscal year.

8           E. Of the monies remaining in the state lottery fund each fiscal  
9 year after appropriations and deposits authorized in subsections A through  
10 D of this section, ~~one million dollars~~ \$3,000,000 or the remaining balance  
11 in the fund, whichever is less, is appropriated to the department of  
12 economic security for grants to nonprofit organizations, including  
13 faith-based organizations, for homeless emergency and transitional shelters  
14 and related support services. THE ALLOCATION IN THIS SUBSECTION IS EXEMPT  
15 FROM THE PROVISIONS OF SECTION 35-190 RELATING TO LAPSING OF  
16 APPROPRIATIONS. The department of economic security shall submit a report  
17 on the amounts, recipients, purposes and results of each grant to the  
18 governor, the speaker of the house of representatives and the president of  
19 the senate on or before December 31 of each year for the prior fiscal year  
20 and shall provide a copy of this report to the secretary of state.

21           F. Of the monies remaining in the state lottery fund each fiscal  
22 year after appropriations and deposits authorized in subsections A through  
23 E of this section, and after a total of at least ~~ninety-nine million six~~  
24 ~~hundred forty thousand dollars~~ \$99,640,000 has been deposited in the state

1 general fund, ~~three million five hundred thousand dollars~~ \$3,500,000 shall  
2 be deposited in the Arizona competes fund established by section  
3 41-1545.01. The balance in the state lottery fund remaining after deposits  
4 into the Arizona competes fund shall be deposited in the university capital  
5 improvement lease-to-own and bond fund established by section 15-1682.03,  
6 up to a maximum of eighty percent of the total annual payments of  
7 lease-to-own and bond agreements entered into by the Arizona board of  
8 regents.

9 G. All monies remaining in the state lottery fund after the  
10 appropriations and deposits authorized in this section shall be deposited  
11 in the state general fund.

12 H. Except for monies expended for debt service of revenue bonds as  
13 provided in subsection A of this section, monies expended under subsection  
14 A of this section are subject to legislative appropriation.

15 I. The commission shall transfer monies prescribed in this section  
16 on a quarterly basis."
