3 "1. AT LEAST SIX MONTHS BEFORE PUBLISHING A COPY OF THE PETITION FOR
4 INCORPORATION OF A COMMUNITY PURSUANT TO PARAGRAPH 2 OF THIS SUBSECTION,
5 PROVIDE TO THE BOARD WRITTEN NOTICE OF THEIR INTENTION TO PUBLISH A COPY OF
6 THE PETITION FOR INCORPORATION OF THE COMMUNITY. THE WRITTEN NOTICE SHALL
7 ALSO BE PUBLISHED FOR TWO CONSECUTIVE WEEKS IN A NEWSPAPER OF GENERAL
8 CIRCULATION IN THE AREA TO BE AFFECTED."

11 NOTICE TO THE BOARD PURSUANT TO PARAGRAPH 1 OF THIS SUBSECTION"

13 Page 2, line 4, strike "1" insert "2"

14 Line 41, strike the comma insert ":"

16 Page 3, between lines 2 and 3, insert:

17 "2. "UNINHABITED" INCLUDES LAND OWNED BY A MINING OR METALLURGICAL
18 COMPANY."

19 Line 6, strike "~~six miles~~"

20 Line 7, strike "ONE MILE" insert "six miles"

21 Line 8, after the comma strike remainder of line

22 Strike lines 9 and 10

23 Page 3, line 11, strike "~~population of less than five thousand persons~~" insert
24 "having a population of five thousand or more persons, and all territory

1 within three miles of any incorporated city or town, as the same now exists
2 or may hereafter be established, having a population of less than five
3 thousand persons"

4 Page 4, after line 28, insert:

5 "5. IF A PLANNED COMMUNITY ASSOCIATION AS DEFINED IN SECTION
6 33-1802, DURING THE PERIOD OF DECLARANT CONTROL, NOTIFIES THE BOARD OF ITS
7 REQUEST TO BE EXCLUDED FROM THE PETITION TO INCORPORATE, THE BOARD SHALL
8 EXCLUDE FROM THE COMMUNITY PROPOSED TO BE INCORPORATED THE AREA OR PORTION
9 OF THE AREA COVERED BY THE PLANNED COMMUNITY ASSOCIATION AFTER THE PETITION
10 HAS BEEN SUBMITTED PURSUANT TO SECTION 9-101, SUBSECTION C, PARAGRAPH 3.
11 THE PETITIONERS ARE NOT REQUIRED TO RESUBMIT A PETITION IF THE REMAINING
12 AREA PROPOSED FOR INCORPORATION MEETS THE POPULATION QUALIFICATIONS FOR
13 INCORPORATION PURSUANT TO THIS SECTION AND SECTION 9-101. IF THE REMAINING
14 AREA PROPOSED FOR INCORPORATION FAILS TO MEET THE POPULATION QUALIFICATIONS
15 FOR INCORPORATION PURSUANT TO THIS SECTION OR SECTION 9-101, THE BOARD
16 SHALL REJECT THE PETITION."
