15 DRUG THERAPY AND DISEASE MANAGEMENT SERVICES ONLY PURSUANT TO THOSE
16 GUIDELINES. THE GUIDELINES SHALL SPECIFY, AT A MINIMUM, THE SPECIFIC DRUG,
17 DRUGS OR DRUG CLASSES AND THE CONDITIONS TO BE MANAGED BY THE PHARMACIST,
18 THE CONDITIONS AND EVENTS FOR WHICH THE PHARMACIST MUST NOTIFY THE PROVIDER
19 AND THE LABORATORY TESTS THE PHARMACIST MAY ORDER."

1 Page 14, between lines 3 and 4, insert:

2 "F. THE ARIZONA STATE BOARD OF PHARMACY, THE ARIZONA MEDICAL BOARD,
3 THE ARIZONA BOARD OF OSTEOPATHIC EXAMINERS IN MEDICINE AND SURGERY AND THE
4 ARIZONA STATE BOARD OF NURSING MAY ADOPT RULES RELATING TO COLLABORATIVE
5 PRACTICE AGREEMENTS."

13 "2. INITIATE, MONITOR AND MODIFY DOES NOT INCLUDE A PHARMACIST'S
14 SELECTION OF DRUG PRODUCTS THAT ARE NOT PRESCRIBED BY THE PROVIDER UNLESS
15 THE SELECTION OF SPECIFIC DRUG PRODUCTS IS AUTHORIZED BY THE COLLABORATIVE
16 PRACTICE AGREEMENT."
