11 ADDITIONAL LANDS MAY BE IRRIGATED WITH GROUNDWATER FOR A PERIOD OF FIVE  
12 YEARS AFTER THE DATE OF THE TEMPORARY IRRIGATION NON-EXPANSION AREA IS  
13 ESTABLISHED. LAND THAT WAS NOT IRRIGATED AT ANY TIME DURING THIS FIVE-YEAR  
14 PERIOD IS DEEMED TO HAVE BEEN IN IRRIGATION IF THE DIRECTOR FINDS THAT  
15 SUBSTANTIAL CAPITAL INVESTMENT HAS BEEN MADE FOR THE SUBJUGATION OF THE  
16 LAND FOR AN IRRIGATION USE, INCLUDING ON-SITE IRRIGATION DISTRIBUTION  
17 FACILITIES AND A WELL OR WELLS THE DRILLING AND CONSTRUCTION OF WHICH WERE  
18 SUBSTANTIALLY COMMENCED BEFORE THE DATE OF THE NOTICE OF THE INITIATION OF  
19 DESIGNATION PROCEDURES."

20 Page 3, strike line 3, insert "MAY BE USED TO IRRIGATE ADDITIONAL LANDS."

21 Line 5, strike "INTERIM WATER REVIEW" insert "TEMPORARY IRRIGATION  
22 NON-EXPANSION"
