1 Page 1, line 9, after "DUTY" insert "OR A PERSON WHO IS THE SPOUSE OF A MEMBER OF  
2 THE NATIONAL GUARD OF THIS STATE OR ANY OTHER STATE OR THE UNITED STATES  
3 ARMED FORCES RESERVES, WHO IS A STUDENT AT AN INSTITUTION OF HIGHER  
4 EDUCATION IN THIS STATE AND WHOSE SPOUSE IS ORDERED TO EITHER STATE OR  
5 FEDERAL RESERVE COMPONENT DUTY, WHETHER THE MEMBER OR SPOUSE IS ATTENDING  
6 CLASS IN PERSON OR ONLINE AND WHETHER THE MEMBER IS STATIONED IN OR OUTSIDE  
7 OF THIS STATE."

8 Line 18, after "2." insert "DEPENDING ON WHEN THE MEMBER IS ORDERED TO EITHER  
9 STATE OR FEDERAL RESERVE COMPONENT DUTY AND DEPENDING ON THE INDIVIDUAL  
10 STUDENT'S NEEDS,"

11 Line 21, after "3." insert "IN ACCORDANCE WITH ANY ACADEMIC UNIT OR  
12 INSTITUTION OF HIGHER EDUCATION REQUIREMENTS,"

13 Line 22, strike "PERFORMING"

14 Lines 26 and 33, after "STUDENT" insert "OR STUDENT'S SPOUSE"

15 Line 40, strike "STUDENT'S"; after "RELEASE" insert "OF THE STUDENT OR  
16 STUDENT'S SPOUSE"

17 Page 2, line 10, after "STUDENT" insert "DESCRIBED IN SUBSECTION A OF THIS  
18 SECTION"; strike "PERFORMING"

19 Between lines 22 and 23, insert:  
20       "1. IF THE STATE OR FEDERAL RESERVE COMPONENT DUTY IS KNOWN IN  
21 ADVANCE, THE STUDENT MUST SUBMIT EVIDENCE DOCUMENTING THE STATE OR FEDERAL  
22 RESERVE COMPONENT DUTY TO THE FACULTY MEMBER TEACHING THE COURSE EARLY IN  
23 THE SEMESTER OR AS SOON AS PRACTICABLE BEFORE THE MISSED CLASS, ASSIGNMENT  
24 OR EXAMINATION. IF THE STATE OR FEDERAL RESERVE COMPONENT DUTY IS NOT
