1 Page 2, after line 35 insert:

2 "Sec. 2. Title 16, chapter 4, article 9, Arizona Revised Statutes,
3 is amended by adding section 16-567, to read:

4 16-567. Polling place and voting center equipment; custody;
5 violation; classification

6 A. NOTWITHSTANDING ANY OTHER LAW, ANY VOTING EQUIPMENT THAT IS USED
7 IN A POLLING PLACE OR VOTING CENTER MAY NOT HAVE INTERNET ACCESS AND MUST
8 PROHIBIT ACCESS BY ANY MEANS TO ANY DATA OR RESULTS. IF THE EQUIPMENT HAS
9 AN ACCESSIBLE PORT, THE PORT MUST BE LOCKED WITH A TAMPER-PROOF SEAL AND
10 MUST BE LOGGED IN THE CHAIN OF CUSTODY DOCUMENT WHEN BROKEN OR ACCESSED.
11 THE DELIVERY, USE AND RETURN OF THE EQUIPMENT SHALL BE LOGGED ON A CHAIN OF
12 CUSTODY DOCUMENT SO THAT THE NAME AND SIGNATURE OF EVERY PERSON WHO
13 DELIVERS, RECEIVES, USES AND RETURNS THAT EQUIPMENT IS RECORDED AND
14 RETAINED AS AN OFFICIAL ELECTION RECORD.

15 B. A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A CLASS 1
16 MISDEMEANOR.

17 Sec. 3. Title 16, chapter 4, article 10, Arizona Revised Statutes,
18 is amended by adding section 16-605, to read:

19 16-605. Counting center equipment; election results; data;
20 custody; violation; classification

21 A. NOTWITHSTANDING ANY OTHER LAW, ANY TABULATION EQUIPMENT THAT IS
22 USED IN A CENTRAL COUNTING CENTER OR OTHER TABULATION CENTER MAY NOT HAVE
23 INTERNET ACCESS AND MUST PROHIBIT ACCESS BY ANY MEANS TO ANY DATA OR
24 RESULTS UNTIL USED BY AUTHORIZED ELECTION PERSONNEL ONLY. IF THE EQUIPMENT
25 HAS AN ACCESSIBLE PORT, THE PORT MUST BE LOCKED WITH A TAMPER-PROOF SEAL
26 AND MUST BE LOGGED IN THE CHAIN OF CUSTODY DOCUMENT WHEN BROKEN OR
27 ACCESSED. ONLY AUTHORIZED PERSONNEL, INCLUDING POLITICAL PARTY OBSERVERS,
28 MAY BE PRESENT AT THE TABULATION OF VOTES. THE USE AND RETURN OF THE
29 EQUIPMENT THAT CONTAINS ELECTION RESULTS AND DATA, INCLUDING ANY REMOVABLE
30 DATA STORAGE DEVICE, SHALL BE LOGGED ON A CHAIN OF CUSTODY DOCUMENT SO THAT
31 THE NAME AND SIGNATURE OF EVERY PERSON WHO DELIVERS, RECEIVES, USES AND
32 RETURNS THE STORAGE DEVICE OR OTHER EQUIPMENT THAT CONTAINS ELECTION DATA
33 AND ELECTION RESULTS IS RECORDED AND RETAINED AS AN OFFICIAL ELECTION

1 RECORD. FOR ANY REMOVABLE STORAGE DEVICE, TWO OBSERVERS WHO ARE NOT
2 MEMBERS OF THE SAME POLITICAL PARTY SHALL BE PRESENT AT ALL TIMES,
3 INCLUDING THE INSERTION AND REMOVAL OF THE DEVICE AND DURING ANY
4 TRANSPORTATION OF THE DEVICE. THE REMOVABLE STORAGE DEVICE MAY NOT BE UNDER
5 THE SOLE CUSTODY AND CONTROL OF ONLY ONE PERSON.

6 B. A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A CLASS 1
7 MISDEMEANOR.

8 C. NOTWITHSTANDING ANY OTHER LAW, ALL ACTIVITIES AT THE COUNTING
9 CENTER SHALL BE INCLUDED IN A NONSTOP VIDEO THAT IS POSTED TO THE COUNTY'S
10 WEBSITE."
