(Reference to House engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 13-3401, Arizona Revised Statutes, is amended to
3 read:

4 13-3401. Definitions

5 In this chapter, unless the context otherwise requires:

6 1. "Administer" means to apply, inject or facilitate the inhalation
7 or ingestion of a substance to the body of a person.

8 2. "Amidone" means any substance identified chemically as
9 (4-4-diphenyl-6-dimethylamine-heptanone-3), or any salt of such substance,
10 by whatever trade name designated.

11 3. "Board" means the Arizona state board of pharmacy.

12 4. "Cannabis" means the following substances under whatever names
13 they may be designated:

14 (a) The resin extracted from any part of a plant of the genus
15 cannabis, and every compound, manufacture, salt, derivative, mixture or
16 preparation of such plant, its seeds or its resin. Cannabis does not
17 include oil or cake made from the seeds of such plant, any fiber, compound,
18 manufacture, salt, derivative, mixture or preparation of the mature stalks
19 of such plant except the resin extracted from the stalks or any fiber, oil
20 or cake or the sterilized seed of such plant which is incapable of
21 germination.

22 (b) Every compound, manufacture, salt, derivative, mixture or
23 preparation of such resin or tetrahydrocannabinol.

1 5. "Coca leaves" means cocaine, its optical isomers and any
2 compound, manufacture, salt, derivative, mixture or preparation of coca
3 leaves, except derivatives of coca leaves which do not contain cocaine,
4 ecgonine or substances from which cocaine or ecgonine may be synthesized or
5 made.

6 6. "Dangerous drug" means the following by whatever official,
7 common, usual, chemical or trade name designated:

8 (a) Any material, compound, mixture or preparation that contains any
9 quantity of the following hallucinogenic substances and their salts,
10 isomers, whether optical, positional or geometric, and salts of isomers,
11 unless specifically excepted, whenever the existence of such salts, isomers
12 and salts of isomers is possible within the specific chemical designation:

14 (ii) Alpha-methyltryptamine.
15 (iii) (2-aminopropyl) benzofuran (APB).

16 quantity of cannabimimetic substances and their salts, isomers, whether
17 optical, positional or geometric, and salts of isomers, unless specifically
18 excepted, whenever the existence of such salts, isomers and salts of
19 isomers is possible within the specific chemical designation. For the
20 purposes of this subdivision, "cannabimimetic substances" means any
21 substances within the following structural classes:

22 (i) 2-(3-hydroxycyclohexyl)phenol with substitution at the
23 5-position of the phenolic ring by alkyl or alkenyl, whether or not
24 substituted on the cyclohexyl ring to any extent. Substances in the
25 2-(3-hydroxycyclohexyl)phenol generic definition include CP-47,497,
26 CP-47,497 C8-Homolog, CP-55,940 and CP-56,667.

27 (ii) 3-(naphthoyl)indole or 3-(naphthylmethane)indole by
28 substitution at the nitrogen atom of the indole ring, whether or not
29 further substituted on the indole ring to any extent, whether or not
30 substituted on the naphthoyl or naphthyl ring to any extent. Substances in
31 the 3-(naphthoyl)indole generic definition include AM-678, AM-2201,

13 in the 3-naphthoyl-indazole or 3-(naphthylmethane)-indazole generic
14 definition include THJ2201 and THJ-018.

15 (iv) 3-(naphthoyl)pyrrole by substitution at the nitrogen atom of
16 the pyrrole ring, whether or not further substituted in the pyrrole ring to
17 any extent, whether or not substituted on the naphthoyl ring to any extent.
18 Substances in the 3-(naphthoyl)pyrrole generic definition include JWH-030,
19 JWH-145, JWH-146, JWH-147, JWH-150, JWH-156, JWH-243, JWH-244, JWH-245,
20 JWH-246, JWH-292, JWH-293, JWH-307, JWH-308, JWH-346, JWH-348, JWH-363,

27 JWH-176.

28 (vi) 3-(phenylacetyl)indole or 3-(benzoyl)indole by substitution at
29 the nitrogen atom of the indole ring, whether or not further substituted in
30 the indole ring to any extent, whether or not substituted on the phenyl
31 ring to any extent. Substances in the 3-(phenylacetyl)indole generic
32 definition include AM-694, AM-2233, JWH-167, JWH-201, JWH-202, JWH-203,

1 JWH-204, JWH-205, JWH-206, JWH-207, JWH-208, JWH-209, JWH--237, JWH-248,

9 cyclobutyl or cyclopentyl rings to any extent. Substances in the
10 3-(cyclopropylmethanone) indole generic definition include UR-144,
11 fluoro-UR-144 and XLR-11.

12 (viii) 3-adamantoylindole with substitution at the nitrogen atom of
13 the indole ring, whether or not further substituted on the indole ring to
14 any extent, whether or not substituted on the adamantyl ring to any
15 extent. Substances in the 3-adamantoylindole generic definition include
16 AB-001.

17 (ix) N-(adamantyl)-indole-3-carboxamide with substitution at the
18 nitrogen atom of the indole ring, whether or not further substituted on the
19 indole ring to any extent, whether or not substituted on the adamantyl ring
20 to any extent. Substances in the N-(adamantyl)-indole-3-carboxamide
21 generic definition include SDB-001.

22 (x) Indole-3-carboxamide or indazole-3-carboxamide with substitution
23 at the nitrogen atom of the indole ring or by substitution at one or both
24 of the nitrogen atoms of the indazole ring, whether or not further
25 substituted on the indole ring or the indazole ring to any extent, whether
26 or not substituted on the nitrogen of the carboxamide to any extent.
27 Substances in the indole-3-carboxamide or indazole-3-carboxamide generic
28 definition include AKB-48, fluoro-AKB-48, APINACA, AB-PINACA, AB-FUBINACA,
29 ABICA and ADBICA.

30 (xi) 8-Quinolinylnyl-indole-3-carboxylate or 8-quinolinylnyl-indazole-3-
31 carboxylate by substitution at the nitrogen atom of the indole ring or by
32 substitution at one or both of the nitrogen atoms of the indazole ring,

1 whether or not further substituted in the indole ring or indazole ring to
2 any extent, whether or not substituted on the quinoline ring to any extent.
3 Substances in the 8-quinolinyl-indole-3-carboxylate or the
4 8-quinolinyl-indazole-3-carboxylate generic definition include PB-22,
5 fluoro-PB-22, NPB-22 and fluoro-NPB-22.

6 (xii) Naphthalenyl-indole-3-carboxylate or naphthalenyl-indazole-3-
7 carboxylate by substitution at the nitrogen atom of the indole ring or by
8 substitution at one or both of the nitrogen atoms of the indazole ring,
9 whether or not further substituted in the indole or indazole ring to any
10 extent, whether or not substituted on the naphthalenyl ring to any extent.
11 Substances in the naphthalenyl-indole-3-carboxylate or
12 naphthalenyl-indazole-3-carboxylate generic definition include NM2201,

14 (c) Any material, compound, mixture or preparation that contains any
