1 Page 1, after line 19, insert:

2 "13. Tucson police department \$950,000

3 14. Yuma police department \$317,000

4 Sec. 2. Appropriation; state treasurer; rural county
5 interoperability communication system

6 A. The sum of \$3,980,000 is appropriated from the state general fund
7 in fiscal year 2022-2023 to the state treasurer for a rural county
8 interoperability communication system that:

9 1. Enables the deployment of secure, multimedia data communications
10 system to a user base consisting of public safety agencies.

11 2. Provides a communications solution environment that allows for
12 identifying a system user's identity, location and operational status
13 during an incident, secure text messaging and file sharing to all users
14 involved in an incident, secure sharing of collaborative maps, building
15 floor plans and images, integrating manually activated panic alarm systems
16 that, when activated, establish direct collaboration between public safety
17 agencies by using multiple forms of real-time communications and
18 information collaboration, including voice and full-motion video sharing,
19 during an incident.

1 3. Is capable of being deployed to end users on existing
2 communication assets owned by participating entities.

3 4. Allows each participating entity to maintain discretionary
4 real-time control of all communications assets owned or operated by the
5 entity.

6 5. Encrypts all media communications.

7 6. Ensures staff privacy.

8 7. Is United States department of homeland security safety act
9 certified qualified antiterrorism technology.

10 8. Is compatible with federal emergency management agency
11 interoperable gateway systems for disaster communications.

12 B. The state treasurer shall distribute the monies appropriated in
13 subsection A of this section in the following amounts to the following
14 recipients for a rural county interoperability communication system:

5 Sec. 3. Appropriation; state treasurer; simulators

6 A. The sum of \$800,000 is appropriated from the state general fund
7 in fiscal year 2022-2023 to the state treasurer for training simulators.

8 B. The state treasurer shall distribute the monies appropriated in
9 subsection A of this section in the following amounts to the following
10 recipients to purchase five screen V-300LE training simulators:

- 11 1. Arizona state university police department \$200,000
- 12 2. City of Flagstaff police department \$200,000
- 13 3. Gila county sheriff \$200,000
- 14 4. Santa Cruz county sheriff \$200,000"
