AMENDING TITLE 41, CHAPTER 1, ARTICLE 1, ARIZONA REVISED STATUTES, BY
ADDING SECTION 41-111; APPROPRIATING MONIES; RELATING TO THE GOVERNOR'S
OFFICE.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 41, chapter 1, article 1, Arizona Revised
3 Statutes, is amended by adding section 41-111, to read:
4 41-111. Governor's office of equal opportunity; ADA
5 coordinator; annual plan
6 A. THE GOVERNOR'S OFFICE OF EQUAL OPPORTUNITY SHALL HIRE A
7 FULL-TIME STATEWIDE AMERICANS WITH DISABILITIES COORDINATOR.
8 B. THE AMERICANS WITH DISABILITIES COORDINATOR SHALL IMPLEMENT AN
9 ANNUAL PLAN TO CARRY OUT THE REQUIREMENTS OF THE AMERICANS WITH
10 DISABILITIES ACT IN THIS STATE. THE PLAN SHALL:
11 1. BE COMMUNITY BASED.
12 2. PROMOTE THE COORDINATION OF DISABILITIES ACTIVITIES THROUGHOUT
13 THIS STATE.
14 3. INCLUDE A COMPONENT THAT PROVIDES EDUCATIONAL OPPORTUNITIES FOR
15 SMALL BUSINESSES.
16 4. ENCOURAGE COORDINATION BETWEEN THE SMALL BUSINESS COMMUNITY AND
17 THE DISABILITY COMMUNITY TO BETTER ENHANCE COMPLIANCE WITH THE AMERICANS
18 WITH DISABILITIES ACT IN PUBLIC AND PRIVATE SETTINGS.
19 5. INCLUDE SPECIFIC ENFORCEMENT OF DISABILITY ACCESSIBILITY GOALS
20 AND A METHOD FOR MEASURING THE PROGRESS TOWARD THE ATTAINMENT OF THE
21 GOALS.
22 Sec. 2. Appropriation; office of governor
23 The sum of \$100,000 and 1 FTE position are appropriated from the
24 state general fund in fiscal year 2022-2023 to the office of the governor
25 for personal services and employee-related expenditures for an Americans
26 with disabilities coordinator.
