# **SB 1145**

AN ACT

AMENDING SECTION 15-1628, ARIZONA REVISED STATUTES; RELATING TO THE ARIZONA BOARD OF REGENTS.

1 Be it enacted by the Legislature of the State of Arizona:  
2       Section 1. Section 15-1628, Arizona Revised Statutes, is amended to  
3 read:

4           15-1628. Powers and procedures pertaining to optional  
5           retirement programs

6           A. The Arizona board of regents may establish optional retirement  
7 programs under which contracts providing retirement and death benefits may  
8 be purchased for **EMPLOYEES WHO ARE HIRED ON OR AFTER JANUARY 1, 2023,**  
9 members of the faculty and administrative officers of the institutions  
10 under its jurisdiction. The benefits to be provided for or on behalf of  
11 participants in the optional retirement program shall be provided through  
12 annuity contracts, fixed or variable in nature, or a combination thereof,  
13 or other retirement plans approved by the Arizona board of regents.

14           B. Elections to participate in the optional retirement programs  
15 shall be made as follows:

16           1. Eligible employees **WHO ARE** initially appointed on or after  
17 August 9, 1974 shall elect to become members of the Arizona state  
18 retirement system or to participate in an optional retirement program  
19 established by the Arizona board of regents. The election shall be made  
20 in writing and filed with the Arizona state retirement system and the  
21 disbursing officer of the employing institution and shall be effective as  
22 of the effective date of appointment. If an eligible employee fails to  
23 make an election as provided in this paragraph, the eligible employee  
24 shall be deemed to have elected membership in the Arizona state retirement  
25 system.

26           2. Eligible employees **WHO ARE** initially appointed before August 9,  
27 1974 may elect to participate in the optional retirement programs. The  
28 election shall be made in writing and filed with the Arizona state  
29 retirement system and the disbursing officer of the employing institution  
30 on or before December 14, 1974, shall become effective as of January 1,  
31 1975 and shall constitute a waiver of all benefits provided by the Arizona  
32 state retirement system, except all such benefits as are expressly  
33 provided by law.

34           3. Any employee who becomes eligible may elect an optional  
35 retirement program. The election shall be made in writing and filed with  
36 the Arizona state retirement system and the disbursing officer of the  
37 employing institution within thirty days after notice in writing to the  
38 employee of the employee's eligibility, and shall become effective on the  
39 first day of the pay period following such election, and shall constitute  
40 a waiver of all benefits provided by the Arizona state retirement system,  
41 except all such benefits as are expressly provided by law.

42           4. Any eligible employee who is a member of the Arizona state  
43 retirement system at the time the employee elects to participate in the  
44 optional retirement program shall leave the **funds MONIES** in the employee's  
45 retirement account on deposit with the Arizona state retirement system  
46 during the continuance of employment. Additional contributions to the

1 employee's retirement account shall not be required, and continued service  
2 with the Arizona board of regents or an institution under the jurisdiction  
3 of the Arizona board of regents while under an optional retirement program  
4 shall be deemed to be member service in the Arizona state retirement  
5 system for the purpose of determining eligibility for any benefits under  
6 such system. The amount of any such benefits under such system shall be  
7 computed only on the basis of service otherwise creditable to a member of  
8 the system and the employee's compensation during such service. For  
9 purposes of subsection D of this section, years of member service in the  
10 Arizona state retirement system shall count as years of service under the  
11 optional retirement programs.

12 C. The Arizona board of regents shall contribute public ~~funds~~  
13 MONIES appropriated or any other ~~funds~~ MONIES available for such purpose  
14 on behalf of each participant in the optional retirement programs in an  
15 amount equal to seven ~~per cent~~ PERCENT of the participant's compensation.  
16 Each participant shall also contribute an amount equal to seven ~~per cent~~  
17 PERCENT of the participant's compensation. The appropriation to each  
18 university for purposes of enabling the Arizona board of regents to make  
19 the contribution provided in this subsection shall not exceed the employer  
20 contribution required under the Arizona state retirement system as  
21 prescribed by title 38, chapter 5, article 2. ~~Funds utilized~~ MONIES USED  
22 by the ARIZONA board of regents or by a university to pay that portion of  
23 the contribution that represents the difference between the employer  
24 contribution as prescribed by title 38, chapter 5, article 2 and the  
25 contribution rate provided in this subsection for an optional retirement  
26 program do not constitute a use of appropriated monies for supplemental  
27 retirement.

28 D. In the case of an electing employee initially appointed on or  
29 after August 9, 1974, contributions pursuant to subsection C of this  
30 section shall not be made by the Arizona board of regents until the  
31 employee's completion of five years of service. Employee contributions  
32 required during this initial ~~five year~~ FIVE-YEAR period and during  
33 continued service with an institution under the jurisdiction of the  
34 Arizona board of regents shall be promptly remitted to the optional  
35 retirement programs approved by the Arizona board of regents. At the end  
36 of an electing employee's completion of five years of service, a single  
37 contribution in an amount determined pursuant to subsection C of this  
38 section, with interest, shall be made by the chief financial officer of  
39 the employing institution to the approved company or companies on behalf  
40 of ~~such~~ THAT employee. In the case of an electing employee who does not  
41 continue in service with an institution under the jurisdiction of the  
42 Arizona board of regents for at least five years, the amount of employer  
43 contributions, with interest, shall be ~~refunded to this state~~ FORFEITED TO  
44 THE INSTITUTION AND USED TO MAKE FUTURE EMPLOYER CONTRIBUTIONS AS REQUIRED  
45 BY SUBSECTION C OF THIS SECTION.

1       E. If an employee's service is terminated by death ~~prior to~~ BEFORE  
2 the completion of five years of service, a death benefit equal to the sums  
3 appropriated for ~~such~~ THAT employee, plus interest, shall be paid to the  
4 beneficiary designated by the participant under the participant's optional  
5 retirement program.

6       F. ~~The provisions of~~ Subsection D of this section ~~shall~~ DOES not  
7 apply to any electing employee who, at the time of initial appointment,  
8 owns a contract determined by the Arizona board of regents to be  
9 acceptable for use in the optional retirement program.

10     G. The Arizona board of regents may provide for the administration  
11 of such optional retirement programs and perform or authorize the  
12 performance of such functions as may be necessary for such purposes. The  
13 Arizona board of regents shall approve the company or companies from which  
14 benefits may be purchased under the optional retirement programs. Such  
15 optional retirement programs shall not ~~permit~~ ALLOW loans. In giving its  
16 approval, the board shall consider:

17       1. The nature and extent of the rights and benefits to be provided  
18 for participants and their beneficiaries.

19       2. The relation of such rights and benefits to the amount of  
20 contributions to be made.

21       3. The suitability of such rights and benefits to the needs of the  
22 participants and the interests of the institutions under ~~its~~ THE BOARD'S  
23 jurisdiction in ~~the recruitment~~ RECRUITING and ~~retention of~~ RETAINING  
24 faculty, ~~and~~ administrative officers AND EMPLOYEES.

25       4. The ability of the approved company or companies to provide such  
26 suitable rights and benefits.

27       H. Any eligible employee WHO IS initially appointed after August 9,  
28 1974, ~~electing~~ AND WHO ELECTS to participate in the optional retirement  
29 programs, ~~shall be~~ IS ineligible for membership in the Arizona state  
30 retirement system as long as the employee remains continuously employed in  
31 any position by the Arizona board of regents or by an institution under  
32 its jurisdiction, except as expressly provided by law.

33       I. The benefits, annuities and employee and employer contributions  
34 provided for in this section, and all interest, earnings and other credits  
35 pertaining to such benefits, annuities and contributions, shall not be  
36 subject to execution or attachment and shall be nonassignable. The  
37 employee and employer contributions provided for in this section and all  
38 interest, earnings and other credits pertaining to such contributions are  
39 exempt from state, county and municipal taxes. The benefits and annuities  
40 received by an employee under this section after December 31, 1988 are  
41 subject to tax pursuant to title 43.

42       J. Subject to amendment of the federal-state agreement provided for  
43 in section 38-702, every eligible employee electing to participate in the  
44 optional retirement programs shall have old age, survivors and disability  
45 insurance coverage provided by the federal social security act in  
46 accordance with ~~the provisions of~~ title 38, chapter 5, article 1.
