SENATE BILL 1180

AN ACT

PRESCRIBING REPORTING REQUIREMENTS FOR COVID-RELATED EXPENDITURES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. COVID-related expenditures; reporting
3 requirements; intent

4 A. Before spending monies from the coronavirus state fiscal
5 recovery fund and the coronavirus capital projects fund as appropriated by
6 section 9901 of the American rescue plan act of 2021 (P.L. 117-2) in the
7 amount of \$10,000,000 or more for one designated purpose, the office of
8 the governor shall notify the president of the senate, the speaker of the
9 house of representatives, the chairpersons of the senate and house of
10 representatives appropriations committees and the director of the joint
11 legislative budget committee of the intended use of the monies.

12 B. Within thirty days after the last day of each calendar quarter
13 through June 30, 2024, the office of the governor shall report to the
14 president of the senate, the speaker of the house of representatives, the
15 chairpersons of the senate and house of representatives appropriations
16 committees and the director of the joint legislative budget committee the
17 actual expenditures from the coronavirus state fiscal recovery fund and
18 the coronavirus capital projects fund as appropriated by section 9901 of
19 the American rescue plan act of 2021 (P.L. 117-2).

20 C. Before spending monies allocated to the superintendent of public
21 instruction from the elementary and secondary school emergency relief fund
22 as appropriated by section 2001 of the American rescue plan act of 2021
23 (P.L. 117-2) in the amount of \$10,000,000 or more for one designated
24 purpose, the superintendent of public instruction shall notify the
25 president of the senate, the speaker of the house of representatives, the
26 chairpersons of the senate and house of representatives appropriations
27 committees and the director of the joint legislative budget committee of
28 the intended use of the monies.

29 D. Within thirty days after the last day of each calendar quarter
30 through June 30, 2024, the superintendent of public instruction shall
31 report to the president of the senate, the speaker of the house of
32 representatives, the chairpersons of the senate and house of
33 representatives appropriations committees and the director of the joint
34 legislative budget committee the actual expenditure of monies allocated to
35 the superintendent of public instruction from the elementary and secondary
36 school emergency relief fund as appropriated by section 2001 of the
37 American rescue plan act of 2021 (P.L. 117-2).

38 E. Before spending monies from the higher education emergency
39 relief fund as appropriated by section 2003 of the American rescue plan
40 act of 2021 (P.L. 117-2) in the amount of \$10,000,000 or more for one
41 designated purpose, the Arizona board of regents shall report to the
42 president of the senate, the speaker of the house of representatives, the
43 chairpersons of the senate and house of representatives appropriations
44 committees and the director of the joint legislative budget committee the

1 intended use of the monies by Arizona state university, the university of
2 Arizona and northern Arizona university.

3 F. Within thirty days after the last day of each calendar quarter
4 through June 30, 2024, the Arizona board of regents shall report to the
5 president of the senate, the speaker of the house of representatives, the
6 chairpersons of the senate and house of representatives appropriations
7 committees and the director of the joint legislative budget committee the
8 actual expenditure of monies from the higher education emergency relief
9 fund as appropriated by section 2003 of the American rescue plan act of
10 2021 (P.L. 117-2) by Arizona state university, the university of Arizona
11 and northern Arizona university.

12 G. Reports required pursuant to this section shall delineate
13 expenditures by agency and program and include descriptions of the purpose
14 of the expenditures.

15 H. The legislature intends that the executive branch of state
16 government report on its planned and actual use of any major additional
17 federal aid to the state of Arizona through federal legislation enacted by
18 the end of fiscal year 2021-2022. The timing and frequency of these
19 reports should be the same as required by subsections A through F of this
20 section. The chairman and vice chairman of the joint legislative budget
21 committee may provide recommendations to the executive branch concerning
22 federal legislation that would qualify under this subsection.
