SENATE BILL 1184

AN ACT

APPROPRIATING MONIES TO THE ARIZONA HEALTH CARE COST CONTAINMENT SYSTEM
ADMINISTRATION, THE DEPARTMENT OF ECONOMIC SECURITY AND THE DEPARTMENT OF
CHILD SAFETY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Supplemental appropriations; Arizona health care
3 cost containment system administration;
4 department of economic security; reports;
5 exemption

6 A. In addition to any other appropriations made in fiscal year
7 2021-2022, the following sums are appropriated to the following agencies
8 in fiscal year 2021-2022:

9 1. The sums of \$30,121,100 from the children's health insurance
10 program fund established by section 36-2995, Arizona Revised Statutes, and
11 \$1,078,032,800 of expenditure authority are appropriated to the Arizona
12 health care cost containment system administration to implement the
13 American rescue plan act of 2021 home and community-based services
14 spending plan and to adjust funding formula requirements.

15 2. The sum of \$362,700,000 of expenditure authority is appropriated
16 to the department of economic security division of developmental
17 disabilities to implement the American rescue plan act of 2021 home and
18 community-based services spending plan.

19 B. The Arizona health care cost containment system administration
20 may not use any monies appropriated in subsection A of this section for
21 marketing purposes. Any direct payments or grants provided with the
22 monies appropriated in subsection A of this section shall include a
23 notification to the recipient that the monies are onetime funding.

24 C. The Arizona health care cost containment system administration
25 shall provide quarterly reports to the joint legislative budget committee,
26 at the same time that the information is provided to the centers for
27 medicare and medicaid services, reflecting any changes to the
28 administration's spending plan for the implementation of the American
29 rescue plan act of 2021.

30 D. The appropriations made in subsection A of this section are
31 exempt from the provisions of section 35-190, Arizona Revised Statutes,
32 relating to lapsing of appropriations.

33 Sec. 2. Supplemental appropriation; department of child
34 safety; exemption

35 A. In addition to any other appropriations made in fiscal year
36 2021-2022, the sum of \$15,100,000 of expenditure authority is appropriated
37 in fiscal year 2021-2022 to the department of child safety operating lump
38 sum line item to continue existing functionality and oversight and to
39 claim available federal monies that will expire and revert back to the
40 federal government.

41 B. The appropriation made in subsection A of this section is exempt
42 from the provisions of section 35-190, Arizona Revised Statutes, relating
43 to lapsing of appropriations.
