AMENDING SECTIONS 32-1233, 32-1234, 32-1276.01 AND 32-1285, ARIZONA REVISED STATUTES; RELATING TO THE STATE BOARD OF DENTAL EXAMINERS.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 32-1233, Arizona Revised Statutes, is amended to
3 read:

4 32-1233. Applicants for licensure; examination requirements

5 An applicant for licensure shall have passed ~~all~~ BOTH of the
6 following:

7 1. The written national dental board examinations.

8 2. ~~The western regional examining board examination or A~~
9 PSYCHOMOTOR clinical examination administered by ~~another~~ A state or
10 regional testing agency in the United States within five years preceding
11 filing the application.

12 ~~3. The Arizona dental jurisprudence examination.~~

13 Sec. 2. Section 32-1234, Arizona Revised Statutes, is amended to
14 read:

15 32-1234. Dental consultant license

16 A person may apply for a dental consultant license if the
17 applicant demonstrates to the board's satisfaction that the applicant:

18 1. Has continuously held a license to practice dentistry for at
19 least twenty-five years issued by one or more states or territories of the
20 United States or the District of Columbia,~~—~~ but is not currently licensed
21 to practice dentistry in Arizona.

22 2. Is of good moral character.

23 3. Has not had a license to practice dentistry revoked by a dental
24 regulatory board in another jurisdiction in the United States for an act
25 that occurred in that jurisdiction and that constitutes unprofessional
26 conduct pursuant to this chapter.

27 4. Is not currently under suspension or restriction by a dental
28 regulatory board in another jurisdiction in the United States for an act
29 that occurred in that jurisdiction and that constitutes unprofessional
30 conduct pursuant to this chapter.

31 5. Has not surrendered, relinquished or given up a license to
32 practice dentistry in lieu of disciplinary action by a dental regulatory
33 board in another jurisdiction in the United States for an act that
34 occurred in that jurisdiction and that constitutes unprofessional conduct
35 pursuant to this chapter.

36 6. Meets the applicable requirements of section 32-1232.

37 7. Meets the requirements of section 32-1233, ~~paragraphs~~ PARAGRAPH
38 1 ~~and~~ 3. If an applicant has taken a state written theory examination
39 instead of the written national dental board examinations, the applicant
40 must provide the board with official documentation of passing the written
41 theory examinations in the state where the applicant holds a current
42 license. The board shall then determine the applicant's eligibility for a
43 license pursuant to this section.

1 8. Meets the application requirements as prescribed in rule by the
2 board.

3 B. The board shall suspend an application for a dental consultant
4 license if the applicant is currently under investigation by a dental
5 regulatory board in another jurisdiction in the United States. The board
6 shall not issue or deny a license to the applicant until the investigation
7 is resolved.

8 C. A person to whom a dental consultant license is issued shall
9 practice dentistry only in the course of the person's employment or on
10 behalf of an entity licensed under title 20 with the practice limited to
11 supervising or conducting utilization review or other claims or case
12 management activity on behalf of the entity licensed pursuant to title 20.
13 A person who holds a dental consultant license is prohibited from
14 providing direct patient care.

15 D. This section ~~shall~~ DOES not ~~be deemed to~~ require a person to
16 apply for or hold a dental consultant license in order for that person to
17 serve as a consultant to or engage in claims review activity for an entity
18 licensed pursuant to title 20.

19 E. Except as provided in subsection B of this section, a dental
20 consultant licensee is subject to all of the provisions of this chapter
21 that are applicable to licensed dentists.

22 Sec. 3. Section 32-1276.01, Arizona Revised Statutes, is amended to
23 read:

24 32-1276.01. Application for licensure; requirements;
25 fingerprint clearance card; denial or
26 suspension of application

27 A. An applicant for licensure as a dental therapist in this state
28 shall do all of the following:

29 1. Apply to the board on a form prescribed by the board.

30 2. Verify under oath that all statements in the application are
31 true to the applicant's knowledge.

32 3. Enclose with the application:

33 (a) A recent photograph of the applicant.

34 (b) The application fee established by the board by rule.

35 B. The board may grant a license to practice dental therapy to an
36 applicant who meets all of the following requirements:

37 1. Is licensed as a dental hygienist pursuant to article 4 of this
38 chapter.

39 2. Graduates from a dental therapy education program that is
40 accredited by or holds an initial accreditation from the American dental
41 association commission on dental accreditation and that is offered through
42 an accredited higher education institution recognized by the United States
43 department of education.

2 ~~(a)~~ within five years before filing the application, a PSYCHOMOTOR
3 clinical examination ~~that is either:~~
4 ~~(i) The western regional examining board examination.~~

11 4. Is not subject to any grounds for denial of the application
12 under this chapter.
13 5. Obtains a valid fingerprint clearance card issued pursuant to
14 title 41, chapter 12, article 3.1.
15 6. Meets all requirements for licensure established by the board by
16 rule.
17 C. The board may deny an application for licensure or license
18 renewal if the applicant:
19 1. Has committed an act that would be cause for censure, probation
20 or suspension or revocation of a license under this chapter.
21 2. While unlicensed, committed or aided and abetted the commission
22 of an act for which a license is required by this chapter.
23 3. Knowingly made any false statement in the application.
24 4. Has had a license to practice dental therapy revoked by a
25 regulatory board in another jurisdiction in the United States for an act
26 that occurred in that jurisdiction and that constitutes unprofessional
27 conduct pursuant to this chapter.
28 5. Is currently suspended or restricted by a regulatory board in
29 another jurisdiction in the United States for an act that occurred in that
30 jurisdiction and that constitutes unprofessional conduct pursuant to this
31 chapter.
32 6. Has surrendered, relinquished or given up a license to practice
33 dental therapy instead of having disciplinary action taken against the
34 applicant by a regulatory board in another jurisdiction in the United
35 States for an act that occurred in that jurisdiction and that constitutes
36 unprofessional conduct pursuant to this chapter.
37 D. The board shall suspend an application for licensure if the
38 applicant is currently under investigation by a dental regulatory board in
39 another jurisdiction. The board shall not issue a license or deny an
40 application for licensure until the investigation is completed.
