AMENDING SECTION 18-104, ARIZONA REVISED STATUTES; REPEALING SECTION 18-105, ARIZONA REVISED STATUTES; AMENDING SECTIONS 18-121, 41-4252, 41-4253, 41-4254 AND 41-4255, ARIZONA REVISED STATUTES; REPEALING SECTIONS 41-4256 AND 41-4257, ARIZONA REVISED STATUTES; AMENDING SECTION 41-4258, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 41, ARIZONA REVISED STATUTES, BY ADDING ARTICLE 3; RELATING TO INFORMATION TECHNOLOGY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section. 1. Section 18-104, Arizona Revised Statutes, is amended to
3 read:

4 18-104. Powers and duties of the department; violation;
5 classification

6 A. The department shall:

7 1. Develop, implement and maintain a coordinated statewide plan for
8 information technology. This includes:

9 (a) Adopting statewide technical, ~~AND~~ coordination ~~and security~~
10 standards for information technology.

11 (b) Serving as statewide coordinator for information technology
12 resources.

13 (c) Developing a statewide disaster recovery plan, **IDENTIFYING**
14 **RISKS IN EACH BUDGET UNIT AND DIRECTING AGENCIES TO ADOPT RISK MITIGATION**
15 **STRATEGIES, METHODS AND PROCEDURES TO MINIMIZE THE RISKS.**

16 (d) Developing a list of approved department projects by priority
17 category.

18 (e) Developing a detailed list of information technology assets
19 that are owned, leased or employed by this state.

20 (f) Evaluating and either approving or disapproving budget unit
21 information technology plans. Budget units shall submit information
22 technology plans that include quality assurance plans and disaster
23 recovery plans to the department each year on or before May 15. The
24 legislative and judicial departments of state government shall submit
25 information technology plans on or before September 1 for information
26 purposes.

27 (g) Evaluating specific information technology projects relating to
28 the approved budget unit and statewide information technology plans **IN**
29 **CONSULTATION WITH THE STATEWIDE INFORMATION SECURITY AND PRIVACY OFFICE IN**
30 **THE ARIZONA DEPARTMENT OF HOMELAND SECURITY.** The department shall approve
31 or reject projects with total costs of at least \$25,000 but not more than
32 \$1,000,000 and may establish conditional approval criteria, including
33 procurement purchase authority. If the total project costs exceed
34 \$1,000,000, the department shall evaluate the project and make
35 recommendations to the information technology authorization committee. If
36 the total project costs exceed \$5,000,000, the department shall require
37 the budget unit to contract with an independent third party to review and
38 guide the technology approach, scope, estimated cost, timeline for
39 completion and overall feasibility of the project before making
40 recommendations to the information technology authorization committee. On
41 or before the thirtieth day following the last day of each calendar
42 quarter, the budget unit shall submit a report from the independent third
43 party to the information technology authorization committee and the joint
44 legislative budget committee regarding the progress of each ongoing
45 project. As part of a budget request for an information technology

1 project that has total costs of at least \$25,000, a budget unit shall
2 indicate the status of review by the department. Projects shall not be
3 artificially divided to avoid review by the department.

4 2. Require that budget units incorporate a life-cycle analysis into
5 the information technology planning, budgeting and procurement processes.

6 3. Require that budget units demonstrate expertise to carry out
7 information technology plans, either by employing staff or contracting for
8 outside services.

9 4. Monitor information technology projects that the department
10 considers to be major or critical, including expenditure and activity
11 reports and periodic review.

12 5. Temporarily suspend the expenditure of monies if the department
13 determines that the information technology project is at risk of failing
14 to achieve its intended results or does not comply with the requirements
15 of this section.

16 6. Continuously study emergent technology and evaluate its impact
17 on this state's system.

18 7. Advise each budget unit as necessary and report to the committee
19 on an annual basis.

20 8. Provide to budget units information technology consulting
21 services it deems necessary, either directly or by procuring outside
22 consulting services.

23 9. Maintain all otherwise confidential information received from a
24 budget unit pursuant to this section as confidential.

25 10. Provide staff support to the committee.

26 11. Subject to section 35-149, accept, spend and account for
27 grants, monies and direct payments from public or private sources and
28 other grants of monies or property to conduct programs that it deems
29 consistent with the government information technology purposes and
30 objectives of the department.

31 12. Adopt rules it deems necessary or desirable to further the
32 government information technology objectives and programs of the
33 department.

34 13. Formulate policies, plans and programs to effectuate the
35 government information technology purposes of the department.

36 14. Advise and make recommendations to the governor and the
37 legislature on all matters concerning its objectives.

38 15. Contract and enter into interagency and intergovernmental
39 agreements pursuant to title 11, chapter 7, article 3 with any public or
40 private party.

41 16. Have an official seal that shall be judicially noticed.

42 17. Establish an interactive online directory of codes, rules,
43 ordinances, if available electronically, and statutes to assist
44 individuals and businesses with regulatory requirements and obligations.

1 As provided in this paragraph, counties, municipalities and budget units
2 shall submit information in a manner and format prescribed by the agency.

3 18. MANAGE ENTERPRISE-LEVEL INFORMATION TECHNOLOGY INFRASTRUCTURE,
4 EXCEPT THAT THE INFORMATION SECURITY AND PRIVACY OFFICE IN THE ARIZONA
5 DEPARTMENT OF HOMELAND SECURITY SHALL MANAGE THE INFORMATION SECURITY
6 ASPECTS OF THE INFRASTRUCTURE.

7 19. DEVELOP STRATEGIES TO PROTECT THE INFORMATION TECHNOLOGY
8 INFRASTRUCTURE OF THIS STATE AND THE DATA THAT IS STORED ON OR TRANSMITTED
9 BY THE INFRASTRUCTURE.

10 20. TEMPORARILY SUSPEND ACCESS TO INFORMATION TECHNOLOGY
11 INFRASTRUCTURE WHEN DIRECTED BY THE ARIZONA DEPARTMENT OF HOMELAND
12 SECURITY AND CONSULT WITH THE ARIZONA DEPARTMENT OF HOMELAND SECURITY
13 REGARDING SECURITY POLICIES, STANDARDS AND PROCEDURES.

14 B. The department shall advise the judicial and legislative
15 branches of state government concerning information technology.

16 C. The department may examine all books, papers, records and
17 documents in the office of any budget unit and may require any state
18 officer of the budget unit to furnish information or statements necessary
19 to carry out this chapter.

20 D. The director, any member of the director's staff or any employee
21 who knowingly divulges or makes known in any manner not permitted by law
22 any particulars of any confidential record, document or information is
23 guilty of a class 5 felony.

25 Section 18-105, Arizona Revised Statutes, is repealed.

26 Sec. 3. Section 18-121, Arizona Revised Statutes, is amended to
27 read:

28 18-121. Information technology authorization committee;
29 members; terms; duties; compensation; definition

30 A. The information technology authorization committee is
31 established consisting of the following members:

32 1. One member of the house of representatives who is appointed by
33 the speaker of the house of representatives and who shall serve as an
34 advisory member.

35 2. One member of the senate who is appointed by the president of
36 the senate and who shall serve as an advisory member.

37 3. Four members from private industry who are appointed by the
38 governor pursuant to section 38-211, or their designees, and who are
39 knowledgeable in information technology.

40 4. One local government member and one federal government member
41 who are appointed by the governor and who shall serve as advisory members.

42 5. Two members who are directors of state agencies and who are
43 appointed by the governor, or their designees.

44 6. The administrative director of the courts or the director's
45 designee.

1 7. The director of the department of administration or the
2 director's designee, who shall be the chairperson of the committee but for
3 all other purposes shall serve as an advisory member.

4 8. Two members from either private industry or state government who
5 are appointed by the governor, or their designees.

6 9. The staff director of the joint legislative budget committee, or
7 the staff director's designee, who shall serve as an advisory member.

8 10. THE STATEWIDE CHIEF INFORMATION SECURITY OFFICER OR THE
9 OFFICER'S DESIGNEE.

10 B. Committee members who are from private industry serve two-year
11 terms. The other members serve at the pleasure of their appointing
12 officers.

13 C. For all budget units and the legislative and judicial branches
14 of state government, the committee shall:

15 1. Review established statewide information technology standards
16 and the statewide information technology plan.

17 2. Review the minimum qualifications established by the director
18 for each position authorized for the department for information
19 technology.

20 3. Approve or disapprove all proposed information technology
21 projects, including project changes and contract amendments, that exceed a
22 total cost of ~~one million dollars~~ \$1,000,000, excluding public monies from
23 county, municipal and other political subdivision sources that are not
24 deposited in a state fund. The committee shall also approve or disapprove
25 any proposed information technology project involving more than one budget
26 unit if the collective total development cost of the project is expected
27 to be more than ~~one million dollars~~ \$1,000,000. As part of a budget
28 request for an information technology project that has total costs of more
29 than ~~one million dollars~~ \$1,000,000, a budget unit and the legislative and
30 judicial branches of state government shall indicate the status of review
31 by the committee. Projects shall not be artificially divided to avoid
32 review by the committee.

33 4. Develop a report format that incorporates the life-cycle
34 analysis for use in submitting project requests to the committee.

35 5. Require expenditure and activity reports from a budget unit or
36 the legislative or judicial branch of state government on implementing
37 information technology projects approved by the committee.

38 6. Conduct periodic reviews on the progress of implementing
39 information technology projects approved by the committee.

40 7. Monitor information technology projects that the committee
41 considers to be major or critical.

42 8. Temporarily suspend the expenditure of monies if the committee
43 determines that the information technology project is at risk of failing
44 to achieve its intended results or does not comply with the requirements
45 of this chapter.

1 9. Hear and decide appeals made by budget units regarding the
2 department's rejection of their proposed information technology plans or
3 projects.

4 10. Report to the governor, the speaker of the house of
5 representatives, the president of the senate and the secretary of state at
6 least annually on all matters concerning its objectives. This includes:

7 (a) Its review of the statewide information technology plan
8 developed by the department.

9 (b) The findings and conclusions of its periodic reviews.

10 (c) Its recommendations on desirable legislation relating to
11 information technology.

12 11. Adopt rules it deems necessary or desirable to further the
13 objectives and programs of the committee.

14 D. The committee shall meet at the call of the chairperson.

15 E. Members of the committee are not eligible to receive
16 compensation but are eligible to receive reimbursement for expenses
17 pursuant to title 38, chapter 4, article 2.

18 F. For the purposes of this section, "advisory member" means a
19 member who gives advice to the other members of the committee at committee
20 meetings but who is not eligible to vote and is not a member for purposes
21 of determining whether a quorum is present.

22 Sec. 4. Section 41-4252, Arizona Revised Statutes, is amended to
23 read:

24 41-4252. Arizona department of homeland security; director;
25 deputy director; assistant directors; divisions

26 A. The Arizona department of homeland security is established. The
27 direction, operation and control of the department are the responsibility
28 of the director.

29 B. The governor shall appoint the director pursuant to section
30 38-211. The director shall administer the department and serve at the
31 pleasure of the governor. The director is entitled to receive
32 compensation as determined under section 38-611. The director shall
33 appoint a deputy director **AND A STATEWIDE CHIEF INFORMATION SECURITY**
34 **OFFICER** and, subject to legislative appropriation, may appoint **ADDITIONAL**
35 **DEPUTY DIRECTORS AND** those assistant directors as the director deems
36 appropriate. The positions of director, **STATEWIDE CHIEF INFORMATION**
37 **SECURITY OFFICER** and deputy director are exempt from chapter 4, articles 5
38 and 6 of this title relating to the state service.

39 C. To be eligible for appointment as director a person must have a
40 background or experience in one or more of the following areas:

- 41 1. Public administration.
- 42 2. Disaster response.
- 43 3. Law enforcement.
- 44 4. Business administration.
- 45 5. **CYBERSECURITY.**

1 D. The director may organize the department into divisions the
2 director deems appropriate.

3 Sec. 5. Section 41-4253, Arizona Revised Statutes, is amended to
4 read:

5 41-4253. Department employees

6 Subject to chapter 4, article 4 and, as applicable, articles 5 and 6
7 of this title, the director shall employ, determine the conditions of
8 employment of and specify the duties of ~~administrative, secretarial and~~
9 ~~clerical~~ employees the director deems necessary.

10 Sec. 6. Section 41-4254, Arizona Revised Statutes, is amended to
11 read:

12 41-4254. Department duties

13 The department shall:

14 1. Formulate policies, plans and programs to enhance the ability of
15 this state to prevent and respond to acts of terrorism, **CYBERSECURITY**
16 **THREATS** and other critical hazards.

17 ~~2. Develop a statewide homeland security strategy.~~

18 **2. ADHERE TO ALL FEDERAL GRANT TERMS AND CONDITIONS.**

19 3. Request appropriations or grants of monies for homeland security
20 purposes.

21 ~~4. Provide to the senior advisory committee members a summary of~~
22 ~~the amount of federal homeland security monies requested by this state for~~
23 ~~each grant program.~~

24 ~~5.~~ **4.** Receive all awards granted to this state by the federal
25 government for homeland security purposes ~~and provide to the senior~~
26 ~~advisory committee members a list of the allocations of federal homeland~~
27 ~~security grants to this state along with the project title and the amount~~
28 ~~of each subgrantee award.~~

29 ~~6.~~ **5.** Distribute monies to local jurisdictions and other
30 organizations eligible under federal regulations based on criteria in the
31 ~~statewide homeland security strategy and~~ federal grant guidelines.

32 ~~7. Coordinate with other state and federal agencies to publish a~~
33 ~~guide for grantees that receive homeland security monies. The guide shall~~
34 ~~ensure that monies distributed by the department:~~

35 ~~(a) Are coordinated across all levels of government.~~

36 ~~(b) Avoid duplication of grant awards.~~

37 ~~(c) Eliminate security gaps in every level of government.~~

38 ~~8. Conduct preparedness training exercises to put state disaster~~

1 Sec. 7. Section 41-4255, Arizona Revised Statutes, is amended to
2 read:

3 41-4255. Annual report

4 A. On or before September 1 of each year, the ARIZONA department of
5 homeland security shall submit a homeland security allocation and
6 expenditure report to the governor, the president of the senate, the
7 speaker of the house of representatives, the chairperson of the senate
8 appropriations committee, the chairperson of the house appropriations
9 committee, ~~AND the staff and cochairpersons of the joint legislative~~
10 ~~budget committee and the members of the joint legislative committee on~~
11 ~~border and homeland security.~~

12 B. The director shall provide a copy of the report to the secretary
13 of state. The department may redact sensitive information contained in
14 the report if necessary.

15 C. The report shall include:

16 1. Each local and state project that was awarded funding for the
17 current year.

18 2. Expenditures for each local and state project that was awarded
19 funding for the current year.

20 3. Expenditures from federal appropriations and grants that were
21 used by the department for administrative and state agency purposes.

22 4. A narrative description detailing each state project awarded
23 funding, including the goals and objectives of each state project.

24 5. The progress made on each project since the last report.

25 6. Project awards and expenditures ~~from prior years beginning with~~
26 ~~fiscal year 2001-2002~~ FOR OPEN GRANT PROJECTS BY JUNE 30 OF EACH YEAR.

27 7. A detailed plan on how homeland security efforts will be
28 continued in the event of decreased federal funding.

35 advisory councils; appointment; terms; duties

36 A. The Arizona department of homeland security regional advisory
37 councils are established.

38 B. **THE DEPARTMENT SHALL ENSURE REASONABLE DISTRIBUTION OF AREA**
39 **REPRESENTATION.** A total of five councils are established as follows:

40 1. The north region is composed of the jurisdictions contained in
41 the Coconino, Navajo and Apache county boundaries. ~~No more than four~~
42 ~~members of the council may be from any one county.~~

43 2. The east region is composed of the jurisdictions contained in
44 the Graham, Greenlee, Gila and Pinal county boundaries. ~~No more than~~
45 ~~three members of the council may be from any one county.~~

1 3. The south region is composed of the jurisdictions contained in
2 the Pima, Santa Cruz, Cochise and Yuma county boundaries. ~~No more than~~
3 ~~three members of the council may be from any one county.~~

4 4. The west region is composed of the jurisdictions contained in
5 the Mohave, La Paz and Yavapai county boundaries. ~~No more than four~~
6 ~~members of the council may be from any one county.~~

7 5. The central region is composed of the jurisdictions contained in
8 the Maricopa county boundaries.

9 C. Each regional advisory council consists of ~~fourteen~~ TWELVE
10 members who serve for a term of three years. Members shall reside or work
11 in the region they represent, except for the representative from the
12 department of public safety. For the purposes of limiting the membership
13 in a county, the representative from the department of public safety and
14 the tribal representative do not count toward the membership limit from a
15 county.

16 D. The governor shall appoint each member of a regional advisory
17 council. The membership of the councils consists of:

18 1. A representative of a fire service from an urban or suburban
19 area in the region.

20 2. A representative of a fire service from a rural area in the
21 region.

22 3. A police chief.

23 4. A county sheriff or the sheriff's proxy.

24 5. A tribal representative.

25 6. An emergency manager.

26 ~~7. A mayor or the mayor's proxy.~~

31 E. A member must have a background in or experience with disaster

33 F. Subject to approval by the director, ~~only those members listed~~
34 ~~in subsection D, paragraphs 4, 7 and 8 may be represented on the council~~
35 ~~by a person designated by that member to serve as that member's proxy OR~~
36 ~~DEPUTY DIRECTOR, WITHIN A REASONABLE TIME FRAME BEFORE THE MEETING,~~
37 ~~MEMBERS MAY BE REPRESENTED ON THE COUNCIL BY A PERSON DESIGNATED BY THAT~~
38 ~~MEMBER TO SERVE AS THE MEMBER'S PROXY. The proxy must have a background~~
39 ~~in or experience with disaster response or law enforcement issues. ~~On or~~~~
40 ~~before July 1 of each year, the member shall submit a biographical sketch~~
41 ~~of the proxy's experience and qualifications for service on the council to~~
42 ~~the Arizona department of homeland security.~~

43 G. At the first meeting held after July 1 of each year, each
44 regional advisory council shall elect a chairperson and ~~vice-chairperson~~
45 VICE CHAIRPERSON.

1 H. Each regional advisory council shall meet on ~~the call of the~~
2 ~~chairperson but at least four times annually~~ AN AS NEEDED BASIS TO CONDUCT
3 BUSINESS. No actions may be taken without a quorum present.

4 I. It is the duty of each regional advisory council member to
5 maintain communication with and represent other offices and organizations
6 within the members' professional discipline in the region.

7 J. In coordination with the department, the regional advisory
8 council shall:

33 new appointment shall be made.

1 41-4282. Statewide information security and privacy office;
2 duties; suspension of budget unit's information

4 A. THE STATEWIDE INFORMATION SECURITY AND PRIVACY OFFICE IS
5 ESTABLISHED IN THE ARIZONA DEPARTMENT OF HOMELAND SECURITY. THE STATEWIDE
6 INFORMATION SECURITY AND PRIVACY OFFICE SHALL SERVE AS THE STRATEGIC
7 PLANNING, FACILITATION AND COORDINATION OFFICE FOR INFORMATION SECURITY IN
8 THIS STATE. INDIVIDUAL BUDGET UNITS SHALL CONTINUE TO MAINTAIN
9 OPERATIONAL RESPONSIBILITY FOR INFORMATION SECURITY.

10 B. THE DIRECTOR SHALL SERVE AS OR APPOINT THE STATEWIDE CHIEF
11 INFORMATION SECURITY OFFICER TO MANAGE THE STATEWIDE INFORMATION SECURITY
12 AND PRIVACY OFFICE. IF OTHER THAN THE DIRECTOR, THE STATEWIDE CHIEF

31 DETECTION, REPORTING AND RESPONSE EFFORTS FOR SECURITY INCIDENTS AND
32 BREACHES ACROSS THE STATE.

33 7. DEVELOP OTHER STRATEGIES AS NECESSARY TO PROTECT THIS STATE'S
34 INFORMATION TECHNOLOGY INFRASTRUCTURE AND THE DATA THAT IS STORED ON OR
35 TRANSMITTED BY THE INFRASTRUCTURE.

36 8. CONSULT WITH THE DEPARTMENT OF ADMINISTRATION FOR A FULL REVIEW
37 OF THE SECURITY ASPECTS FOR INFORMATION TECHNOLOGY PROJECTS PRESCRIBED IN
38 SECTION 18-104.

39 9. OPERATE THE INFORMATION SECURITY ASPECTS OF THE ENTERPRISE-LEVEL
40 INFRASTRUCTURE MANAGED BY THE DEPARTMENT OF ADMINISTRATION.

41 D. THE STATEWIDE INFORMATION SECURITY AND PRIVACY OFFICE MAY
42 TEMPORARILY SUSPEND OPERATION OF INFORMATION INFRASTRUCTURE THAT IS OWNED,
43 LEASED, OUTSOURCED OR SHARED TO ISOLATE THE SOURCE OF, OR STOP THE SPREAD
44 OF, AN INFORMATION SECURITY SYSTEM BREACH OR OTHER SIMILAR INCIDENT. A
45 BUDGET UNIT AND THE DEPARTMENT OF ADMINISTRATION, AS APPLICABLE, SHALL

1 COMPLY WITH DIRECTIVES TO TEMPORARILY DISCONTINUE OR SUSPEND OPERATIONS OF
2 INFORMATION INFRASTRUCTURE.

3 E. EACH BUDGET UNIT AND ITS CONTRACTORS SHALL IDENTIFY AND REPORT
4 SECURITY INCIDENTS TO THE STATEWIDE INFORMATION SECURITY AND PRIVACY
5 OFFICE IMMEDIATELY ON DISCOVERY AND DEPLOY MITIGATION STRATEGIES AS
6 DIRECTED.

7 F. THE ARIZONA DEPARTMENT OF HOMELAND SECURITY MAY EXAMINE ALL
8 BOOKS, PAPERS, RECORDS AND DOCUMENTS IN THE OFFICE OF ANY BUDGET UNIT AND
9 MAY REQUIRE ANY STATE OFFICER OF THE BUDGET UNIT TO PROVIDE THE
10 INFORMATION OR STATEMENTS NECESSARY TO CARRY OUT THIS SECTION.

11 G. BUDGET UNITS SHALL DEMONSTRATE EXPERTISE TO CARRY OUT SECURITY
12 ASSURANCE PLANS, EITHER BY EMPLOYING STAFF OR CONTRACTING FOR OUTSIDE
13 SERVICES.

14 H. A BUDGET UNIT MAY ENTER INTO AN AGREEMENT WITH THE DEPARTMENT OF
15 ADMINISTRATION OR THE ARIZONA DEPARTMENT OF HOMELAND SECURITY TO MEET THE
16 REQUIREMENTS OF THIS SECTION.

17 Sec. 11. Retention of members

18 Notwithstanding section 41-4258, Arizona Revised Statutes, as
19 amended by this act, all persons serving as members of the Arizona
20 department of homeland security regional advisory councils on the
21 effective date of this act may continue to serve until the expiration of
22 their normal terms.
