AN ACT

REPEALING SECTION 41-3022.18, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3025.07; RELATING TO THE SCHOOL FACILITIES OVERSIGHT BOARD.

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Repeal  
3 Section 41-3022.18, Arizona Revised Statutes, is repealed.  
4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes,  
5 is amended by adding section 41-3025.07, to read:  
6 41-3025.07. School facilities oversight board; termination  
7 July 1, 2025  
8 A. THE SCHOOL FACILITIES OVERSIGHT BOARD TERMINATES ON JULY 1,  
9 2025.  
10 B. TITLE 41, CHAPTER 56, ARTICLES 1, 2, 3, 4, 5, 6, 7, 8 AND 9 AND  
11 THIS SECTION ARE REPEALED ON JANUARY 1, 2026 ONLY IF EITHER:  
12 1. THE BOARD HAS NO OUTSTANDING STATE SCHOOL FACILITIES REVENUE  
13 BONDS ISSUED PURSUANT TO TITLE 41, CHAPTER 56, ARTICLE 6, NO OUTSTANDING  
14 STATE SCHOOL IMPROVEMENT REVENUE BONDS ISSUED PURSUANT TO TITLE 41,  
15 CHAPTER 56, ARTICLE 7 AND NO OUTSTANDING LEASE-TO-OWN TRANSACTIONS  
16 PURSUANT TO SECTIONS 41-5703, 41-5704 AND 41-5705.  
17 2. THE LEGISLATURE HAS OTHERWISE PROVIDED FOR PAYING OR RETIRING  
18 ANY OUTSTANDING STATE SCHOOL FACILITIES REVENUE BONDS, ANY OUTSTANDING  
19 STATE SCHOOL IMPROVEMENT REVENUE BONDS AND ANY OUTSTANDING LEASE-TO-OWN  
20 TRANSACTIONS.  
21 C. IF NEITHER OF THE CONDITIONS IN SUBSECTION B OF THIS SECTION HAS  
22 OCCURRED ON OR BEFORE JANUARY 1, 2026, TITLE 41, CHAPTER 56, ARTICLES 1,  
23 2, 3, 4, 5, 6, 7, 8 AND 9 AND THIS SECTION ARE REPEALED THIRTY DAYS AFTER  
24 THE RETIREMENT OF ALL REVENUE BONDS ISSUED PURSUANT TO TITLE 41, CHAPTER  
25 56, ARTICLES 6 AND 7 AND ANY OUTSTANDING LEASE-TO-OWN TRANSACTIONS ISSUED  
26 PURSUANT TO SECTIONS 41-5703, 41-5704 AND 41-5705.  
27 Sec. 3. Purpose  
28 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
29 the legislature continues the school facilities oversight board to  
30 evaluate the capital needs of school districts and to distribute monies to  
31 school districts to cure existing deficiencies and to provide for building  
32 renewal and the construction of new facilities.  
33 Sec. 4. Retroactivity  
34 Sections 1 and 2 of this act are effective retroactively to July 1,  
35 2022.
