HOUSE BILL 2694

AN ACT

AMENDING SECTIONS 32-2101, 32-2124, 32-2132, 32-2135 AND 32-2163, ARIZONA
REVISED STATUTES; RELATING TO THE STATE REAL ESTATE DEPARTMENT.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 32-2101, Arizona Revised Statutes, is amended to
3 read:

4 32-2101. Definitions

5 In this chapter, unless the context otherwise requires:

6 1. "Acting in concert" means evidence of collaborating to pursue a
7 concerted plan.

8 2. "Advertising" means the attempt by publication, dissemination,
9 exhibition, solicitation or circulation, oral or written, or for broadcast
10 on radio or television to induce directly or indirectly any person to
11 enter into any obligation or acquire any title or interest in lands
12 subject to this chapter, including the land sales contract to be used and
13 any photographs, drawings or artist's presentations of physical conditions
14 or facilities existing or to exist on the property. Advertising does not
15 include:

16 (a) Press releases or other communications delivered to newspapers,
17 periodicals or other news media for general information or public
18 relations purposes if no charge is made by the newspapers, periodicals or
19 other news media for the publication or use of any part of these
20 communications.

21 (b) Communications to stockholders as follows:

22 (i) Annual reports and interim financial reports.

23 (ii) Proxy materials.

24 (iii) Registration statements.

25 (iv) Securities prospectuses.

26 (v) Applications for listing of securities on stock exchanges.

27 (vi) Prospectuses.

28 (vii) Property reports.

29 (viii) Offering statements.

30 3. "Affiliate" means a person who, directly or indirectly through
31 one or more intermediaries, controls, is controlled by or is under common
32 control with the person specified.

33 4. "Associate broker" means a licensed broker who is employed by
34 another broker. Unless otherwise specifically provided, an associate
35 broker has the same license privileges as a salesperson.

36 5. "Barrier" means a natural or man-made geographical feature that
37 prevents parcels of land from being practicably, reasonably and
38 economically united or reunited and that was not caused or created by the
39 owner of the parcels.

40 6. "Blanket encumbrance" means any mortgage, any deed of trust or
41 any other encumbrance or lien securing or evidencing the payment of money
42 and affecting more than one lot or parcel of subdivided land, or an
43 agreement affecting more than one lot or parcel by which the subdivider
44 holds the subdivision under an option, contract to sell or trust

1 agreement. Blanket encumbrance does not include taxes and assessments
2 that are levied by public authority.

3 7. "Board" means the state real estate advisory board.

4 8. "Broker", when used without modification, means a person who is
5 licensed as a broker under this chapter or who is required to be licensed
6 as a broker under this chapter.

7 9. "Business broker" means a real estate broker who acts as an
8 intermediary or agent between sellers or buyers, or both, in the sale or
9 purchase, or both, of businesses or business opportunities where a lease
10 or sale of real property is either a direct or incidental part of the
11 transaction.

12 10. "Camping site" means a space that is designed and promoted for
13 the purpose of locating any trailer, tent, tent trailer, pickup camper or
14 other similar device used for camping.

15 11. "Cemetery" or "cemetery property" means any one, or a
16 combination of more than one, of the following in a place that is used, or
17 intended to be used, and dedicated for cemetery purposes:

18 (a) A burial park, for earth interments.

19 (b) A mausoleum, for crypt or vault entombments.

20 (c) A crematory, or a crematory and columbarium, for cinerary
21 interments.

22 (d) A cemetery plot, including interment rights, mausoleum crypts,
23 niches and burial spaces.

24 12. "Cemetery broker" means a person other than a real estate
25 broker or real estate salesperson who, for another, for compensation:

26 (a) Sells, leases or exchanges cemetery property or interment
27 services of or for another, or on the person's own account.

28 (b) Offers for another or for the person's own account to buy,
29 sell, lease or exchange cemetery property or interment services.

30 (c) Negotiates the purchase and sale, lease or exchange of cemetery
31 property or interment services.

32 (d) Negotiates the purchase or sale, lease or exchange, or lists or
33 solicits, or negotiates a loan on or leasing of cemetery property or
34 interment services.

35 13. "Cemetery salesperson" means a natural person who acts on the
36 person's own behalf or through and on behalf of a professional limited
37 liability company or a professional corporation engaged by or on behalf of
38 a licensed cemetery or real estate broker, or through and on behalf of a
39 corporation, partnership or limited liability company that is licensed as
40 a cemetery or real estate broker, to perform any act or transaction
41 included in the definition of cemetery broker.

42 14. "Commissioner" means the state real estate commissioner.

43 15. "Common promotional plan" means a plan, undertaken by a person
44 or a group of persons acting in concert, to offer lots for sale or lease.
45 If the land is offered for sale by a person or group of persons acting in

1 concert, and the land is contiguous or is known, designated or advertised
2 as a common unit or by a common name, the land is presumed, without regard
3 to the number of lots covered by each individual offering, as being
4 offered for sale or lease as part of a common promotional plan. Separate
5 subdividers selling lots or parcels in separately platted subdivisions
6 within a master planned community shall not be deemed to be offering their
7 combined lots for sale or lease as part of a common promotional plan.

8 16. "Compensation" means any fee, commission, salary, money or
9 other valuable consideration for services rendered or to be rendered as
10 well as the promise of consideration whether contingent or not.

11 17. "Contiguous" means lots, parcels or fractional interests that
12 share a common boundary or point. Lots, parcels or fractional interests
13 are not contiguous if they are separated by either of the following:

14 (a) A barrier.

15 (b) A road, street or highway that has been established by this
16 state or by any agency or political subdivision of this state, that has
17 been designated by the federal government as an interstate highway or that
18 has been regularly maintained by this state or by any agency or political
19 subdivision of this state and has been used continuously by the public for
20 at least the last five years.

21 18. "Control" or "controlled" means a person who, through
22 ownership, voting rights, power of attorney, proxy, management rights,
23 operational rights or other rights, has the right to make decisions
24 binding on an entity, whether a corporation, a partnership or any other
25 entity.

26 19. "Corporation licensee" means a lawfully organized corporation
27 that is registered with the Arizona corporation commission and that has an
28 officer licensed as the designated broker pursuant to section 32-2125.

29 20. "Department" means the state real estate department.

30 21. "Designated broker" means the natural person who is licensed as
31 a broker under this chapter and who is either:

32 (a) Designated to act on behalf of an employing real estate,
33 cemetery or membership camping entity.

34 (b) Doing business as a sole proprietor.

35 22. "Developer" means a person who offers real property in a
36 development for sale, lease or use, either immediately or in the future,
37 on the person's own behalf or on behalf of another person, under this
38 chapter. Developer does not include a person whose involvement with a
39 development is limited to the listing of property within the development
40 for sale, lease or use.

41 23. "Development" means any division, proposed division or use of
42 real property that the department has authority to regulate, including
43 subdivided and unsubdivided lands, cemeteries, condominiums, timeshares,
44 membership campgrounds and stock cooperatives.

1 24. "Employing broker" means a person who is licensed or is
2 required to be licensed as a:

3 (a) Broker entity pursuant to section 32-2125, subsection A.

4 (b) Sole proprietorship if the sole proprietor is a broker licensed
5 pursuant to this chapter.

6 25. "Fractional interest" means an undivided interest in improved
7 or unimproved land, lots or parcels of any size created for the purpose of
8 sale or lease and evidenced by any receipt, certificate, deed or other
9 document conveying the interest. Undivided interests in land, lots or
10 parcels created in the names of a husband and wife as community property,
11 joint tenants or tenants in common, or in the names of other persons who,
12 acting together as part of a single transaction, acquire the interests
13 without a purpose to divide the interests for present or future sale or
14 lease shall be deemed to constitute only one fractional interest.

15 26. "Improved lot or parcel" means a lot or parcel of a subdivision
16 on which there is a residential, commercial or industrial building or
17 concerning which a contract has been entered into between a subdivider and
18 a purchaser that obligates the subdivider directly, or indirectly through
19 a building contractor, to completely construct a residential, commercial
20 or industrial building on the lot or parcel within two years after the
21 date on which the contract of sale for the lot is entered into.

22 27. "Inactive license" means a license that is issued pursuant to
23 article 2 of this chapter to a licensee who is on inactive status during
24 the current license period and who is not engaged by or on behalf of a
25 broker.

26 28. "Lease" or "leasing" includes any lease, whether it is the
27 sole, the principal or any incidental part of a transaction.

28 29. "License" means the whole or part of any agency permit,
29 certificate, approval, registration, public report, charter or similar
30 form of permission required by this chapter.

31 30. "Licensee" means a person to whom a license for the current
32 license period has been granted under any provision of this chapter, and,
33 for the purposes of section 32-2153, subsection A, includes original
34 license applicants.

35 31. "License period" means the two-year period beginning with the
36 date of original issue or renewal of a particular license and ending on
37 the expiration date, if any.

38 32. "Limited liability company licensee" means a lawfully organized
39 limited liability company that has a member or manager who is a natural
40 person and who is licensed as the designated broker pursuant to section
41 32-2125.

42 33. "LIVE CLASSROOM COURSE" MEANS A COURSE OR INSTRUCTIONAL SEGMENT
43 DELIVERED IN EITHER AN IN-PERSON CLASSROOM INSTRUCTIONAL FORMAT OR A
44 SYNCHRONOUS REMOTE INSTRUCTIONAL FORMAT THAT ALLOWS STUDENTS TO OBSERVE
45 AND PARTICIPATE REMOTELY IN AN INSTRUCTIONAL SEGMENT VIA LIVESTREAMING.

1 ~~33.~~ 34. "Lot reservation" means an expression of interest by a
2 prospective purchaser in buying at some time in the future a subdivided or
3 unsubdivided lot, unit or parcel in this state. In all cases, a
4 subsequent affirmative action by the prospective purchaser must be taken
5 to create a contractual obligation to purchase.

6 ~~34.~~ 35. "Master planned community" means a development that
7 consists of two or more separately platted subdivisions and that is either
8 subject to a master declaration of covenants, conditions or restrictions,
9 is subject to restrictive covenants sufficiently uniform in character to
10 clearly indicate a general scheme for improving or developing real
11 property or is governed or administered by a master owner's association.

12 ~~35.~~ 36. "Member" means a member of the real estate advisory board.

13 ~~36.~~ 37. "Membership camping broker" means a person, other than a
14 salesperson, who, for compensation:

15 (a) Sells, purchases, lists, exchanges or leases membership camping
16 contracts.

17 (b) Offers to sell, purchase, exchange or lease membership camping
18 contracts.

19 (c) Negotiates or offers, attempts or agrees to negotiate the sale,
20 purchase, exchange or lease of membership camping contracts.

21 (d) Advertises or holds himself out as being engaged in the
22 business of selling, buying, exchanging or leasing membership camping
23 contracts or counseling or advising regarding membership camping
24 contracts.

25 (e) Assists or directs in procuring prospects calculated or
26 intended to result in the sale, purchase, listing, exchange or lease of
27 membership camping contracts.

28 (f) Performs any of the foregoing acts as an employee or on behalf
29 of a membership camping operator or membership contract owner.

30 ~~37.~~ 38. "Membership camping contract" means an agreement that is
31 offered or sold in this state evidencing a purchaser's right or license to
32 use the camping or outdoor recreation facilities of a membership camping
33 operator and includes a membership that provides for this use.

34 ~~38.~~ 39. "Membership camping operator" means an enterprise, other
35 than one that is tax exempt under section 501(c)(3) of the internal
36 revenue code of 1986, as amended, that solicits membership paid for by a
37 fee or periodic payments and has as one of its purposes camping or outdoor
38 recreation, including the use of camping sites primarily by members.
39 Membership camping operator does not include camping or recreational
40 trailer parks that are open to the general public and that contain camping
41 sites rented for a per use fee or a mobile home park.

42 ~~39.~~ 40. "Membership camping salesperson" means a natural person
43 who acts on the person's own behalf or through and on behalf of a
44 professional limited liability company or a professional corporation
45 engaged by or on behalf of a licensed membership camping or real estate

1 broker, or by or on behalf of a corporation, partnership or limited
2 liability company that is licensed as a membership camping or real estate
3 broker, to perform any act or participate in any transaction in a manner
4 included in the definition of membership camping broker.

5 ~~40.~~ 41. "Online course" means prelicensure education that is a
6 planned learning experience with a geographic separation that may be
7 synchronous or asynchronous, that does not require real-time interaction
8 between a student and an instructor and that uses a platform with
9 self-paced or prerecorded lessons and materials that a student can access
10 via the internet to proceed at the student's own pace.

11 ~~41.~~ 42. "Partnership licensee" means a partnership with a managing
12 general partner who is licensed as the designated broker pursuant to
13 section 32-2125.

14 ~~42.~~ 43. "Permanent access", as required under article 4 of this
15 chapter, means permanent access from the subdivision to any federal, state
16 or county highway.

17 ~~43.~~ 44. "Perpetual care" or "endowed care" means maintaining and
18 caring, in all places where interments have been made, for the trees,
19 shrubs, roads, streets and other improvements and embellishments contained
20 within or forming a part of the cemetery but does not include maintaining
21 or repairing monuments, tombs, copings or other man-made ornaments as
22 associated with individual burial spaces.

23 ~~44.~~ 45. "Perpetual or endowed-care cemetery" means a cemetery in
24 which lots or other burial spaces are sold or transferred under the
25 representation that the cemetery will receive perpetual care or endowed
26 care free of further cost to the purchaser after payment of the original
27 purchase price for the lot, burial space or interment right.

28 ~~45.~~ 46. "Person" means any individual, corporation, partnership or
29 company and any other form of multiple organization for carrying on
30 business, foreign or domestic.

31 ~~46.~~ 47. "Private cemetery" means a cemetery or place that is not
32 licensed under article 6 of this chapter, where burials or interments of
33 human remains are made, in which sales or transfers of interment rights or
34 burial plots are not made to the public and in which not more than ten
35 interments or burials occur annually.

36 ~~47.~~ 48. "Promotion" or "promotional practice" means advertising
37 and any other act, practice, device or scheme to induce directly or
38 indirectly any person to enter into any obligation or acquire any title or
39 interest in or use of real property subject to this chapter, including
40 meetings with prospective purchasers, arrangements for prospective
41 purchasers to visit real property, travel allowances and discount,
42 exchange, refund and cancellation privileges.

43 ~~48.~~ 49. "Real estate" includes leasehold-interests and any estates
44 in land as defined in title 33, chapter 2, articles 1 and 2, regardless of
45 whether located in this state.

1 ~~49.~~ 50. "Real estate broker" means a person, other than a
2 salesperson, who, for another and for compensation:
3 (a) Sells, exchanges, purchases, rents or leases real estate,
4 businesses and business opportunities or timeshare interests.
5 (b) Offers to sell, exchange, purchase, rent or lease real estate,
6 businesses and business opportunities or timeshare interests.
7 (c) Negotiates or offers, attempts or agrees to negotiate the sale,
8 exchange, purchase, rental or leasing of real estate, businesses and
9 business opportunities or timeshare interests.
10 (d) Lists or offers, attempts or agrees to list real estate,
11 businesses and business opportunities or timeshare interests for sale,
12 lease or exchange.
13 (e) Auctions or offers, attempts or agrees to auction real estate,
14 businesses and business opportunities or timeshare interests.
15 (f) Buys, sells, offers to buy or sell or otherwise deals in
16 options on real estate, businesses and business opportunities or timeshare
17 interests or improvements to real estate, businesses and business
18 opportunities or timeshare interests.
19 (g) Collects or offers, attempts or agrees to collect rent for the
20 use of real estate, businesses and business opportunities or timeshare
21 interests. This subdivision does not apply to a person who is not a
22 licensee, who works for a real estate broker or a real estate salesperson,
23 who collects in-person rent and related fees on behalf of the real estate
24 broker or real estate salesperson for the use of real estate as part of
25 the person's clerical duties and who provides a receipt when rent is paid.
26 (h) Advertises or holds himself out as being engaged in the
27 business of buying, selling, exchanging, renting or leasing real estate,
28 businesses and business opportunities or timeshare interests or counseling
29 or advising regarding real estate, businesses and business opportunities
30 or timeshare interests.
31 (i) Assists or directs in procuring prospects that are calculated
32 to result in the sale, exchange, leasing or rental of real estate,
33 businesses and business opportunities or timeshare interests.
34 (j) Assists or directs in negotiating any transaction calculated or
35 intended to result in the sale, exchange, leasing or rental of real
36 estate, businesses and business opportunities or timeshare interests.
37 (k) Incident to the sale of real estate, businesses and business
38 opportunities negotiates or offers, attempts or agrees to negotiate a loan
39 secured or to be secured by any mortgage or other encumbrance on or
40 transfer of real estate, businesses and business opportunities or
41 timeshare interests subject to section 32-2155, subsection C. This
42 subdivision does not apply to mortgage brokers as defined in and subject
43 to title 6, chapter 9, article 1.

1 (l) Engages in the business of assisting or offering to assist
2 another in filing an application for the purchase or lease of, or in
3 locating or entering on, lands owned by the state or federal government.

4 (m) Claims, demands, charges, receives, collects or contracts to
5 collect an advance fee in connection with any employment enumerated in
6 this section, including employment undertaken to promote the sale or lease
7 of real property by advance fee listing, by furnishing rental information
8 to a prospective tenant for a fee paid by the prospective tenant, by
9 advertisement or by any other offering to sell, lease, exchange or rent
10 real property or selling kits connected therewith. This shall not include
11 the activities of any communications media of general circulation or
12 coverage not primarily engaged in the advertisement of real estate or any
13 communications media activities that are specifically exempt from
14 applicability of this article under section 32-2121.

15 (n) Engages in any of the acts listed in subdivisions (a) through
16 (m) of this paragraph for the sale or lease of other than real property if
17 a real property sale or lease is a part of, contingent on or ancillary to
18 the transaction.

19 (o) Performs any of the acts listed in subdivisions (a) through (m)
20 of this paragraph as an employee of, or in behalf of, the owner of real
21 estate, or interest in the real estate, or improvements affixed on the
22 real estate, for compensation.

23 (p) Acts as a business broker.

24 ~~50.~~ 51. "Real estate sales contract" means an agreement in which
25 one party agrees to convey title to real estate to another party on the
26 satisfaction of specified conditions set forth in the contract.

27 ~~51.~~ 52. "Real estate salesperson" means a natural person who acts
28 on the person's own behalf or through and on behalf of a professional
29 limited liability company or a professional corporation engaged by or on
30 behalf of a licensed real estate broker, or by or on behalf of a limited
31 liability company, partnership or corporation that is licensed as a real
32 estate broker, to perform any act or participate in any transaction in a
33 manner included in the definition of real estate broker subject to section
34 32-2155.

35 ~~52.~~ 53. "Sale" or "lease" includes every disposition, transfer,
36 option or offer or attempt to dispose of or transfer real property, or an
37 interest, use or estate in the real property, including offering the
38 property as a prize or gift if a monetary charge or consideration for
39 whatever purpose is required.

40 ~~53.~~ 54. "Salesperson", when used without modification, means a
41 natural person who acts on the person's own behalf or through and on
42 behalf of a professional limited liability company or a professional
43 corporation licensed under this chapter or any person required to be
44 licensed as a salesperson under this chapter.

1 ~~54.~~ 55. "School" means a person or entity that offers a course of
2 study towards completion of the education requirements leading to
3 licensure or renewal of licensure under this chapter.

4 ~~55.~~ 56. "Stock cooperative" means a corporation to which all of
5 the following apply:

6 (a) The corporation is formed or used to hold title to improved
7 real property in fee simple or for a term of years.

8 (b) All or substantially all of the shareholders of the corporation
9 each receive a right of exclusive occupancy in a portion of the real
10 property to which the corporation holds title.

11 (c) The right of occupancy may only be transferred with the
12 concurrent transfer of the shares of stock in the corporation held by the
13 person having the right of occupancy.

14 ~~56.~~ 57. "Subdivider" means any person who offers for sale or lease
15 six or more lots, parcels or fractional interests in a subdivision or who
16 causes land to be subdivided into a subdivision for the subdivider or for
17 others, or who undertakes to develop a subdivision, but does not include a
18 public agency or officer authorized by law to create subdivisions.

19 ~~57.~~ 58. "Subdivision" or "subdivided lands":

20 (a) Means improved or unimproved land or lands divided or proposed
21 to be divided for the purpose of sale or lease, whether immediate or
22 future, into six or more lots, parcels or fractional interests.

23 (b) Includes a stock cooperative, lands divided or proposed to be
24 divided as part of a common promotional plan and residential condominiums
25 as defined in title 33, chapter 9.

26 (c) Does not include:

27 (i) Leasehold offerings of one year or less.

28 (ii) The division or proposed division of land located in this
29 state into lots or parcels each of which is or will be thirty-six acres or
30 more in area including to the centerline of dedicated roads or easements,
31 if any, contiguous to the lot or parcel.

32 (iii) The leasing of agricultural lands or apartments, offices,
33 stores, hotels, motels, pads or similar space within an apartment
34 building, industrial building, rental recreational vehicle community,
35 rental manufactured home community, rental mobile home park or commercial
36 building.

37 (iv) The subdivision into or development of parcels, plots or
38 fractional portions within the boundaries of a cemetery that has been
39 formed and approved pursuant to this chapter.

40 (v) A sale or lease of a lot, parcel or fractional interest that
41 occurs ten or more years after the sale or lease of another lot, parcel or
42 fractional interest if the other lot, parcel or fractional interest is not
43 subject to this article and is treated as an independent parcel unless, on
44 investigation by the commissioner, there is evidence of intent to
45 subdivide.

1 ~~58.~~ 59. "Timeshare" or "timeshare property" means real property
2 ownership or right of occupancy in real property pursuant to article 9 of
3 this chapter. For the purposes of this chapter, a timeshare is not a
4 security unless it meets the definition of a security under section
5 44-1801.

6 ~~59.~~ 60. "Trustee" means:

7 (a) A person who is designated under section 32-2194.27 to act as a
8 trustee for an endowment-care cemetery fund.

9 (b) A person holding bare legal title to real property under a
10 subdivision trust. A trustee shall not be deemed to be a developer,
11 subdivider, broker or salesperson within this chapter.

12 ~~60.~~ 61. "Unimproved lot or parcel" means a lot or parcel of a
13 subdivision that is not an improved lot or parcel.

14 ~~61.~~ 62. "Unsubdivided lands":

15 (a) Means land or lands divided or proposed to be divided for the
16 purpose of sale or lease, whether immediate or future, into six or more
17 lots, parcels or fractional interests and the lots or parcels are
18 thirty-six acres or more each but less than one hundred sixty acres each,
19 or that are offered, known or advertised under a common promotional plan
20 for sale or lease, except that agricultural leases shall not be included
21 in this definition.

22 (b) Includes any land that is sold and that would otherwise
23 constitute the sixth lot, parcel or fractional interest if the sale occurs
24 ten or more years after the earliest of the previous five sales and if all
25 of the sales consist of property that was originally contained within the
26 same parcel that is thirty-six acres or more and less than one hundred
27 sixty acres.

28 Sec. 2. Section 32-2124, Arizona Revised Statutes, is amended to
29 read:

30 32-2124. Qualifications of licensees

31 A. Except as otherwise provided in this chapter, the commissioner
32 shall require proof, through the application or otherwise, as the
33 commissioner deems advisable with due regard to the interests of the
34 public, as to the honesty, truthfulness, good character and competency of
35 the applicant and shall require that the applicant has:

36 1. If for an original real estate broker's license, at least three
37 years' actual experience as a licensed real estate salesperson or real
38 estate broker during the five years immediately preceding the time of
39 application.

40 2. If for an original cemetery broker's license, either a current
41 real estate broker's license, or if the applicant does not have a current
42 real estate broker's license, at least three years' actual experience as a
43 cemetery salesperson or broker or as a licensed real estate salesperson or
44 broker during the five years immediately preceding the time of
45 application.

1 3. If for an original membership camping broker's license, either a
2 current real estate broker's license, or if the applicant does not have a
3 current real estate broker's license, at least three years' actual
4 experience as a licensed membership camping salesperson or broker or as a
5 licensed real estate salesperson or broker during the five years
6 immediately preceding the time of application.

7 4. If for any type of broker's or salesperson's license, not had a
8 license denied within one year immediately preceding application in this
9 state pursuant to section 32-2153 or a similar statute in any other state.

10 5. If for any type of broker's or salesperson's license, not had a
11 license revoked within the two years immediately preceding application in
12 this state pursuant to section 32-2153 or a similar statute in any other
13 state.

14 6. If reapplying for a license that expired more than one year

8 2. A general understanding of:

9 (a) Cemetery associations, cemetery corporations and duties of
10 cemetery directors and officers.

11 (b) Plot ownership, deeds, certificates of ownership, contracts of
12 sale, liens and leases.

13 (c) Establishing, dedicating, maintaining, managing, operating,
14 improving, preserving and conducting a cemetery.

15 (d) The provisions of this chapter and rules adopted pursuant to
16 this chapter relating to the organization and regulation of cemeteries and

19 3. A general understanding of the obligations between principal and

24 other examination method that an applicant for a license as a membership
25 camping broker or a membership camping salesperson has:

26 1. An appropriate knowledge of the English language, including
27 reading, writing and spelling, and of elementary arithmetic.

28 2. A general understanding of:

29 (a) The general purposes and legal effect of contracts and agency
30 contracts.

31 (b) Establishing, maintaining, managing and operating a membership
32 campground.

33 (c) The provisions of this chapter and rules adopted pursuant to
34 this chapter relating to the organization and regulation of membership
35 campgrounds and the licensing and regulation of membership camping brokers

28 the acts within the scope of this chapter if the person is not also a
29 licensed broker in this state, or a salesperson licensed under the broker
30 employing or compensating the salesperson, except that a licensed broker
31 in this state may pay compensation to and receive compensation from a
32 broker who is lawfully operating in another state.

33 B. Notwithstanding that pursuant to subsection A of this section a
34 licensed broker in this state may pay to and receive compensation from an
35 out-of-state broker, this authority does not allow an out-of-state broker
36 to conduct activity in this state that would otherwise require a broker's
37 license issued by the department.

38 C. A licensed broker in this state may cooperate with an
39 out-of-state broker who would otherwise require licensure in this state
40 if:

41 1. The licensed broker and the out-of-state broker enter into a
42 written cooperation agreement before the out-of-state broker conducts any
43 activity otherwise requiring a broker's license pursuant to this
44 chapter. The cooperation agreement shall include the following:

- 1 (a) A list of the real estate activities to be conducted by the
2 out-of-state broker.
- 3 (b) A statement that the out-of-state broker agrees to fully comply
4 with the laws of this state and submit to the regulatory jurisdiction of
5 the department for activities subject to real estate broker licensure
6 pursuant to this chapter.
- 7 (c) A statement that the licensed broker in this state understands
8 and accepts responsibility for the acts of the out-of-state broker.
- 9 2. All negotiations in this state or with people who own property
10 in this state are conducted through the licensed broker in this state.
- 11 3. The licensed broker in this state assumes all responsibility for
12 the acts of the out-of-state broker.
- 13 4. All principal funds handled by either the licensed broker in
14 this state or the out-of-state broker are subject to the deposit and
15 handling requirements of section 32-2151.
- 16 D. The offering of real estate brokerage services specified by
17 section 32-2101, paragraph ~~49~~ 50 for compensation or any other thing of
18 value pertaining to real property located in this state through an
19 internet website constitutes activity that requires a broker's license
20 issued by the department.
- 21 E. This section does not allow an out-of-state broker who is not
22 licensed in this state to list, market or advertise in this state real
23 property located in this state for sale, lease or exchange.
- 24 F. Signs shall not be placed on real property in this state by an
25 out-of-state broker. An out-of-state broker shall not use a cooperation
26 agreement as authority to sell, lease, rent, exchange or attempt to sell,
27 lease, rent or exchange real property to a resident of this state.
