**CHAPTER 345**  
**SENATE BILL 1178**

AN ACT

AMENDING SECTION 41-1304.05, ARIZONA REVISED STATUTES; RELATING TO STATE GOVERNMENT.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 41-1304.05, Arizona Revised Statutes, is amended  
3 to read:

4 41-1304.05. Architect of the capitol; state capitol building  
5 areas and other facilities; jurisdiction;  
6 maintenance; definition

7 A. THE OFFICE OF THE ARCHITECT OF THE CAPITOL IS ESTABLISHED IN THE  
8 ARIZONA LEGISLATIVE COUNCIL. THE DIRECTOR OF THE ARIZONA LEGISLATIVE  
9 COUNCIL SHALL SELECT AN ARCHITECT OF THE CAPITOL AND OTHER PERSONNEL  
10 NECESSARY TO DEVELOP AND MAINTAIN A MASTER PLAN FOR THE STATE CAPITOL  
11 COMPLEX. THE ARCHITECT OF THE CAPITOL APPOINTED BY THE DIRECTOR OF THE  
12 ARIZONA LEGISLATIVE COUNCIL MUST HAVE MASTER PLANNING EXPERIENCE AND  
13 EXPERIENCE WORKING WITH THE STATE HISTORIC PRESERVATION OFFICE AND  
14 HISTORIC GOVERNMENT BUILDINGS. THE ARCHITECT OF THE CAPITOL SHALL SUBMIT  
15 THE MASTER PLAN TO THE MEMBERS OF THE ARIZONA LEGISLATIVE COUNCIL FOR  
16 APPROVAL AT LEAST ONCE DURING EACH REGULAR SESSION OF THE LEGISLATURE.

17 ~~A.~~ B. The ARIZONA legislative council is responsible for the  
18 allocation of space, operation, alteration, renovation and control of the  
19 following:

20 1. The original 1898 statehouse area of the state capitol building  
21 known as the state capitol museum.

22 2. The 1919 wing and the 1938 justice addition of the state capitol  
23 building known jointly as the legislative services wing.

24 3. Any other facility acquired for legislative use and placed under  
25 legislative council jurisdiction and the grounds adjacent to it.

26 4. Except as provided in subsections ~~B~~ and C AND D of this section,  
27 the grounds adjacent to the state capitol museum, the legislative services  
28 wing, the house of representatives wing and the senate wing and comprising  
29 the area east of the state capitol executive tower with a northern  
30 boundary of west Adams street, an eastern boundary of Seventeenth avenue  
31 and a southern boundary of west Jefferson street in Phoenix, Arizona.

32 ~~B.~~ C. The speaker of the ~~state~~ house of representatives is  
33 responsible for the following:

34 1. The allocation of space, operation, alteration, renovation and  
35 control of the house of representatives wing of the state capitol  
36 building.

37 2. The allocation of space and control of the parking lot area  
38 adjacent to the house of representatives wing, the parking lot area with a  
39 southern boundary of west Adams street, an eastern boundary of Seventeenth  
40 avenue and a northern boundary of west Monroe street in Phoenix, Arizona  
41 and comprised of one hundred five parking spaces and the southeast portion  
42 of the parking lot area with a southern boundary of west Monroe street and  
43 an eastern boundary of Seventeenth avenue in Phoenix, Arizona and  
44 comprised of fifty parking spaces.

- 1           ~~E.~~ D. The president of the ~~state~~ senate is responsible for the  
2 following:
- 3           1. The allocation of space, operation, alteration, renovation and  
4 control of the senate wing of the state capitol building.
- 5           2. The allocation of space and control of the parking lot area  
6 adjacent to the senate wing and the southwest portion of the parking lot  
7 area of the Wesley Bolin memorial plaza east of the state capitol building  
8 and comprised of one hundred twenty parking spaces.
- 9           ~~D.~~ E. The joint legislative budget committee is responsible for  
10 the allocation of space, operation, alteration, renovation and control of  
11 the building located at 1716 ~~W.~~ WEST Adams ~~STREET~~ in Phoenix.
- 12           ~~E.~~ F. The director of the department of administration is  
13 responsible for the maintenance of the entire state capitol building.
- 14           ~~F.~~ G. For the purposes of this section, "control" includes  
15 security services.
