SENATE AMENDMENTS TO S.B. 1079  
(Reference to printed bill)

- 1 Page 1, line 8, after "CONTINUED" strike remainder of line
- 2 Strike lines 9 through 29, insert "UNLESS IT IS NECESSARY FOR THE FULL, FAIR  
3 AND PROPER PRESENTATION OF EVIDENCE. A CONTINUANCE OF A PROCEDURAL TIME  
4 LIMIT MAY NOT BE GRANTED IF THE DELAY IS NOT IN THE BEST INTEREST OF THE  
5 CHILD.
- 6 C. A CONTINUANCE BEYOND THIRTY DAYS SHALL BE GRANTED ONLY ON A  
7 FINDING OF EXTRAORDINARY CIRCUMSTANCES. EXTRAORDINARY CIRCUMSTANCES INCLUDE  
8 ACTS OR OMISSIONS THAT ARE UNFORESEEN OR UNAVOIDABLE.
- 9 D. A PARTY REQUESTING A CONTINUANCE OF MORE THAN THIRTY DAYS SHALL  
10 FILE A MOTION FOR AN EXTENSION OF TIME SETTING FORTH THE REASONS WHY  
11 EXTRAORDINARY CIRCUMSTANCES EXIST. THE MOTION SHALL BE FILED WITHIN FIVE  
12 DAYS OF THE DISCOVERY OF THE EXTRAORDINARY CIRCUMSTANCE. THE COURT'S  
13 FINDING OF EXTRAORDINARY CIRCUMSTANCES SHALL BE IN WRITING AND SHALL SET  
14 FORTH THE FACTUAL BASIS FOR THE CONTINUANCE.
- 15 E. THE COURT MAY NOT EXTEND THE PROCEDURAL TIME LIMIT PRESCRIBED BY  
16 SECTION 8-537 FOR A TOTAL PERIOD OF MORE THAN SIXTY DAYS UNLESS THE COURT  
17 MAKES A WRITTEN FINDING THAT SUBSTANTIAL EVIDENCE EXISTS THAT THE  
18 ADDITIONAL TIME IS IN THE BEST INTEREST OF THE CHILD."
