SENATE AMENDMENTS TO S.B. 1180
(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. COVID-related expenditures; reporting
3 requirements; intent

4 A. Before spending monies from the coronavirus state fiscal recovery
5 fund and the coronavirus capital projects fund as appropriated by section
6 9901 of the American rescue plan act of 2021 (P.L. 117-2) in the amount of
7 \$10,000,000 or more for one designated purpose, the office of the governor
8 shall notify the president of the senate, the speaker of the house of
9 representatives, the chairpersons of the senate and house of
10 representatives appropriations committees and the director of the joint
11 legislative budget committee of the intended use of the monies.

12 B. Within thirty days after the last day of each calendar quarter
13 through June 30, 2024, the office of the governor shall report to the
14 president of the senate, the speaker of the house of representatives, the
15 chairpersons of the senate and house of representatives appropriations
16 committees and the director of the joint legislative budget committee the
17 actual expenditures from the coronavirus state fiscal recovery fund and the
18 coronavirus capital projects fund as appropriated by section 9901 of the
19 American rescue plan act of 2021 (P.L. 117-2).

20 C. Before spending monies allocated to the superintendent of public
21 instruction from the elementary and secondary school emergency relief fund
22 as appropriated by section 2001 of the American rescue plan act of 2021
23 (P.L. 117-2) in the amount of \$10,000,000 or more for one designated
24 purpose, the superintendent of public instruction shall notify the
25 president of the senate, the speaker of the house of representatives, the

1 chairpersons of the senate and house of representatives appropriations
2 committees and the director of the joint legislative budget committee of
3 the intended use of the monies.

4 D. Within thirty days after the last day of each calendar quarter
5 through June 30, 2024, the superintendent of public instruction shall
6 report to the president of the senate, the speaker of the house of
7 representatives, the chairpersons of the senate and house of
8 representatives appropriations committees and the director of the joint
9 legislative budget committee the actual expenditure of monies allocated to
10 the superintendent of public instruction from the elementary and secondary
11 school emergency relief fund as appropriated by section 2001 of the
12 American rescue plan act of 2021 (P.L. 117-2).

13 E. Before spending monies from the higher education emergency relief
14 fund as appropriated by section 2003 of the American rescue plan act of
15 2021 (P.L. 117-2) in the amount of \$10,000,000 or more for one designated
16 purpose, the Arizona board of regents shall report to the president of the
17 senate, the speaker of the house of representatives, the chairpersons of
18 the senate and house of representatives appropriations committees and the
19 director of the joint legislative budget committee the intended use of the
20 monies by Arizona state university, the university of Arizona and northern
21 Arizona university.

22 F. Within thirty days after the last day of each calendar quarter
23 through June 30, 2024, the Arizona board of regents shall report to the
24 president of the senate, the speaker of the house of representatives, the
25 chairpersons of the senate and house of representatives appropriations
26 committees and the director of the joint legislative budget committee the
27 actual expenditure of monies from the higher education emergency relief
28 fund as appropriated by section 2003 of the American rescue plan act of
29 2021 (P.L. 117-2) by Arizona state university, the university of Arizona
30 and northern Arizona university.

1 G. Reports required pursuant to this section shall delineate
2 expenditures by agency and program and include descriptions of the purpose
3 of the expenditures.

4 H. The legislature intends that the executive branch of state
5 government report on its planned and actual use of any major additional
6 federal aid to the state of Arizona through federal legislation enacted by
7 the end of fiscal year 2021-2022. The timing and frequency of these
8 reports should be the same as required by subsections A through F of this
9 section. The chairman and vice chairman of the joint legislative budget
10 committee may provide recommendations to the executive branch concerning
11 federal legislation that would qualify under this subsection."
