- 15 A. THE PROSECUTOR CRIME VICTIM NOTIFICATION FUND IS ESTABLISHED  
16 CONSISTING OF LEGISLATIVE APPROPRIATIONS AND MONIES AVAILABLE FROM ANY  
17 OTHER LAWFUL SOURCE. THE ATTORNEY GENERAL SHALL ADMINISTER THE FUND, SHALL  
18 DISTRIBUTE FUND MONIES TO QUALIFYING ORGANIZATIONS AND ENTITIES AND MAY USE  
19 NOT MORE THAN FIVE PERCENT OF THE MONIES DEPOSITED IN THE FUND FOR  
20 ADMINISTRATIVE COSTS. MONIES IN THE FUND ARE SUBJECT TO LEGISLATIVE  
21 APPROPRIATION AND MAY BE USED BY PROSECUTING AGENCIES IN THIS STATE TO FUND  
22 SOFTWARE THAT DOES THE FOLLOWING:  
23 1. ENABLES THE DEVELOPMENT OF AN AUTOMATED CRIME VICTIM NOTIFICATION  
24 SYSTEM TO THE USER BASE CONSISTING OF PROSECUTING AGENCIES. THE AUTOMATED

1 CRIME VICTIM NOTIFICATION SYSTEM MUST ENHANCE THE USER'S NOTIFICATION  
2 SYSTEM AND DO THE FOLLOWING:

3 (a) NOTIFY THE VICTIM OF ALL NOTIFICATIONS REQUIRED BY TITLE 8,  
4 CHAPTER 3 AND TITLE 13, CHAPTER 40.

5 (b) INTERFACE WITH THE PROSECUTING AGENCIES' RECORD MANAGEMENT  
6 SYSTEM.

7 (c) PROVIDE CONFIGURABLE TRIGGERS TO SEND MESSAGES TO CRIME VICTIMS.

8 (d) PROVIDE THE ABILITY TO ATTACH INFORMATIONAL BROCHURES OR OTHER  
9 ELECTRONIC ATTACHMENTS TO THE MESSAGES.

10 (e) PROVIDE THE ABILITY FOR VICTIMS TO FIND THEIR CASE STATUS ON THE  
11 AGENCIES' WEBSITES.

12 (f) INCLUDE THE AGENCIES' BRANDING, EMAIL ADDRESSES AND WEB DOMAINS  
13 FOR ALL COMMUNICATIONS.

14 (g) PROVIDE THE ABILITY TO SEND MESSAGES IN MULTIPLE LANGUAGES.

15 (h) PROVIDE A SHORT CODE OR A LONG CODE TELEPHONE NUMBER WITH A  
16 LOCAL AREA CODE.

17 (i) MONITOR THE NUMBER OF MESSAGES SENT AND THE TYPES OF MESSAGES  
18 SENT AND VISUALIZE THE DATA.

19 B. A VENDOR OF ANY SOFTWARE DESCRIBED IN SUBSECTION A OF THIS  
20 SECTION MUST HAVE PREVIOUSLY DEPLOYED A SOLUTION FOR A PROSECUTOR'S OFFICE.

21 C. PARTICIPATION BY A PROSECUTING AGENCY IN AN AUTOMATED CRIME  
22 VICTIM NOTIFICATION SYSTEM IS VOLUNTARY. PARTICIPATION BY AN AGENCY IN THE  
23 COUNTY DOES NOT OBLIGATE ANY OTHER AGENCY TO PARTICIPATE OR PROVIDE DATA TO  
24 THIS SYSTEM."

26 second semicolon insert "prosecutor crime victim notification fund;"

27 Line 15, strike "\$5,100,000" insert "\$3,600,000"
