SENATE AMENDMENTS TO S.B. 1720
(Reference to printed bill)

1 Page 1, between lines 3 and 4, insert:

2 "Sec. 2. 2022 precinct committeeman elections; candidate
3 filings

4 A. Notwithstanding any other law, for candidates for election in
5 2022 to the office of precinct committeeman immediately following
6 redistricting that is conducted as otherwise provided by law, the following
7 apply:

8 1. If the candidate's nomination paper and nomination petition are
9 in compliance with otherwise applicable law, the filing officer shall
10 accept as a valid filing the nomination paper and nomination petition of a
11 person that designate an election precinct for that person's candidacy and
12 that use either or both of the following:

13 (a) The candidate's election precinct as used in the election for
14 that office immediately preceding the redistricting.

15 (b) The candidate's election precinct as designated by the county
16 board of supervisors as a result of or after a redistricting plan that is
17 adopted for the upcoming election.

1 2. If the candidate's nomination paper and nomination petition are
2 in compliance with otherwise applicable law, the filing officer shall
3 accept and petition signers are valid if the petition signers are qualified
4 signers who are residents of either or both of the following election
5 precincts that the candidate proposes to represent:

6 (a) The candidate's election precinct as used in the election for
7 that office immediately preceding the redistricting.

8 (b) The candidate's election precinct as designated by the county
9 board of supervisors as a result of or after a redistricting plan that is
10 adopted for the upcoming election.

11 3. The number of signatures required for the candidate's nomination
12 petition shall be the lesser of the following:

13 (a) The number of qualified signers as prescribed in section 16-322,
14 Arizona Revised Statutes, that is based on the candidate's election
15 precinct as used in the election for that office immediately preceding the
16 redistricting.

17 (b) The number of qualified signers as prescribed in section 16-322,
18 Arizona Revised Statutes, that is based on the candidate's election
19 precinct as designated by the county board of supervisors as a result of or
20 after a redistricting plan that is adopted for the upcoming election.

21 4. The candidate shall file the nomination paper and nomination
22 petition not later than April 4, 2022.

1 B. Notwithstanding any other law, for any 2022 candidate for
2 precinct committeeman who files with that candidate's county political
3 party committee as prescribed by Laws 2022, chapter 3, section 4 while it
4 is in effect and if the candidate is in compliance with otherwise
5 applicable law, the following apply:

6 1. The candidate's filing is valid.

7 2. Not later than April 4, 2022, the chair of the county political
8 party committee shall forward to the county officer in charge of elections
9 the names and candidate information of all precinct committeeman candidates
10 who have filed with the county political party committee as prescribed in
11 this subsection."
