SENATE AMENDMENTS TO H.B. 2473

(Reference to House engrossed bill)

1 Page 1, line 5, after the first semicolon insert "firearm trade associations;"

2 Line 12, after "ENTITY" insert "OR FIREARM TRADE ASSOCIATION. A PUBLIC ENTITY
3 COMPLIES WITH THE WRITTEN CERTIFICATION REQUIREMENT BY INCLUDING A WRITTEN
4 CERTIFICATION THAT WAS SUBMITTED BY THE COMPANY AS PART OF THE PROCUREMENT
5 PROCESS"

6 Line 15, after "ENTITY" insert "OR FIREARM TRADE ASSOCIATION"

7 Between lines 15 and 16, insert:

8 "C. SUBSECTION A OF THIS SECTION DOES NOT APPLY TO A CONTRACT
9 ENTERED INTO BY A PUBLIC ENTITY IF EITHER:

10 1. THE CONTRACT IS A SOLE SOURCE CONTRACT.

11 2. THE PUBLIC ENTITY DOES NOT RECEIVE A RESPONSIVE BID FROM ANY
12 COMPANY THAT IS ABLE TO PROVIDE THE WRITTEN CERTIFICATION.

13 D. THIS SECTION DOES NOT APPLY TO A CONTRACT ENTERED INTO BEFORE THE
14 EFFECTIVE DATE OF THIS SECTION."

18 PROJECTILE OR PROPELLANT POWDER."

16 REFRAINING FROM CONTINUING AN EXISTING BUSINESS RELATIONSHIP OR TERMINATING
17 AN EXISTING BUSINESS RELATIONSHIP IN ORDER TO COMPLY WITH A FEDERAL, STATE
18 OR LOCAL LAW, POLICY, RULE OR REGULATION OR FOR ANY TRADITIONAL BUSINESS
19 REASON THAT IS SPECIFIC TO THE FIREARM ENTITY OR FIREARM TRADE ASSOCIATION
20 BUT IS NOT BASED SOLELY ON ITS STATUS AS A FIREARM ENTITY OR FIREARM TRADE
21 ASSOCIATION."

22 Line 31, after "EXPLOSIVE" insert "OR EXPANDING GASES"

23 Line 36, after "DEVICE" insert ", INCLUDING A DETACHABLE MAGAZINE,"

24 Line 39, strike "ALL" insert "EITHER"

25 Line 42, strike "A" insert "AN INDOOR OR OUTDOOR"

26 Strike line 43

27 Page 2, strike lines 1 through 3

28 Renumber to conform

1 Page 2, line 4, after the first quotation mark insert "FIREARM"

2 After line 14, insert:

3 "8. "PUBLIC ENTITY":

4 (a) MEANS THIS STATE, A POLITICAL SUBDIVISION OF THIS STATE OR AN
5 AGENCY, BOARD, COMMISSION OR DEPARTMENT OF THIS STATE OR A POLITICAL
6 SUBDIVISION OF THIS STATE.

7 (b) DOES NOT INCLUDE A POLITICAL SUBDIVISION THAT OPERATES A FEDERAL
8 RECLAMATION PROJECT."
