# **HOUSE BILL 2753**

AN ACT

AMENDING SECTION 15-1643, ARIZONA REVISED STATUTES; APPROPRIATING MONIES;  
RELATING TO HEALTH EDUCATION.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:  
2       Section 1. Section 15-1643, Arizona Revised Statutes, is amended to  
3 read:

4           15-1643. Arizona area health education system; centers;  
5           governing boards; duties; report; primary care  
6           residency programs; definitions

7       A. The Arizona board of regents shall establish the Arizona area  
8 health education system in the college of medicine of the university of  
9 Arizona. The board shall appoint a system director.

10      B. The system shall consist of six area health education centers  
11 administered by the director of the Arizona area health education  
12 system. Each center shall represent a geographic area with specified  
13 populations that the system determines currently lack services by the  
14 health care professions. One center shall focus on the Indian health care  
15 delivery system.

16      C. The Arizona board of regents shall appoint a governing board for  
17 each center consisting of not fewer than ten people and not more than  
18 twenty people. Board membership shall consist of health care providers  
19 and consumers and shall reflect the ethnic representation of the center's  
20 geographic area. Each governing board shall make recommendations to the  
21 director regarding health professionals' educational needs, local program  
22 priorities and the allocation of system monies. Board members are not  
23 eligible to receive compensation or reimbursement of expenses.

24      D. Each center shall conduct:

25       1. Physician and other health professional education programs that  
26 consist of any of the following:

- 27           (a) An undergraduate clinical training program.  
28           (b) A graduate program.  
29           (c) Postgraduate continuing education.

30       2. Programs to recruit and retain minority students in health  
31 professions.

32       3. Continuing education programs for health professionals.

33           E. ON OR BEFORE MAY 1, 2024, THE ARIZONA AREA HEALTH EDUCATION  
34 SYSTEM SHALL ESTABLISH A PROGRAM FOR QUALIFYING COMMUNITY HEALTH CENTERS,  
35 RURAL HEALTH CLINICS AND TRIBAL HEALTH FACILITIES THAT DOES ALL OF THE  
36 FOLLOWING:

37           1. SUPPORTS AND EXPANDS THE NUMBER OF PRIMARY CARE RESIDENCY  
38 POSITIONS.

39           2. PROVIDES SUPPORT AND TECHNICAL ASSISTANCE FOR STARTING OR  
40 EXPANDING PRIMARY CARE RESIDENCY PROGRAMS IN RURAL AREAS AND HEALTH  
41 PROFESSIONAL SHORTAGE AREAS.

42           3. FACILITATES INFORMATION AND RESOURCE SHARING AND PROVIDES  
43 TRAINING AND TECHNICAL ASSISTANCE, INCLUDING PRECEPTOR TRAINING AND  
44 DEVELOPMENT, CONTINUING EDUCATION, MEDICAL LIBRARY ACCESS AND OTHER  
45 FUNCTIONS, TO SUPPORT THE SUCCESS OF QUALIFYING COMMUNITY HEALTH CENTER,

1 RURAL HEALTH CLINIC AND TRIBAL HEALTH FACILITY PRIMARY CARE RESIDENCY  
2 PROGRAMS.

3 ~~F.~~ F. The director shall submit a written report on or before  
4 November 15 of each year to the governor, the president of the senate and  
5 the speaker of the house of representatives. The report shall contain the  
6 following:

7 1. The fiscal status of each center.

8 2. Information regarding center education, outreach and training  
9 programs.

10 3. Information regarding placement of health care personnel in  
11 areas the director determines are underserved by these professionals.

12 4. An assessment of system accomplishments.

13 5. Recommendations for possible legislative action.

14 ~~F.~~ G. The system shall provide expertise and administrative  
15 services to each center.

16 H. FOR THE PURPOSES OF THIS SECTION:

17 1. "PRIMARY CARE" MEANS FAMILY MEDICINE, INTERNAL MEDICINE,  
18 PEDIATRICS, PEDIATRIC INTERNAL MEDICINE, PSYCHIATRY, OBSTETRICS AND  
19 GYNECOLOGY, GERIATRICS OR GENERAL SURGERY.

20 2. "TRIBAL HEALTH FACILITY" MEANS AN OUTPATIENT HEALTH FACILITY  
21 THAT IS OPERATED BY AN INDIAN TRIBE AND THAT IS AUTHORIZED TO PROVIDE  
22 SERVICES PURSUANT TO THE INDIAN SELF-DETERMINATION AND EDUCATION  
23 ASSISTANCE ACT (P.L. 93-638; 88 STAT. 2203).

24 Sec. 2. Appropriation; Arizona area health education system;  
25 primary care residency programs; exemption;  
26 definition

27 A. The sum of \$5,000,000 is appropriated onetime from the state  
28 general fund in fiscal year 2023-2024 to the Arizona area health education  
29 system for the purposes of section 15-1643, subsection E, Arizona Revised  
30 Statutes, as added by this act. The Arizona area health education system  
31 may use up to \$500,000 of the appropriation to support a collaborative of  
32 qualifying community health centers', rural health clinics' and tribal  
33 health facilities primary care residency programs.

34 B. The appropriation made in subsection A of this section is exempt  
35 from the provisions of section 35-190, Arizona Revised Statutes, relating  
36 to lapsing of appropriations.

37 C. For the purposes of this section, "tribal health facility" has  
38 the same meaning prescribed in section 15-1643, Arizona Revised Statutes,  
39 as amended by this act.

40 Sec. 3. Appropriations; Arizona health care cost containment  
41 system administration; primary care graduate  
42 medical education; exemption; definition

43 A. The sum of \$5,000,000 is appropriated from the state general  
44 fund in each of fiscal years 2023-2024, 2024-2025 and 2025-2026 to the  
45 Arizona health care cost containment system administration for the

1 purposes of section 36-2907.06, subsection I, paragraph 4, Arizona Revised  
2 Statutes, for the direct and indirect costs of primary care graduate  
3 medical education at qualifying community health centers, rural health  
4 clinics and tribal health facilities.

5       B. The appropriation made in subsection A of this section is exempt  
6 from the provisions of section 35-190, Arizona Revised Statutes, relating  
7 to lapsing of appropriations.

8       C. For the purposes of this section, "tribal health facility" has  
9 the same meaning prescribed in section 15-1643, Arizona Revised Statutes,  
10 as amended by this act.
