1 Page 1, line 6, strike "checklist" insert "discharge document"

2 Between lines 35 and 36, insert:

3 "9. A COPY OF THE RESIDENT'S ADVANCE DIRECTIVES, IF ANY, ON FILE AT
4 THE ASSISTED LIVING CENTER OR ASSISTED LIVING HOME."

5 Line 43, after the period insert "EACH ASSISTED LIVING CENTER AND ASSISTED
6 LIVING HOME SHALL PERIODICALLY UPDATE THIS FORM FOR EACH RESIDENT AS
7 NECESSARY."

8 Page 2, line 11, after "SHALL" insert "COORDINATE WITH THE HEALTH CARE
9 INSTITUTION FROM WHICH THE PATIENT HAS BEEN TRANSFERRED OR THE HEALTH CARE
10 INSTITUTION TO WHICH THE PATIENT WILL BE DISCHARGED AND SHALL"; after
11 "PROVIDE" insert "A"; strike "PLANS FOR PATIENTS"

12 Strike lines 12 and 13

13 Line 14, strike "BY THE HOSPITAL'S URGENT CARE FACILITY" insert "PLAN FOR EACH
14 INPATIENT"; strike "PLANS MUST" insert "PLAN SHALL"

15 Line 15, after "STAFF" insert a period strike remainder of line

17 Line 18, after "NUMBER" insert "AND, IF AVAILABLE"; strike "AND, IF"

18 Strike line 19

19 Line 20, strike "TWENTY-FOUR HOURS A DAY, SEVEN DAYS A WEEK"; after the period
20 insert "THE HOSPITAL'S POINT OF CONTACT SHALL MONITOR THE TELEPHONE AND, IF
21 AVAILABLE, THE EMAIL ADDRESS PROVIDED AND SHALL PROMPTLY RESPOND TO ANY
22 INQUIRY. FOR FORTY-EIGHT HOURS AFTER DISCHARGE,"

1 Page 2, line 24, after "PLAN" insert a period strike remainder of line

2 Strike lines 25 through 30, insert "HOSPITALS SHALL HAVE A QUALIFIED HOSPITAL
3 REPRESENTATIVE RESPOND TO DISCHARGE PLAN QUESTIONS RECEIVED FROM THE
4 ASSISTED LIVING CENTER OR ASSISTED LIVING HOME."

5 Strike lines 43 and 44

6 Page 3, strike lines 1 through 19, insert:

7 "(g) FOLLOW-UP HEALTH CARE SERVICES AND OTHER SERVICES RECOMMENDED
8 FOR THE PATIENT."

10 Line 20, strike the first "THE" insert "ANY"; after "PRESCRIPTION" strike
11 remainder of line

12 Line 21, strike "PRESCRIPTION" insert ", IF APPLICABLE, THAT"

13 Line 22, after the period insert "THE COPY OF THE PRESCRIPTION SHALL INCLUDE
14 THE PATIENT'S NAME, MEDICATION ADMINISTRATION INSTRUCTIONS AND THE
15 ELECTRONIC SIGNATURE OF THE PRESCRIBER. THE COPY OF THE PRESCRIPTION MAY
16 BE PROVIDED ELECTRONICALLY."

17 Line 24, strike "THE NAME AND LOCATION OF THE"

18 Line 25, strike "PHARMACY FOR"; strike "PRESCRIPTION DRUG OR"

19 Line 29, after "G." insert "THE DISCHARGING HOSPITAL SHALL CONTACT THE
20 ASSISTED LIVING CENTER OR ASSISTED LIVING HOME FROM WHICH THE PATIENT
21 ENTERED THE HOSPITAL, AFTER INITIAL INPATIENT ASSESSMENT, TO DISCUSS AN
22 EVALUATION OF THE PATIENT'S LIKELY POSTDISCHARGE HEALTH CARE NEEDS. THE
23 HOSPITAL SHALL REEVALUATE AND DISCUSS WITH THE ASSISTED LIVING CENTER OR
24 ASSISTED LIVING HOME FROM WHICH THE PATIENT ENTERED THE HOSPITAL THE
25 PATIENT'S CONDITION, AS APPROPRIATE, TO IDENTIFY CHANGES TO THE PATIENT'S
26 CONDITION THAT MAY IMPACT THE PATIENT'S POSTDISCHARGE HEALTH CARE NEEDS,
27 INCLUDING, IF ANY, RECOMMENDATIONS BY THE HOSPITAL TO TRANSFER THE PATIENT
28 TO A DIFFERENT FACILITY OTHER THAN THE FACILITY FROM WHICH THE PATIENT
29 ENTERED THE HOSPITAL TO ADDRESS THE PATIENT'S HIGHER CARE NEEDS."

30 Line 33, after "OF" insert "OR DISCUSSION ABOUT"

31 Line 36, after the period strike remainder of line

32 Strike lines 37 and 38

1 Page 3, line 39, strike "FACILITY."

2 Strike lines 41 through 43, insert "PROMPTLY. IF THE ASSISTED LIVING CENTER OR
3 ASSISTED LIVING HOME FROM WHICH THE PATIENT ENTERED THE HOSPITAL CAN NO
4 LONGER MEET THE PATIENT'S NEEDS, THE FACILITY SHALL PROVIDE DOCUMENTATION
5 TO THE HOSPITAL DEMONSTRATING THE REASONS WHY THE FACILITY CANNOT ACCEPT
6 THE PATIENT BACK TO THE FACILITY.

7 H. FOR PATIENTS BEING TRANSFERRED FROM A HOSPITAL TO AN ASSISTED
8 LIVING CENTER OR ASSISTED LIVING HOME WHO HAVE NOT PREVIOUSLY BEEN ADMITTED
9 TO THE ASSISTED LIVING CENTER OR ASSISTED LIVING HOME, THE HOSPITAL SHALL
10 COORDINATE WITH THE ASSISTED LIVING CENTER OR ASSISTED LIVING HOME TO ALLOW
11 TIME TO EXPEDITIOUSLY OBTAIN DOCUMENTATION FROM A PHYSICIAN, REGISTERED
12 NURSE PRACTITIONER, REGISTERED NURSE OR PHYSICIAN ASSISTANT COORDINATING
13 THE LEVEL OF CARE NEEDED IN THE ASSISTED LIVING CENTER OR ASSISTED LIVING
14 HOME."

15 Reletter to conform

16 Page 4, line 1, after "H." insert "FOR EMERGENCY DEPARTMENT OR OBSERVATION
17 PATIENTS, THE HOSPITAL SHALL PROVIDE THE PATIENT'S ASSISTED LIVING CENTER
18 OR ASSISTED LIVING HOME FROM WHICH THE PATIENT ENTERED THE HOSPITAL WITH A
19 POINT OF CONTACT, INCLUDING A TELEPHONE NUMBER AND, IF AVAILABLE, AN EMAIL
20 ADDRESS. THE HOSPITAL'S POINT OF CONTACT SHALL MONITOR THE TELEPHONE AND,
21 IF AVAILABLE, THE EMAIL ADDRESS PROVIDED AND PROMPTLY RESPOND TO ANY
22 INQUIRY. FOR FORTY-EIGHT HOURS AFTER DISCHARGE, THE DISCHARGING HOSPITAL'S
23 DESIGNATED POINT OF CONTACT MUST BE AVAILABLE TO RESPOND TO THE RECEIVING
24 ASSISTED LIVING CENTER OR ASSISTED LIVING HOME TO ASSIST IN RETURNING OR
25 ADMITTING THE PATIENT TO THE ASSISTED LIVING CENTER OR ASSISTED LIVING HOME
26 AND TO CLARIFY ANY NEEDED INFORMATION IN THE DISCHARGE PLAN. HOSPITALS
27 SHALL HAVE A QUALIFIED HOSPITAL REPRESENTATIVE RESPOND TO DISCHARGE PLAN
28 QUESTIONS RECEIVED FROM THE ASSISTED LIVING CENTER OR ASSISTED LIVING HOME.
29 THE HOSPITAL SHALL ALSO PROVIDE THE PATIENT'S ASSISTED LIVING CENTER OR
30 ASSISTED LIVING HOME WITH A COPY OF ANY PRESCRIPTION ORDERS AS PRESCRIBED
31 IN SUBSECTION F, PARAGRAPH 4 OF THIS SECTION AND ANY IDENTIFIED FOLLOW-UP
32 CARE SERVICES RECOMMENDED FOR THE PATIENT. THE HOSPITAL SHALL PROVIDE THE

1 ADDITIONAL INFORMATION OUTLINED IN SUBSECTION F, PARAGRAPH 3 OF THIS
2 SECTION IF THE HOSPITAL DETERMINES IT IS APPLICABLE."
