2 EMPLOYEE OR WHO OVERSEES ANY SIGNIFICANT ASPECT OF ELECTION OPERATIONS MAY
3 NOT" insert "NEITHER THE SECRETARY OF STATE, A MEMBER OF A COUNTY BOARD OF
4 SUPERVISORS, A COUNTY RECORDER, NOR ANY OTHER OFFICER IN CHARGE OF
5 ELECTIONS, ELECTED OR NON-ELECTED, SHALL BE A CHAIRPERSON, TREASURER, OR
6 OTHER MEMBER OF A POLITICAL ACTION COMMITTEE. NOR SHALL ANY EMPLOYEE OF
7 SUCH PERSON, OR OF A BOARD OF SUPERVISORS AS A WHOLE,"

8 Between lines 8 and 9, insert

9 "B. NEITHER THE SECRETARY OF STATE, A MEMBER OF A COUNTY BOARD OF
10 SUPERVISORS, A COUNTY RECORDER, NOR ANY OTHER OFFICER IN CHARGE OF
11 ELECTIONS, ELECTED OR NON-ELECTED, SHALL COORDINATE WITH ANY POLITICAL
12 ACTION COMMITTEE WITH RESPECT TO ANY FUNDRAISING OR ANY ADVOCACY FOR THE
13 SUPPORT OR DEFEAT OF ANY CANDIDATE FOR OFFICE OR BALLOT MEASURE. NOR SHALL
14 ANY EMPLOYEE OF SUCH, OR OF A BOARD OF SUPERVISORS AS A WHOLE, PERSON BE A
15 CHAIRPERSON, TREASURER OR OTHER MEMBER OF A POLITICAL ACTION COMMITTEE.

16 C. SUBSECTIONS B AND C OF THIS SECTION EXTEND TO INDEPENDENT
17 CONTRACTORS OF SUCH PERSONS WHO ARE CONTRACTED WITH FOR WORK RELATED TO
18 ELECTIONS."
