1 Page 1, between lines 1 and 2, insert:

2 "Section 1. Section 15-1801, Arizona Revised Statutes, is amended to
3 read:

4 15-1801. Definitions

5 In this article, unless the context otherwise requires:

6 1. "Armed forces of the United States" ~~means the army, the navy, the~~
7 ~~air force, the marine corps, the coast guard, the commissioned corps of the~~
8 ~~United States public health services, the national oceanographic and~~
9 ~~atmospheric administration, the national guard and any military reserve~~
10 ~~unit of any branch of the armed forces of the United States~~ HAS THE SAME
11 MEANING PRESCRIBED IN SECTION 41-601.

12 2. "Continuous attendance" means enrollment at an educational
13 institution in this state as a full-time student, as such term is defined
14 by the governing body of the educational institution, for a normal academic
15 year since the beginning of the period for which continuous attendance is
16 claimed. Such person need not attend summer sessions or any other
17 intersession beyond the normal academic year in order to maintain
18 continuous attendance.

19 3. "Domicile" means a person's true, fixed and permanent home and
20 place of habitation. It is the place where he intends to remain and to
21 which he expects to return when he leaves without intending to establish a
22 new domicile elsewhere.

1 4. "Emancipated person" means a person who is neither under a legal
2 duty of service to his parent nor entitled to the support of such parent
3 under the laws of this state.

4 5. "Parent" means a person's father or mother, or if one parent has
5 custody, that parent, or if there is no surviving parent or the whereabouts
6 of the parents are unknown, then a guardian of an unemancipated person if
7 there are not circumstances indicating that such guardianship was created
8 primarily for the purpose of conferring the status of an in-state student
9 on such unemancipated person.

10 Sec. 2. Section 41-601, Arizona Revised Statutes, is amended to
11 read:

12 41-601. Definitions

13 In this article, unless the context otherwise requires:

14 1. "ARMED FORCES OF THE UNITED STATES" MEANS THE ARMY, THE NAVY, THE
15 AIR FORCE, THE SPACE FORCE, THE MARINE CORPS, THE COAST GUARD, THE
16 COMMISSIONED CORPS OF THE UNITED STATES PUBLIC HEALTH SERVICES, THE
17 NATIONAL OCEANOGRAPHIC AND ATMOSPHERIC ADMINISTRATION, THE NATIONAL GUARD
18 AND ANY MILITARY RESERVE UNIT OF ANY BRANCH OF THE ARMED FORCES OF THE
19 UNITED STATES.

20 ~~1.~~ 2. "Commission" means the Arizona veterans' service advisory
21 commission.

22 ~~2.~~ 3. "Department" means the department of veterans' services.

23 ~~3.~~ 4. "Director" means the director of the department of veterans'
24 services.

25 ~~4.~~ 5. "Veteran" means a citizen of the United States who was
26 enlisted, drafted, inducted or commissioned and who was accepted for and
27 assigned to active duty in the armed forces of the United States."

4 fiscal year 2023-2024 to the department of veterans' services for costs

6 branch pursuant to 38 United States Code section 101 and 10 United States
7 Code section 101."
