3 Between lines 7 and 8, insert:

4 "B. IF A CITY OR TOWN REDUCES THE PER CAPITA ANNUAL OPERATING BUDGET
5 FOR A LAW ENFORCEMENT AGENCY, THE CITY OR TOWN SHALL REDUCE THE ANNUAL
6 OPERATING BUDGET FOR ALL DEPARTMENTS WITHIN THE CITY OR TOWN IN AN AMOUNT
7 EQUAL TO THE REDUCTION IN THE PER CAPITA ANNUAL OPERATING BUDGET FOR THE
8 CITY'S OR TOWN'S LAW ENFORCEMENT AGENCY. THE PER CAPITA ANNUAL OPERATING
9 BUDGET FOR THE CITY'S OR TOWN'S LAW ENFORCEMENT AGENCY SHALL BE THE LAST
10 BUDGET TO BE REDUCED. FOR THE PURPOSES OF THIS SUBSECTION, FUNDING FOR A
11 ONETIME CAPITAL IMPROVEMENT IS NOT CONSIDERED PART OF THE OPERATING BUDGET
12 FOR A CITY OR TOWN DEPARTMENT."

16 Line 18, after "TOWN" strike remainder of line

17 Strike lines 19 and 20, insert "IS EXPERIENCING A SEVERE FINANCIAL HARDSHIP OR
18 NEEDS TO RAISE ANY PORTION OF THE CITY'S OR TOWN'S TAXES TO CONTINUE THE
19 LAW ENFORCEMENT AGENCY'S PER CAPITAL ANNUAL OPERATING BUDGET. THE CITY OR
20 TOWN SHALL DOCUMENT THE SEVERE FINANCIAL HARDSHIP AND PROVIDE THE
21 DOCUMENTATION OF THE SEVERE FINANCIAL HARDSHIP TO THE STATE TREASURER, THE
22 PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES."

5 (c) AN UNFUNDED STATE OR FEDERAL MANDATE.
