4 "Section 1. Title 12, chapter 1, article 1, Arizona Revised
5 Statutes, is amended by adding section 12-116.12, to read:

6 12-116.12. Penalty fee; first responder's supplemental death
7 benefit

8 A. BEGINNING FROM AND AFTER JUNE 30, 2025, IN ADDITION TO ANY OTHER
9 PENALTY, FINE, FEE, SURCHARGE OR ASSESSMENT AUTHORIZED BY LAW, A PERSON
10 SHALL PAY A PENALTY FEE OF \$20 ON EVERY CONVICTION FOR A CRIMINAL OFFENSE.

11 B. THE COURT SHALL TRANSMIT THE PENALTY FEE COLLECTED PURSUANT TO
12 THIS SECTION TO THE COUNTY TREASURER, EXCEPT THAT MUNICIPAL COURTS SHALL
13 TRANSMIT THE PENALTY FEE TO THE CITY OR TOWN TREASURER.

14 C. THE CITY, TOWN OR COUNTY TREASURER SHALL TRANSMIT THE PENALTY
15 FEES TO THE STATE TREASURER. THE STATE TREASURER SHALL DEPOSIT THE PENALTY
16 FEES, PURSUANT TO SECTIONS 35-146 AND 35-147, IN THE STATE SUPPLEMENTAL
17 BENEFIT FUND ESTABLISHED BY SECTION 38-1173.

18 D. THE COURT MAY NOT WAIVE OR MITIGATE THE PENALTY FEE.

8 FIRST RESPONDERS WHO ARE SERIOUSLY INJURED IN THE LINE OF DUTY AND THE
9 FIRST RESPONDER'S FAMILY."
