4 After line 5, insert:

5 "5. "PERMANENTLY AFFIXED SIGN" MEANS A DUAL COLOR SIGN THAT IS AT  
6 LEAST 18 INCHES BY 24 INCHES WITH CAPITALIZED LETTERS OF AT LEAST 200 POINT  
7 TYPE SIZE."
