9 (b) A COMPANY OR OTHER ENTITY THAT IS ANY OF THE FOLLOWING:

10 (i) HEADQUARTERED IN CHINA, CUBA, IRAN, NORTH KOREA, RUSSIA, SAUDI  
11 ARABIA, SYRIA OR VENEZUELA.

12 (ii) DIRECTLY OR INDIRECTLY HELD OR CONTROLLED BY THE GOVERNMENT OF  
13 CHINA, CUBA, IRAN, NORTH KOREA, RUSSIA, SAUDI ARABIA, SYRIA OR VENEZUELA.

14 (iii) OWNED BY OR THE MAJORITY OF STOCK OR OTHER OWNERSHIP INTEREST  
15 OF WHICH IS HELD OR CONTROLLED BY INDIVIDUALS WHO ARE CITIZENS OF CHINA,  
16 CUBA, IRAN, NORTH KOREA, RUSSIA, SAUDI ARABIA, SYRIA OR VENEZUELA.

17 (c) A COMPANY OR OTHER ENTITY THAT IS OWNED BY OR THE MAJORITY OF  
18 STOCK OR OTHER OWNERSHIP INTEREST OF WHICH IS HELD OR CONTROLLED BY A  
19 COMPANY OR ENTITY DESCRIBED IN SUBDIVISION (b) OF THIS PARAGRAPH.

1 (d) AN INDIVIDUAL WHO IS A CITIZEN OF CHINA, CUBA, IRAN, NORTH KOREA,  
2 RUSSIA, SAUDI ARABIA, SYRIA OR VENEZUELA.  
3 2. DOES NOT INCLUDE THE UNITED STATES GOVERNMENT OR ITS STATES,
