SENATE AMENDMENTS TO H.B. 2094
(Reference to House engrossed bill)

- 1 Page 1, line 11, after "PRIVATE" insert "RESIDENTIAL"
- 2 Between lines 12 and 13, insert:
 - 3 " (a) THE RESIDENTIAL PROPERTY IS THE PRIMARY RESIDENCE OF THE
 - 4 PROPERTY OWNER, A TENANT WITH A LEASE TERM OF ONE YEAR OR LONGER OR A
 - 5 TRUSTEE OF THE LIVING TRUST THAT OWNS THE RESIDENTIAL PROPERTY."
- 6 Reletter to conform
- 7 Line 14, after the period insert "THE OWNER WHO PROVIDES THE WRITTEN
- 8 PERMISSION MUST BE ON THE PROPERTY WHILE THE MOBILE FOOD VENDOR IS
- 9 OPERATING."
- 10 Between lines 19 and 20, insert:
 - 11 " (e) THE MOBILE FOOD VENDOR DOES NOT SERVE FOOD BETWEEN THE HOURS OF
 - 12 10:00 P.M. AND 6:00 A.M.
 - 13 (f) THE MOBILE FOOD VENDOR REMOVES THE FOOD WASTE, COOKING GREASE
 - 14 AND OTHER TRASH FROM THE RESIDENTIAL PROPERTY IN COMPLIANCE WITH APPLICABLE
 - 15 LAWS AND REGULATIONS."
- 16 Strike lines 44 and 45
- 17 Page 2, between lines 4 and 5, insert:
 - 18 " D. IF REQUIRED BY A CITY OR TOWN ORDINANCE, THE MOBILE FOOD VENDOR
 - 19 SHALL PAY NOT MORE THAN \$150 PER YEAR TO OPERATE ON PRIVATE RESIDENTIAL
 - 20 PROPERTY WITHIN THE CITY OR TOWN PURSUANT TO SUBSECTION A, PARAGRAPH 1 OF
 - 21 THIS SECTION."
- 22 Page 4, line 41, strike "~~background check or identification and fingerprinting of~~
- 23 ~~the~~"

- 1 Page 4, line 42, strike "~~owner of the mobile food vending operation~~" insert
- 2 "background check or identification and fingerprinting of the owner of the
- 3 mobile food vending operation **OR A**"; after "**CARD**" insert "**ISSUED BY THE**
- 4 **DEPARTMENT OF PUBLIC SAFETY**"
- 5 Amend title to conform
