1 Page 1, strike lines 16 through 45, insert:

2           "C. FOR THE AVOIDANCE OF DOUBT, THE COUNTY RECORDER AND COUNTY  
3 OFFICER IN CHARGE OF ELECTIONS SHALL MAINTAIN ELECTION BOARD WORKER AND  
4 EMPLOYEE DOCUMENTATION IN THE FORM OF A LOG AT EACH STAGE OF THE SIGNATURE  
5 AND AFFIDAVIT VERIFICATION PROCESS, INCLUDING BY EACH SIGNATURE  
6 VERIFICATION WORK STATION, AND BY ALL ELECTION BOARD WORKERS AND EMPLOYEES  
7 INVOLVED IN EACH PHASE OF REVIEW AND SHALL PROVIDE FOR FULL ACCOUNTING AND  
8 DISCLOSURE OF THE TOTAL NUMBER OF SIGNATURE VERIFICATIONS PERFORMED BY EACH  
9 ELECTION BOARD WORKER AND EMPLOYEE INCLUDING THE DETERMINATION MADE BY EACH  
10 ELECTION BOARD WORKER AND EMPLOYEE INCLUDING, THE NAME OF THE ELECTION  
11 BOARD WORKER WHO CONDUCTED THE SIGNATURE VERIFICATION, THE DATE THE REVIEW  
12 WAS CONDUCTED, THE BATCH NUMBERS AND THE TOTAL NUMBER OF SIGNATURE  
13 VERIFICATIONS PERFORMED AND THE TOTAL NUMBER OF DETERMINATIONS IN EACH  
14 CATEGORY, ACCEPTED, REJECTED, SENT FOR FURTHER REVIEW, AND THE FINAL  
15 DETERMINATION MADE AT SUBSEQUENT PHASES OR LEVELS OF REVIEW. EVERY ELECTION  
16 BOARD WORKER AND EMPLOYEE AT EACH PHASE OR LEVEL OF REVIEW SHALL BE  
17 PROVIDED WITH THE SIGNATURE VERIFICATION LOG CONSISTING OF THE TOTAL LOGS  
18 FOR THE PREVIOUS PHASE OR STAGE OF SIGNATURE VERIFICATION REVIEW. THE  
19 COUNTY RECORDER AND COUNTY OFFICER IN CHARGE OF ELECTIONS SHALL MAINTAIN  
20 COMPLETE LOGS OF ALL SIGNATURE VERIFICATIONS PROCESSED DAILY AND THESE MUST  
21 BE MADE AVAILABLE DAILY TO ANY POLITICAL PARTY AND ALL CANDIDATES ON  
22 REQUEST."
