19 AGENCIES TO ENSURE THAT NOTIFICATIONS ARE MADE IN A TIMELY AND ACCURATE
20 MANNER.

21 7. COMPLIES WITH THE TECHNICAL GUIDELINES AND STANDARDS FOR THE
22 OPERATION OF A STATEWIDE AUTOMATED VICTIM INFORMATION AND NOTIFICATION
23 SYSTEM RECOMMENDED BY THE UNITED STATES DEPARTMENT OF JUSTICE'S BUREAU OF
24 JUSTICE ASSISTANCE.

25 8. PROVIDES A DESIGNATED STATEWIDE TOLL-FREE NUMBER THAT IS
26 AVAILABLE TWENTY-FOUR HOURS A DAY, SEVEN DAYS A WEEK, THAT IS OPERATED BY
27 TRAINED OPERATORS AVAILABLE IN MULTIPLE LANGUAGES AND THAT ALLOWS VICTIMS,
28 SURVIVING IMMEDIATE FAMILY MEMBERS, WITNESSES AND OTHER CONCERNED CITIZENS
29 TO SEARCH FOR AND OBTAIN INFORMATION ABOUT AN OFFENDER, INMATE OR CASE AND
30 TO REGISTER FOR NOTIFICATIONS."

10 Sec. 2. Sexual assault kit study committee; membership;
11 duties; report; delayed repeal

12 A. The sexual assault kit study committee is established consisting
13 of the following members appointed by the speaker of the house of
14 representatives:

15 1. Five members of the house of representatives, not more than three
16 of whom are members of the same political party. The speaker of the house
17 of representatives shall designate one of these members to serve as
18 chairperson of the committee.

19 2. Two county sheriffs or their appointees.

20 3. One police chief or the police chief's appointee.

21 4. One county attorney or the county attorney's appointee.

22 5. One representative of a group that represents victims' rights.

23 B. Appointed members serve at the pleasure of the speaker of the
24 house of representatives.

25 C. Committee members are not eligible to receive compensation.

26 D. The committee shall:

27 1. Meet as often as the chairperson deems necessary.

28 2. Examine the feasibility of providing crime victims with a
29 tracking system for sexual assault forensic examination kits.

30 3. On or before December 1, 2023, submit a report of its findings
31 and recommendations to the speaker of the house of representatives and the

1 president of the senate and provide a copy of this report to the secretary
2 of state.

3 E. This section is repealed from and after September 30, 2024."
