AN ACT

AMENDING LAWS 2022, CHAPTER 309, SECTION 8; APPROPRIATING MONIES; RELATING TO THE DEPARTMENT OF TRANSPORTATION.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Laws 2022, chapter 309, section 8 is amended to read:
3 Sec. 8. Appropriations; department of transportation; highway
4 construction; intent; reports; exemption; lapsing
5 A. The following amounts are appropriated from the state highway
6 fund established by section 28-6991, Arizona Revised Statutes, in fiscal
7 year 2022-2023 to the department of transportation for the following
8 highway projects:
9 1. Design and construct additional vehicle
10 lanes, separated by a lighted median,
11 on Interstate 10 between State Route 85
12 and Citrus Road \$64,200,000
13 The legislature intends that:
14 (a) Not more than one hundred twenty days after the effective date
15 of this section, the city of Buckeye contribute \$3,000,000 to the project
16 described in this paragraph.
17 (b) The Maricopa association of governments collect and contribute
18 at least \$10,000,000 from sources other than this state for the project
19 described in this paragraph.
20 (c) The department use any federal discretionary monies awarded for
21 the project described in this paragraph before spending the monies
22 appropriated in this paragraph.
23 2. Improve Jackrabbit Trail between Thomas Road
24 and McDowell Road \$20,080,000
25 The legislature intends that the city of Buckeye contribute
26 \$5,020,000 to the project described in this paragraph.
27 3. Acquire right-of-way to extend State
28 Route 24 \$15,000,000
29 4. Rehabilitate pavement along United States
30 Route 60 between Loop 101
31 and Loop 202 \$38,482,000
32 5. Study the construction of an emergency
33 evacuation bridge in Lake Havasu City \$ 200,000

41 B. Within thirty days after the last day of each calendar quarter,
 42 the department shall report to the joint legislative budget committee
 43 staff the projected cost and status of the projects for the appropriations
 44 made in subsection A of this section. The report shall include any
 45 impacts to the projects due to the increase in the cost of concrete.

1 C. Before transferring monies between the projects described in
2 subsection A of this section, the department shall submit a report for
3 review by the joint committee on capital review.

4 D. Notwithstanding section 41-1252, Arizona Revised Statutes, the
5 appropriations made in subsection A of this section are not subject to
6 review by the joint committee on capital review.

7 E. The appropriations made in subsection A of this section do not
8 lapse until the purpose for which the appropriations were made has been
9 accomplished or abandoned or the appropriations stand for a full fiscal
10 year without an expenditure or encumbrance.

11 Sec. 2. Supplemental appropriation; department of
12 transportation; State Routes 238 and 347;
13 exemption; lapsing

14 A. In addition to any other monies appropriated in fiscal year
15 2022-2023, the sum of \$13,000,000 is appropriated from the state highway
16 fund established by section 28-6991, Arizona Revised Statutes, in fiscal
17 year 2022-2023 to the department of transportation to distribute to the
18 city of Maricopa to design and construct improvements to State Route 238
19 or State Route 347, or both.

20 B. Notwithstanding section 41-1252, Arizona Revised Statutes, the
21 appropriation made in subsection A of this section is not subject to
22 review by the joint committee on capital review.

23 C. The appropriation made in subsection A of this section does not
24 lapse until the purpose for which the appropriation was made has been
25 accomplished or abandoned or the appropriation stands for a full fiscal
26 year without an expenditure or encumbrance.
