# HOUSE BILL 2199

AN ACT

AMENDING SECTIONS 32-532 AND 32-557, ARIZONA REVISED STATUTES; RELATING TO  
COSMETOLOGY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 32-532, Arizona Revised Statutes, is amended to  
3 read:

4 32-532. Instructors; license reciprocity

5 Notwithstanding section 32-531, a person is entitled to receive a  
6 license to teach cosmetology, aesthetics, nail technology or hairstyling  
7 in a school if the person submits to the board an application for an  
8 instructor license on a form prescribed by the board, pays the prescribed  
9 fees and complies with one of the following:

10 1. Is a current licensed ~~cosmetologist~~ COSMETOLOGY INSTRUCTOR,  
11 ~~aesthetician~~ AESTHETICS INSTRUCTOR, nail ~~technician~~ TECHNOLOGY INSTRUCTOR  
12 or ~~hairstylist~~ HAIRSTYLING instructor in another state or country.

13 2. IS A CURRENT LICENSED COSMETOLOGIST, AESTHETICIAN, NAIL  
14 TECHNICIAN OR HAIRSTYLIST IN ANOTHER STATE OR COUNTRY AND HAS AT LEAST ONE  
15 YEAR OF INSTRUCTOR EXPERIENCE IN THE OTHER STATE OR COUNTRY IN  
16 COSMETOLOGY, AESTHETICS, NAIL TECHNOLOGY OR HAIRSTYLING, OR ANY  
17 COMBINATION THEREOF.

18 ~~2.~~ 3. Does all of the following:

19 (a) Either:

20 (i) Submits to the board satisfactory evidence that the person is  
21 at least eighteen years of age.

22 (ii) Holds a diploma from a high school or its equivalent as  
23 prescribed by the board in its rules and submits to the board satisfactory  
24 evidence that the person is at least sixteen years of age.

25 (b) Is a licensed cosmetologist, aesthetician, nail technician or  
26 hairstylist in another state or country.

27 (c) Completes instructor training in another state or country that  
28 has instructor education requirements that are at least substantially  
29 equivalent to those of this state.

30 (d) Passes the examination for an instructor license.

31 (e) Has five years of licensed industry experience within the ten  
32 years preceding application.

33 (f) Meets requirements as prescribed by the board in its rules.

34 Sec. 2. Section 32-557, Arizona Revised Statutes, is amended to  
35 read:

36 32-557. Services for the public; restrictions

37 A. Students may render services to the public only under the direct  
38 supervision of an instructor.

39 B. The following notice shall be posted in a conspicuous place  
40 within the school in letters large enough to be read across the length of  
41 the room, "school of cosmetology – work done exclusively by students."

1           C. A student in a school shall not receive a salary or commission  
2 from the school for any cosmetology, aesthetics, nail technology or  
3 hairstyling services while enrolled in the school as a student. A STUDENT  
4 WHO IS ENROLLED IN A SCHOOL FOR THE PURPOSE OF BECOMING AN INSTRUCTOR MAY  
5 BE A PAID EMPLOYEE OF THE SCHOOL.

6           D. A school shall post a price list for services rendered to the  
7 public that is large enough to be easily read from a distance of ten feet.
