## AN ACT

REPEALING SECTIONS 41-3023.01, 41-3023.05, 41-3023.07, 41-3023.08 AND  
41-3023.10, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27,  
ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTIONS 41-3025.09,  
41-3025.10, 41-3029.04, 41-3029.05 AND 41-3029.06; RELATING TO  
CONTINUATION OF STATE AGENCIES.

1 Be it enacted by the Legislature of the State of Arizona:

2       Section 1. Repeal

3       Sections 41-3023.01, 41-3023.05, 41-3023.07, 41-3023.08 and  
4 41-3023.10, Arizona Revised Statutes, are repealed.

5       Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes,  
6 is amended by adding sections 41-3025.09, 41-3025.10, 41-3029.04,  
7 41-3029.05 and 41-3029.06, to read:

8       41-3025.09. State board of dental examiners; termination  
9    July 1, 2025

10    A. THE STATE BOARD OF DENTAL EXAMINERS TERMINATES ON JULY 1, 2025.

11    B. TITLE 32, CHAPTER 11 AND THIS SECTION ARE REPEALED ON JANUARY 1,  
12 2026.

13       41-3025.10. Board of massage therapy; termination July 1,  
14    2025

15    A. THE BOARD OF MASSAGE THERAPY TERMINATES ON JULY 1, 2025.

16    B. TITLE 32, CHAPTER 42 AND THIS SECTION ARE REPEALED ON JANUARY 1,  
17 2026.

18       41-3029.04. Naturopathic physicians medical board;  
19    termination July 1, 2029

20    A. THE NATUROPATHIC PHYSICIANS MEDICAL BOARD TERMINATES ON JULY 1,  
21 2029.

35       Sec. 3. Purpose

36       Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
37 the legislature continues the state board of dental examiners to promote  
38 the safe and professional practice of dentistry in this state.

39       Sec. 4. Purpose

40       Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
41 the legislature continues the board of massage therapy to promote the safe  
42 practice of massage therapy by qualified professionals.

43       Sec. 5. Purpose

44       Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
45 the legislature continues the naturopathic physicians medical board to

1 promote the safe and professional practice of naturopathic medicine in  
2 this state.

3       Sec. 6. Purpose

4       Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
5 the legislature continues the state board of optometry to promote the safe  
6 and professional practice of optometry.

7       Sec. 7. Purpose

8       Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
9 the legislature continues the Arizona health care cost containment system  
10 to promote a comprehensive health care system to eligible citizens of this  
11 state.

12      Sec. 8. Retroactivity

13      Sections 1 and 2 of this act apply retroactively to from and after  
14 July 1, 2023.
