## **SB 1067**

AN ACT

ESTABLISHING THE JOINT STUDY COMMITTEE ON STATEWIDE ANIMAL CONTROL  
STANDARDS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Joint study committee on statewide animal control  
3 standards; membership; duties; report; delayed  
4 repeal

5 A. The joint study committee on statewide animal control standards  
6 is established consisting of the following members:

7 1. Two members of the senate who are appointed by the president of  
8 the senate and who are of different political parties. The president of  
9 the senate shall designate one of these members to serve as chairperson of  
10 the committee.

11 2. Two members of the house of representatives who are appointed by  
12 the speaker of the house of representatives and who are of different  
13 political parties. The speaker of the house of representatives shall  
14 designate one of these members to serve as vice chairperson of the  
15 committee.

16 3. One representative of Maricopa county animal care and control  
17 who is appointed by the speaker of the house of representatives.

18 4. One representative of Pima county animal care and control who is  
19 appointed by the president of the senate.

20 5. Four representatives of animal control agencies in counties with  
21 a population of less than eight hundred thousand persons. Two of these  
22 members shall be appointed by the president of the senate and two of these  
23 members shall be appointed by the speaker of the house of representatives.  
24 Each member must be from a different county.

25 6. Four representatives who represent humane animal organizations.  
26 Two of these members shall be appointed by the president of the senate and  
27 two of these members shall be appointed by the speaker of the house of  
28 representatives. Each member must be from a different organization that  
29 provides animal control services to a city or county that does not have a  
30 city or county shelter.

31 7. One representative who is a veterinarian and who is a member of  
32 the faculty at an accredited veterinary college. This member must be  
33 appointed by the Arizona state veterinary medical examining board.

34 B. A majority of the members of the committee constitutes a quorum.  
35 The committee shall meet as often as the chairperson deems necessary and  
36 shall meet at any place deemed necessary or convenient by the chairperson.  
37 The committee may meet virtually.

38 C. The committee shall:

39 1. Research and report on the need for statewide consistency of  
40 animal control standards.

41 2. On or before December 31, 2023, submit a report of its findings  
42 and recommendations to the governor, the president of the senate and the  
43 speaker of the house of representatives and shall provide a copy of this  
44 report to the secretary of state.

1           D. The committee may use the services of legislative staff to  
2 provide necessary administrative and operational services.

3           E. On request of the committee, an agency of this state or a  
4 political subdivision of this state shall provide the committee with its  
5 services, equipment, documents, personnel and facilities to the extent  
6 possible without cost to the committee.

7           F. This section is repealed from and after June 30, 2024.
