AMENDING SECTION 15-1701, ARIZONA REVISED STATUTES; RELATING TO FINANCIAL AID.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 15-1701, Arizona Revised Statutes, is amended to  
3 read:

4 15-1701. Arizona promise program; eligibility requirements;  
5 award; fund; definitions

6 A. ~~Eligible postsecondary institutions~~ EACH UNIVERSITY UNDER THE  
7 JURISDICTION OF THE ARIZONA BOARD OF REGENTS shall implement an Arizona  
8 promise program to provide financial assistance to students who meet the  
9 criteria prescribed in this section and who are pursuing studies in this  
10 state leading to a baccalaureate degree. A DEGREE-GRANTING PRIVATE  
11 POSTSECONDARY EDUCATIONAL INSTITUTION IN THIS STATE MAY IMPLEMENT AN  
12 ARIZONA PROMISE PROGRAM TO PROVIDE FINANCIAL ASSISTANCE TO STUDENTS ON THE  
13 SAME TERMS AS A UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF  
14 REGENTS AS PRESCRIBED IN THIS SECTION.

15 B. Except as otherwise provided by law, to be eligible to  
16 participate in the Arizona promise program and to qualify for an award  
17 under this section, a student shall meet all of the following  
18 requirements:

19 1. Qualify for in-state student status as prescribed in section  
20 15-1802.

21 2. Have graduated from a high school in this state with a minimum  
22 2.5 cumulative grade point average on a 4.0 scale for all work attempted  
23 in grades nine through twelve.

24 3. Satisfy the admission standards as determined by an eligible  
25 postsecondary institution.

26 4. Complete and submit the free application for federal student aid  
27 and meet the eligibility criteria for the federal pell grant.

28 5. Secure admission to, and be enrolled in, an eligible  
29 postsecondary institution for at least full-time status as determined by  
30 federal student financial aid guidelines.

31 C. To retain eligibility while pursuing the program of higher  
32 learning in which the student is enrolled, the student shall meet all of  
33 the following requirements:

34 1. Maintain satisfactory academic progress as required for  
35 eligibility for federal student financial aid.

36 2. Complete and submit the free application for federal student  
37 aid.

38 3. Maintain at least full-time status as determined by federal  
39 student financial aid guidelines.

40 4. Comply with the standards related to maintenance of eligibility  
41 as adopted by the governing board of the eligible postsecondary  
42 institution.

43 D. Each eligible postsecondary institution shall provide to each  
44 eligible student an award up to the actual cost of in-state tuition and  
45 fees, except that an award provided pursuant to this section shall be

1 reduced by the amount of any other federal aid scholarships or public  
2 grants and any other financial gifts, grants or aid received by that  
3 person. AN AWARD PROVIDED TO AN ELIGIBLE STUDENT BY A PRIVATE  
4 POSTSECONDARY EDUCATIONAL INSTITUTION PURSUANT TO THIS SUBSECTION MAY NOT  
5 EXCEED THE HIGHEST ACTUAL COST OF IN-STATE TUITION AND FEES CHARGED BY A  
6 UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF REGENTS.

7 E. An award under this section may be awarded for a maximum of  
8 eight academic semesters or their equivalent.

9 F. An award under this section shall be awarded to all eligible  
10 applicants without limit other than the amount of monies available for the  
11 Arizona promise program and the number of eligible applicants. If  
12 appropriated monies are insufficient to provide awards for all eligible  
13 applicants, the Arizona board of regents shall guarantee the award for  
14 applicants who enroll in ~~a university under the jurisdiction of the~~  
15 ~~Arizona board of regents~~ AN ELIGIBLE POSTSECONDARY INSTITUTION.

16 G. The Arizona promise program fund is established consisting of  
17 legislative appropriations and any other monies for the purpose of  
18 administering the Arizona promise program and distributing award monies.  
19 The Arizona board of regents shall administer the fund, including  
20 developing and implementing centralized administrative processes for  
21 distributing monies in the fund to eligible postsecondary institutions  
22 each fiscal year. The Arizona board of regents may accept and spend  
23 federal monies and private grants, gifts, contributions and devises,  
24 including private, philanthropic, public and other sources of monies, to  
25 assist in carrying out the purposes of this section. Monies in the fund  
26 are continuously appropriated and are exempt from the provisions of  
27 section 35-190 relating to lapsing of appropriations. Monies in the fund  
28 may be used for any of the following:

29 1. Reimbursing Arizona promise program awards that cover the  
30 balance of tuition and fees for eligible participants enrolled in an  
31 eligible postsecondary institution after all other gifts and aid received.

32 2. Administering the Arizona promise program, including hiring and  
33 retaining additional personnel. The administration of the program includes  
34 data collection, reporting, tracking and analyzing the program.

35 3. Designing and implementing a marketing and promotion plan for  
36 the Arizona promise program.

37 H. Annual expenditures for marketing, promoting and administering  
38 the Arizona promise program may not exceed three percent of the monies in  
39 the fund each fiscal year.

40 I. Monies remaining in the Arizona promise program fund at the end  
41 of each fiscal year may be used by eligible postsecondary institutions for  
42 Arizona promise program costs in the next fiscal year.

- 1 J. For the purposes of this section:  
2 1. "Eligible postsecondary ~~institutions~~ INSTITUTION" means:  
3 (a) ~~Universities~~ UNIVERSITY under the jurisdiction of the Arizona  
4 board of regents.  
5 (b) A DEGREE-GRANTING PRIVATE POSTSECONDARY EDUCATIONAL INSTITUTION  
6 IN THIS STATE THAT HAS IMPLEMENTED AN ARIZONA PROMISE PROGRAM PURSUANT TO  
7 SUBSECTION A OF THIS SECTION.  
8 2. "Tuition and fees" means tuition, mandatory fees and program  
9 fees that are associated with a program in the eligible postsecondary  
10 institution and that are charged by an eligible postsecondary institution.
