AN ACT

AMENDING TITLE 36, CHAPTER 1, ARTICLE 1, ARIZONA REVISED STATUTES, BY
ADDING SECTION 36-123.04; APPROPRIATING MONIES; RELATING TO THE DEPARTMENT
OF HEALTH SERVICES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 36, chapter 1, article 1, Arizona Revised
3 Statutes, is amended by adding section 36-123.04, to read:

4 36-123.04. Dementia services program; duties; Alzheimer's
5 disease state plan

6 A. THE DEPARTMENT IS DESIGNATED AS THE LEAD AGENCY IN THIS STATE TO
7 ADDRESS ALZHEIMER'S DISEASE AND RELATED FORMS OF DEMENTIAS.

8 B. THE DIRECTOR SHALL ESTABLISH A DEMENTIA SERVICES PROGRAM WITHIN
9 THE DEPARTMENT THAT DOES ALL OF THE FOLLOWING:

10 1. FACILITATE COORDINATION AND SUPPORT OF POLICIES AND PROGRAMS IN
11 THE LEGISLATURE AND THE EXECUTIVE BRANCH, INCLUDING AGENCIES OF THE
12 EXECUTIVE BRANCH THAT RELATE TO ALZHEIMER'S DISEASE AND RELATED FORMS OF
13 DEMENTIA.

14 2. FACILITATE THE COORDINATION, REVIEW, PUBLICATION AND
15 IMPLEMENTATION OF AND UPDATES TO THE ALZHEIMER'S DISEASE STATE PLAN
16 DEVELOPED PURSUANT TO THIS SECTION.

17 3. FACILITATE AND SUPPORT COORDINATION OF OUTREACH PROGRAMS AND
18 SERVICES BETWEEN STATE AGENCIES, LOCAL PUBLIC HEALTH DEPARTMENTS, TRIBAL
19 NATIONS, EDUCATIONAL INSTITUTIONS AND COMMUNITY GROUPS FOR THE PURPOSE OF
20 FOSTERING PUBLIC AWARENESS AND EDUCATION REGARDING ALZHEIMER'S DISEASE AND
21 RELATED FORMS OF DEMENTIA.

22 4. FACILITATE THE COORDINATION OF SERVICES AND ACTIVITIES BETWEEN
23 GROUPS THAT ARE INTERESTED IN DEMENTIA RESEARCH, PROGRAMS AND SERVICES,
24 INCLUDING AREA AGENCIES ON AGING, SERVICE PROVIDERS, ADVOCACY GROUPS,
25 LEGAL SERVICES, EMERGENCY PERSONNEL, LAW ENFORCEMENT, LOCAL PUBLIC HEALTH
26 DEPARTMENTS, TRIBAL NATIONS AND STATE COLLEGES AND UNIVERSITIES.

27 5. APPLY FOR FEDERAL FUNDING AND GRANTS RELATED TO PUBLIC HEALTH
28 SERVICES FOR AND EARLY DETECTION AND RISK REDUCTION OF ALZHEIMER'S DISEASE
29 AND RELATED FORMS OF DEMENTIA.

30 6. INCORPORATE EARLY DETECTION AND RISK REDUCTION STRATEGIES INTO
31 EXISTING DEPARTMENT-LED PUBLIC HEALTH PROGRAMS.

32 C. THE DEMENTIA SERVICES PROGRAM MAY USE COMMUNITY PARTNERS AND
33 AGENCIES OF THIS STATE AND LOCAL GOVERNMENTS FOR ASSISTANCE.

34 D. THE DEPARTMENT SHALL DEVELOP AN ALZHEIMER'S DISEASE STATE
35 PLAN. THE STATE PLAN MUST DO ALL OF THE FOLLOWING:

36 1. ASSESS THE CURRENT AND FUTURE IMPACT OF ALZHEIMER'S DISEASE AND
37 RELATED FORMS OF DEMENTIA ON THIS STATE.

38 2. ASSESS THE EXISTING STATE SERVICES AND RESOURCES THAT ADDRESS
39 THE NEEDS OF PERSONS WHO HAVE ALZHEIMER'S DISEASE OR A RELATED FORM OF
40 DEMENTIA AND THEIR FAMILY CAREGIVERS.

41 3. ASSESS THE NEEDS OF PERSONS OF ALL CULTURAL BACKGROUNDS WHO HAVE
42 ALZHEIMER'S DISEASE OR A RELATED FORM OF DEMENTIA AND HOW THEIR LIVES ARE
43 AFFECTED BY THE DISEASE, INCLUDING FROM YOUNGER-ONSET, THROUGH MID-STAGE,
44 TO LATE-STAGE.

1 4. ASSESS THIS STATE'S CAPACITY AND CAPABILITY TO PROVIDE EFFECTIVE
2 DETECTION AND DIAGNOSIS OF COGNITIVE IMPAIRMENTS AND DEMENTIA.

3 5. IDENTIFY GAPS IN THE PROVISION OF PUBLIC SERVICES AND PRIVATE
4 SERVICES FOR PERSONS WHO HAVE ALZHEIMER'S DISEASE OR A RELATED FORM OF
5 DEMENTIA.

6 6. PROVIDE A STRATEGIC PLAN, INCLUDING RECOMMENDATIONS, FOR STATE
7 ACTION TO DO ALL OF THE FOLLOWING:

8 (a) INCREASE ACCESS TO CARE, SUPPORT AND TREATMENT FOR PERSONS WHO
9 HAVE ALZHEIMER'S DISEASE OR A RELATED FORM OF DEMENTIA.

10 (b) IMPROVE QUALITY OF CARE FOR PERSONS WHO HAVE ALZHEIMER'S
11 DISEASE OR A RELATED FORM OF DEMENTIA.

12 (c) ADVANCE RISK REDUCTION, EARLY DETECTION AND DIAGNOSIS OF
13 ALZHEIMER'S DISEASE AND RELATED FORMS OF DEMENTIA.

14 (d) ENSURE A COORDINATED STATEWIDE RESPONSE TO ALZHEIMER'S DISEASE
15 AND RELATED FORMS OF DEMENTIA.

16 7. BE PUBLISHED ON THE DEPARTMENT'S PUBLIC WEBSITE.

17 E. ON OR BEFORE JULY 1, 2024, AND EVERY THIRD YEAR THEREAFTER, THE
18 DEPARTMENT SHALL REVIEW THE ALZHEIMER'S DISEASE STATE PLAN AND SUBMIT AN
19 UPDATED STATE PLAN TO THE GOVERNOR, THE PRESIDENT OF THE SENATE AND THE
20 SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND SUBMIT A COPY TO THE
21 SECRETARY OF STATE. WHEN REVIEWING AND UPDATING THE ALZHEIMER'S DISEASE
22 STATE PLAN, THE DEPARTMENT SHALL COLLABORATE WITH PERSONS WHO HAVE
23 ALZHEIMER'S DISEASE OR A RELATED FORM OF DEMENTIA, THOSE WHO DIRECTLY CARE
24 FOR THEM AND PUBLIC, PRIVATE AND NONPROFIT ORGANIZATIONS FOCUSED ON
25 ALZHEIMER'S CARE SERVICES, RESEARCH, ADVOCACY, HEALTH CARE AND CAREGIVER
26 SUPPORT.

27 Sec. 2. Appropriation; department of health services;
28 dementia services program; Alzheimer's disease
29 state plan

30 The sum of \$300,000 and two FTE positions are appropriated from the
31 state general fund in fiscal year 2023-2024 to the department of health
32 services for the dementia services program established in the department
33 of health services pursuant to section 36-123.04, Arizona Revised
34 Statutes, as added by this act, and the implementation of the Alzheimer's
35 disease state plan.
