SENATE BILL 1282

AN ACT

AMENDING TITLE 36, CHAPTER 16, ARIZONA REVISED STATUTES, BY ADDING ARTICLE 2; AMENDING LAWS 2022, CHAPTER 330, SECTION 3; APPROPRIATING MONIES; RELATING TO NURSE ANESTHETISTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 36, chapter 16, Arizona Revised Statutes, is
3 amended by adding article 2, to read:

4 ARTICLE 2. CLINICAL ROTATIONS

5 36-1811. Student registered nurse anesthetists; clinical
6 rotation program; grants; definition

7 A. THE STUDENT REGISTERED NURSE ANESTHETIST CLINICAL ROTATION
8 PROGRAM IS ESTABLISHED IN THE ARIZONA STATE BOARD OF NURSING TO EXPAND THE
9 CAPACITY OF PRECEPTOR TRAINING PROGRAMS AT HEALTH CARE INSTITUTIONS FOR
10 NURSE ANESTHETIST STUDENTS.

11 B. THE ARIZONA STATE BOARD OF NURSING SHALL DEVELOP A GRANT PROGRAM
12 TO DISTRIBUTE MONIES APPROPRIATED FOR THE STUDENT REGISTERED NURSE
13 ANESTHETIST CLINICAL ROTATION PROGRAM TO HEALTH CARE INSTITUTIONS THAT ARE
14 LICENSED PURSUANT TO CHAPTER 4 OF THIS TITLE ONLY TO EXPAND OR DEVELOP
15 CLINICAL TRAINING PLACEMENTS FOR NURSE ANESTHETIST STUDENTS, WITH
16 PREFERENCE GIVEN TO THE EXPANSION OR DEVELOPMENT OF CLINICAL ROTATIONS IN
17 OBSTETRICS, PEDIATRICS AND CARDIOVASCULAR CARE.

18 C. GRANT MONIES AWARDED PURSUANT TO THIS SECTION ARE INTENDED TO
19 SUPPLEMENT AND NOT SUPPLANT EXISTING TRAINING PROGRAM EXPENSES COVERED BY
20 THE HEALTH CARE INSTITUTION GRANTEE.

21 D. THE ARIZONA STATE BOARD OF NURSING SHALL ESTABLISH AN
22 APPLICATION PROCESS FOR THE GRANT PROGRAM AND MAY AWARD GRANTS FOR
23 MULTIYEAR PROGRAMS. THE ARIZONA STATE BOARD OF NURSING SHALL CONSIDER THE
24 FOLLOWING FACTORS WHEN DETERMINING GRANT AWARDS:

25 1. THE GEOGRAPHIC AND POPULATION DISTRIBUTION.

26 2. THE NUMBER OF NURSE ANESTHETIST STUDENTS EXPECTED TO BE TRAINED
27 AND RETAINED.

28 3. THE COST OF THE PROPOSAL FOR THE NUMBER OF NURSE ANESTHETIST
29 STUDENTS EXPECTED TO PARTICIPATE AND BE RETAINED COMPARED TO OTHER
30 PROPOSALS.

31 E. FOR THE PURPOSES OF THIS SECTION, "HEALTH CARE INSTITUTION" HAS
32 THE SAME MEANING PRESCRIBED IN SECTION 36-401.

37 Sec. 3. Appropriation; Arizona state board of nursing;

39 rotation program; exemption

40 A. The sum of \$200,000 is appropriated from the state general fund
41 in fiscal year 2023-2024 to the Arizona state board of nursing for the
42 student registered nurse anesthetist clinical rotation program established
43 by section 36-1811, Arizona Revised Statutes, as added by this act.

44 B. The appropriation made in subsection A of this section is exempt
45 from the provisions of section 35-190, Arizona Revised Statutes, relating
46 to lapsing of appropriations.
