# SENATE BILL 1284

AN ACT

AMENDING TITLE 13, CHAPTER 9, ARIZONA REVISED STATUTES, BY ADDING SECTIONS  
13-912 AND 13-922; RELATING TO PROBATION.

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Title 13, chapter 9, Arizona Revised Statutes, is  
3 amended by adding sections 13-912 and 13-922, to read:  
4 13-912. Modification of lifetime probation; sexual offenses;  
5 applicability  
6 A. NOTWITHSTANDING ANY OTHER LAW, A PERSON WHO IS PLACED ON  
7 LIFETIME PROBATION FOR A SEXUAL OFFENSE MAY NOT PETITION THE COURT FOR AN  
8 ORDER TERMINATING PROBATION BEFORE THE FOLLOWING EXPIRATION OF TIME:  
9 1. FOR A CLASS 2 OR 3 FELONY CONVICTION, TWENTY YEARS AFTER THE  
10 DATE THAT THE PERSON WAS PLACED ON PROBATION.  
11 2. FOR A CLASS 4, 5 OR 6 FELONY CONVICTION, TEN YEARS AFTER THE  
12 DATE THAT THE PERSON WAS PLACED ON PROBATION.  
13 B. THIS SECTION DOES NOT APPLY TO A PERSON WHO REQUESTS AN ANNUAL  
14 PROBATION REVIEW HEARING PURSUANT TO SECTION 13-923.  
15 13-922. Probation termination or modification; sexual  
16 offenses; criminal records check  
17 IF A PERSON IS PLACED ON PROBATION FOR A FELONY SEXUAL OFFENSE, THE  
18 PROBATION DEPARTMENT SHALL COMPLETE AN INVESTIGATION OF ARREST  
19 NOTIFICATIONS AND WARRANT CHECKS TO DETERMINE WHETHER THE PERSON HAS ANY  
20 CURRENT OR PENDING CRIMINAL CHARGES BEFORE RECOMMENDING A MODIFICATION OR  
21 EARLY TERMINATION OF THE PERSON'S PROBATION SENTENCE. THE COURT MAY NOT  
22 ISSUE AN ORDER TERMINATING OR MODIFYING THE PERSON'S PROBATION SENTENCE IF  
23 THERE IS A CURRENT OR PENDING CRIMINAL CHARGE AGAINST THE PERSON.
