# SENATE BILL 1312

AN ACT

AMENDING TITLE 1, CHAPTER 8, ARTICLE 1, ARIZONA REVISED STATUTES, BY  
ADDING SECTIONS 1-802, 1-803 AND 1-804, ARIZONA REVISED STATUTES; RELATING  
TO THE GOVERNMENTAL OPERATIONS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 1, chapter 8, article 1, Arizona Revised Statutes,  
3 is amended by adding sections 1-802, 1-803 and 1-804, to read:

4 1-802. Planning; vehicle miles of travel reduction goals  
5 prohibited

6 THIS STATE OR A CITY, TOWN, COUNTY OR POLITICAL SUBDIVISION OF THIS  
7 STATE MAY NOT CONSIDER OR ESTABLISH ANY VEHICLE MILES OF TRAVEL REDUCTION  
8 GOALS OR TARGETS IN DEVELOPING ANY TRANSPORTATION OR LAND USE PLANNING OR  
9 SELECTING TRANSPORTATION OR TRANSIT PROJECTS.

10 1-803. Vehicle miles of travel; tracking prohibited

11 THIS STATE OR A CITY, TOWN, COUNTY OR POLITICAL SUBDIVISION OF THIS  
12 STATE MAY NOT TRACK OR MAINTAIN A RECORD OF A PERSON'S VEHICLE MILES OF  
13 TRAVEL BY RECORDING THE ODOMETER READING ON THE PERSON'S MOTOR VEHICLE  
14 THROUGH THE USE OF TRAFFIC OR OTHER CAMERAS THAT TRACK A PERSON'S MOVEMENT  
15 BY CAPTURING THE PERSON'S LICENSE PLATE OR USING THIRD-PARTY DATA OR ANY  
16 OTHER MEANS TO WHICH THE PERSON DOES NOT EXPRESSLY CONSENT THAT WOULD  
17 ALLOW THIS STATE OR THE CITY, TOWN, COUNTY OR POLITICAL SUBDIVISION OF  
18 THIS STATE TO KNOW HOW MANY VEHICLE MILES A PERSON HAS TRAVELED.

19 1-804. Vehicle miles of travel; tax prohibited; exception

20 A. THIS STATE OR A CITY, TOWN, COUNTY OR POLITICAL SUBDIVISION OF  
21 THIS STATE MAY NOT IMPOSE OR COLLECT ANY MILEAGE FEE OR TAX, A PER-MILE  
22 CHARGE, FEE OR TAX OR ANY TAX OR FEE BASED ON VEHICLE MILES TRAVELED BY AN  
23 INDIVIDUAL IN A MOTOR VEHICLE.

24 B. THIS SECTION DOES NOT APPLY TO AN INTERSTATE AGREEMENT THAT IS  
25 ESTABLISHED TO ADMINISTER THE PAYMENT OR REPORT OF FUEL TAXES OR  
26 REGISTRATION FEES FOR COMMERCIAL VEHICLES THAT OPERATE IN MORE THAN ONE  
27 STATE.
