# **SB 1566**

## AN ACT

AMENDING SECTION 16-165, ARIZONA REVISED STATUTES; RELATING TO  
QUALIFICATION AND REGISTRATION OF ELECTORS.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:  
2       Section 1. Section 16-165, Arizona Revised Statutes, is amended to  
3 read:

4           16-165. Causes for cancellation; report

5       A. The county recorder shall cancel a registration:

6           1. At the request of the person registered.

7           2. When the county recorder is informed and confirms that the  
8 person registered is dead.

9           3. If the person has been adjudicated an incapacitated person as  
10 defined in section 14-5101.

11          4. When the person registered has been convicted of a felony, and  
12 the judgment of conviction has not been reversed or set aside. The county  
13 recorder shall cancel the registration on receipt of notice of a felony  
14 conviction from the court or from the secretary of state or when reported  
15 by the elector on a signed juror questionnaire that is completed pursuant  
16 to section 21-314.

17          5. On production of a certified copy of a judgment directing a  
18 cancellation to be made.

19          6. Promptly after the election if the person registered has applied  
20 for a ballot pursuant to section 16-126.

21          7. When a person has been on the inactive voter list and has not  
22 voted during the time periods prescribed in section 16-166, subsection C.

23          8. When the county recorder receives written information from the  
24 person registered that the person has a change of residence within the  
25 county and the person does not complete and return a new registration form  
26 within twenty-nine days after the county recorder mails notification of  
27 the need to complete and return a new registration form with current  
28 information.

29          9. When the county recorder receives written information from the  
30 person registered that the person has a change of address outside the  
31 county, including when the county recorder either:

32           (a) Receives a form from the person pursuant to subsection E of  
33 this section on which the person has confirmed that the person is not a  
34 resident of this state.

35           (b) Receives a summary report from the jury commissioner or jury  
36 manager pursuant to section 21-314 indicating that the person has stated  
37 that the person is not a resident of the county. Before the county  
38 recorder cancels a registration pursuant to this subdivision, the county  
39 recorder shall send the person notice by forwardable mail and a postage  
40 prepaid preaddressed return form requesting the person confirm by signing  
41 under penalty of perjury that the person is a resident of the county and  
42 is not knowingly registered to vote in another county or another  
43 state. The notice shall inform the person that failure to return the form  
44 within thirty-five days will result in the person's registration being

1 canceled. If the person fails to return the notice within thirty-five  
2 days the county recorder shall cancel the person's registration.

3       10. When the county recorder obtains information pursuant to this  
4 section and confirms that the person registered is not a United States  
5 citizen, including when the county recorder receives a summary report from  
6 the jury commissioner or jury manager pursuant to section 21-314  
7 indicating that a person who is registered to vote has stated that the  
8 person is not a United States citizen. Before the county recorder cancels  
9 a registration pursuant to this paragraph, the county recorder shall send  
10 the person notice by forwardable mail that the person's registration will  
11 be canceled in thirty-five days unless the person provides satisfactory  
12 evidence of United States citizenship pursuant to section 16-166. The  
13 notice shall include a list of documents the person may provide and a  
14 postage prepaid preaddressed return envelope. If the person registered  
15 does not provide satisfactory evidence within thirty-five days, the county  
16 recorder shall cancel the registration and notify the county attorney and  
17 attorney general for possible investigation.

18       11. When the county recorder receives confirmation from another  
19 county recorder that the person registered has registered to vote in that  
20 other county.

21       12. ON THE EFFECTIVE DATE OF THIS AMENDMENT TO THIS SECTION AND ON  
22 APRIL 2 IN EVERY YEAR THEREAFTER THAT ENDS IN ONE, AFTER NOTIFYING EACH  
23 PERSON WHO WAS ON THE VOTER REGISTRATION ROLLS ON THAT DATE THAT THE  
24 PERSON'S VOTER REGISTRATION IS CANCELED AND THAT THE PERSON MUST  
25 REREISTER TO VOTE. THE COUNTY RECORDER SHALL PROVIDE INFORMATION AND  
26 INSTRUCTIONS ON HOW TO REREISTER TO VOTE AND SHALL ARCHIVE THE VOTER  
27 REGISTRATION ROLLS FOR EACH DATE ON WHICH ALL VOTER REGISTRATIONS ARE  
28 CANCELED.

29       B. If the county recorder receives credible information that a  
30 person has registered to vote in a different county, the county recorder  
31 shall confirm the person's voter registration with that other county and,  
32 on confirmation, shall cancel the person's registration pursuant to  
33 subsection A, paragraph 11 of this section.

34       C. If the county recorder cancels a registration pursuant to  
35 subsection A, paragraph 8 of this section, the county recorder shall send  
36 the person notice that the registration has been canceled and a  
37 registration form with the information described in section 16-131,  
38 subsection C attached to the form.

39       D. When proceedings in the superior court or the United States  
40 district court result in a person being declared incapable of taking care  
41 of himself and managing his property, and for whom a guardian of the  
42 person and estate is appointed, result in such person being committed as  
43 an insane person or result in a person being convicted of a felony, the  
44 clerk of the superior court in the county in which those proceedings  
45 occurred shall file with the secretary of state an official notice of that

1 fact. The secretary of state shall notify the appropriate county recorder  
2 and the recorder shall cancel the name of the person on the register.  
3 Such a notice shall name the person covered, shall give the person's date  
4 and place of birth if available, the person's social security number, if  
5 available, the person's usual place of residence, the person's address and  
6 the date of the notice, and shall be filed with the recorder of the county  
7 where the person last resided.

8 E. Each month the department of health services shall transmit to  
9 the secretary of state without charge a record of the death of every  
10 resident of the state reported to the department within the preceding  
11 month. This record shall include only the name of the decedent, the  
12 decedent's date of birth, the decedent's date of death, the decedent's  
13 social security number, if available, the decedent's usual legal residence  
14 at the time of death and, if available, the decedent's father's name or  
15 mother's maiden name. The secretary of state shall use the record for the  
16 sole purpose of canceling the names of deceased persons from the statewide  
17 voter registration database. In addition, the department of health  
18 services shall annually provide to the secretary of state from the  
19 statewide electronic death registration system without charge a record of  
20 all deaths of residents of this state that are reported to the department  
21 of health services. The records transmitted by the department of health  
22 services shall include only the name of the decedent, the decedent's date  
23 of birth, the decedent's social security number, if available, the  
24 decedent's usual legal residence at the time of death and, if available,  
25 the decedent's father's name or mother's maiden name. The secretary of  
26 state shall compare the records of deaths with the statewide voter  
27 registration database. Public access to the records is prohibited. Use  
28 of information from the records for purposes other than those required by  
29 this section is prohibited. The name of each deceased person shall  
30 promptly be canceled from the statewide voter registration database and  
31 the secretary of state shall notify the appropriate county recorder and  
32 the recorder shall cancel the name of the person from the register.

33 F. Each month the department of transportation shall furnish to the  
34 secretary of state without charge a list of persons who the department has  
35 been notified have been issued a driver license or the equivalent of an  
36 Arizona nonoperating identification license in another state. Within ten  
37 days after receiving the list of persons from the department of  
38 transportation, the secretary of state shall provide to the appropriate  
39 county recorder a list of registered voters in that county who have been  
40 issued a driver license or the equivalent of an Arizona nonoperating  
41 identification license in another state. The county recorder shall  
42 promptly send notice by forwardable mail to each person who has obtained a  
43 driver license or the equivalent of an Arizona nonoperating identification  
44 license in another state and a postage prepaid preaddressed return form  
45 requesting the person confirm by signing under penalty of perjury that the

1 person is a resident of this state and is not knowingly registered to vote  
2 in another state or confirm that the person is not a resident of this  
3 state. The notice shall inform the person that failure to return the form  
4 within ninety days will result in the person's registration being placed  
5 in inactive status. If the person returns the form within ninety days  
6 confirming that the person is a resident of this state, the county  
7 recorder shall maintain the registration in active status. If the person  
8 fails to return the form within ninety days, the county recorder shall  
9 place the person's registration in inactive status.

10 G. Each month the secretary of state shall compare the statewide  
11 voter registration database to the driver license database maintained by  
12 the department of transportation. The secretary of state shall notify the  
13 appropriate county recorder if a person who is registered to vote in that  
14 county has changed the person's residence address or is not a United  
15 States citizen.

16 H. To the extent practicable, each month the county recorder shall  
17 compare the county's voter registration database to the social security  
18 administration database.

19 I. To the extent practicable, each month the county recorder shall  
20 compare persons who are registered to vote in that county and who the  
21 county recorder has reason to believe are not United States citizens and  
22 persons who are registered to vote without satisfactory evidence of  
23 citizenship as prescribed by section 16-166 with the systematic alien  
24 verification for entitlements program maintained by the United States  
25 citizenship and immigration services to verify the citizenship status of  
26 the persons registered.

27 J. For persons who are registered to vote without satisfactory  
28 evidence of citizenship as prescribed in section 16-166, the county  
29 recorder shall compare the electronic verification of vital events system  
30 maintained by a national association for public health statistics and  
31 information systems, if accessible, with the information on the person's  
32 voter registration file.

33 K. To the extent practicable, the county recorder shall review  
34 relevant city, town, county, state and federal databases to which the  
35 county recorder has access to confirm information obtained that requires  
36 cancellation of registrations pursuant to this section.

37 L. After canceling a registration pursuant to this section, the  
38 county recorder shall send a notice by forwardable mail informing the  
39 person that the person's registration has been canceled, the reason for  
40 cancellation, the qualifications of electors pursuant to section 16-101  
41 and instructions on registering to vote if the person is qualified.

42 M. The secretary of state shall report the following information to  
43 the legislature at the end of each quarter:

44 1. The number of deaths reported to the secretary of state by the  
45 department of health services, the number of voter registration

1 cancellation notices issued by the secretary of state to the county  
2 recorders as a result of those reports and the number of registrations  
3 canceled as a result of those notices.

4       2. The number of persons reported to the secretary of state who  
5 have been issued a driver license or the equivalent of an Arizona  
6 nonoperating identification license in another state, the number of  
7 notices sent pursuant to subsection E of this section and the number of  
8 voter registrations that have been placed in inactive status and the  
9 number of voter registrations that have been canceled as a result of those  
10 notices.

11      3. The number of persons who have stated on a ~~Jury~~ JUROR  
12 questionnaire that the person is not a United States citizen, the number  
13 of notices sent pursuant to subsection A, paragraph 10 of this section and  
14 the number of registrations that have been canceled as a result of those  
15 notices.

16      4. The number of persons who have stated on a ~~Jury~~ JUROR  
17 questionnaire that the person is not a resident of the county, the number  
18 of notices sent pursuant to subsection A, paragraph 9, subdivision (b) of  
19 this section and the number of registrations that have been canceled as a  
20 result of those notices.

21      5. The number of registrations on the inactive voter list that have  
22 been canceled pursuant to subsection A, paragraph 7 of this section.
