AN ACT

AMENDING TITLE 41, CHAPTER 37, ARTICLE 2, ARIZONA REVISED STATUTES, BY  
ADDING SECTION 41-3956; RELATING TO THE ARIZONA DEPARTMENT OF HOUSING.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 41, chapter 37, article 2, Arizona Revised  
3 Statutes, is amended by adding section 41-3956, to read:

4 **41-3956. Home buyer assistance program; fund; rules**

5 A. THE DEPARTMENT SHALL ESTABLISH AND ADMINISTER THE HOME BUYER  
6 ASSISTANCE PROGRAM TO:

7 1. ASSIST HOME BUYERS BY PROVIDING LOW-INTEREST MORTGAGE LOANS,  
8 WITH DOWN PAYMENT AND CLOSING COST ASSISTANCE OPTIONS, FOR THE PURCHASE OF  
9 HOMES.

10 2. COORDINATE WITH AND, AS APPROPRIATE, PROVIDE MATCHING MONIES FOR  
11 SIMILAR PROGRAMS THAT ARE OFFERED BY PRIVATE EMPLOYERS AND COUNTY AND  
12 MUNICIPAL GOVERNMENTS SO AS TO MAXIMIZE THE TOTAL AMOUNT THAT HOME BUYERS  
13 CAN RECEIVE UNDER THIS PROGRAM.

14 B. THE HOME BUYER ASSISTANCE PROGRAM FUND IS ESTABLISHED CONSISTING  
15 OF LEGISLATIVE APPROPRIATIONS, MONIES RECEIVED FROM THE REPAYMENT OF LOANS  
16 PROVIDED BY THE PROGRAM AND INTEREST EARNED ON THOSE MONIES. THE  
17 DEPARTMENT SHALL ADMINISTER THE FUND. MONIES IN THE FUND ARE CONTINUOUSLY  
18 APPROPRIATED.

19 C. FOR LOANS PROVIDED UNDER THIS PROGRAM, THE DEPARTMENT SHALL:

20 1. ALLOW HOME BUYERS TO USE THE LOANS FOR THE PURCHASE OF NEWLY  
21 CONSTRUCTED OR EXISTING HOMES, INCLUDING HOMES THAT ARE HELD IN  
22 COOPERATIVE OR CONDOMINIUM FORMS OF OWNERSHIP.

23 2. REQUIRE THAT BORROWERS UNDER THIS PROGRAM NOT OWN OTHER  
24 RESIDENTIAL REAL ESTATE AT THE TIME THAT THE LOAN IS PROVIDED.

25 3. REQUIRE THAT A HOME PURCHASED UNDER THIS PROGRAM BE OCCUPIED BY  
26 THE HOME BUYER AS A PRINCIPAL RESIDENCE.

27 D. ANY PROCEEDS FROM OR REPAYMENT OF LOANS PROVIDED UNDER THE  
28 PROGRAM SHALL BE DEPOSITED, PURSUANT TO SECTIONS 35-146 AND 35-147, IN THE  
29 HOME BUYER ASSISTANCE PROGRAM FUND ESTABLISHED BY THIS SECTION TO BE USED  
30 FOR THE PURPOSES OF THE PROGRAM.

31 E. THE DEPARTMENT SHALL ADOPT RULES TO IMPLEMENT THE PROGRAM.
