### AN ACT

AMENDING SECTION 41-2408, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 21, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-2414; APPROPRIATING MONIES; RELATING TO THE ARIZONA CRIMINAL JUSTICE COMMISSION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 41-2408, Arizona Revised Statutes, is amended to  
3 read:

4 41-2408. Criminal justice data collection; reporting  
5 requirements; definition

6 A. The Arizona criminal justice commission is designated as the  
7 central collection point for criminal justice data collection.

8 B. Unless prohibited by federal or state law, the Arizona criminal  
9 justice commission may require any state or local criminal justice agency  
10 to submit any necessary information that is currently collected and  
11 readily reportable ELECTRONICALLY by the agency at the time of the  
12 request, including ALL OF THE FOLLOWING:

13 1. An agency's compliance with statutorily required reports or  
14 mandated federal or state reporting. ~~or~~

15 2. Any other information that is deemed necessary by a vote of the  
16 full commission.

17 C. This section does not authorize the Arizona criminal justice  
18 commission to require state or local criminal justice agencies to collect  
19 or maintain any new data that is not required under subsection B of this  
20 section.

21 D. For the purposes of this section, "criminal justice agency" has  
22 the same meaning prescribed in section 41-1750.

23 Sec. 2. Title 41, chapter 21, article 1, Arizona Revised Statutes,

27 A. THE ARIZONA CRIMINAL JUSTICE COMMISSION SHALL IMPLEMENT THE  
28 STATE, COUNTY AND MUNICIPAL OPEN DATA SYSTEM. THE DATA SYSTEM SHALL BE  
29 PUBLISHED ON THE COMMISSION'S WEBSITE IN A MODERN, OPEN, ELECTRONIC FORMAT  
30 THAT IS READILY ACCESSIBLE TO THE PUBLIC. BEGINNING ON JANUARY 1, 2024,

- 43 justice agencies to report data into the system:



- 1           1. \$4,700,000 in fiscal year 2023-2024.

- 4           B. The appropriations made in subsection A of this section are
- 5 exempt from the provisions of section 35-190, Arizona Revised Statutes,
- 6 relating to lapsing of appropriations.
