AN ACT

AMENDING TITLE 36, CHAPTER 4, ARTICLE 2, ARIZONA REVISED STATUTES, BY
ADDING SECTION 36-425.09; RELATING TO HEALTH CARE INSTITUTIONS.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 36, chapter 4, article 2, Arizona Revised
3 Statutes, is amended by adding section 36-425.09, to read:

4 36-425.09. Behavioral health residential facilities;
5 admittance; notification; sobriety; violations;
6 assessments

7 A. WHEN A PATIENT IS ADMITTED FOR INITIAL EVALUATION, A BEHAVIORAL
8 HEALTH RESIDENTIAL FACILITY SHALL NOTIFY THE PATIENT'S FAMILY OR NEXT OF
9 KIN AS PROMPTLY AS POSSIBLE. THE NOTIFICATION SHALL BE DOCUMENTED IN THE
10 PATIENT'S MEDICAL RECORD.

11 B. A PERSON MAY NOT BE TRANSPORTED TO A BEHAVIORAL HEALTH
12 RESIDENTIAL FACILITY BY REPRESENTATIVES OF THE FACILITY UNLESS THE PERSON
13 IS SOBER OR IS REFERRED BY AN APPROVED PROVIDER OF A TRIBAL HEALTH CARE
14 PROGRAM.

15 C. NOTWITHSTANDING SECTION 36-431.01, A BEHAVIORAL HEALTH
16 RESIDENTIAL FACILITY THAT FAILS TO COMPLY WITH THE REQUIREMENTS OF THIS
17 SECTION IS SUBJECT TO AN ASSESSMENT IN AN AMOUNT EQUAL TO, AT A MINIMUM,
18 THE FOLLOWING:

- 19 1. FOR A FIRST VIOLATION, \$750.
- 20 2. FOR A SECOND VIOLATION, \$1,000.
- 21 3. FOR A THIRD VIOLATION, A THIRTY-DAY LICENSE SUSPENSION.

22 D. EACH DAY THAT A VIOLATION OCCURS CONSTITUTES A SEPARATE
23 VIOLATION.

24 E. THE DIRECTOR MAY ISSUE A NOTICE OF ASSESSMENT THAT INCLUDES THE
25 PROPOSED AMOUNT OF THE ASSESSMENT PURSUANT TO SUBSECTION C OF THIS
26 SECTION. A BEHAVIORAL HEALTH RESIDENTIAL FACILITY MAY APPEAL THE
27 ASSESSMENT OR ANY ACTION AGAINST THE BEHAVIORAL HEALTH RESIDENTIAL
28 FACILITY'S LICENSE BY REQUESTING A HEARING PURSUANT TO TITLE 41, CHAPTER
29 6, ARTICLE 10. IF AN ASSESSMENT OR ACTION AGAINST A LICENSE IS APPEALED,
30 THE DIRECTOR MAY NOT TAKE ANY FURTHER ACTION PURSUANT TO THIS SUBSECTION
31 UNTIL AFTER THE HEARING.
